In consideration of SENATE BILL 3036, SENATE DRAFT 1 RELATING TO BEACH MANAGEMENT FOR THE NORTH SHORE OF OAHU

Senate Bill 3036, Senate Draft 1 proposes to appropriate funds to the University of Hawaii Sea Grant College Program (UH Sea Grant) to conduct a study and create a beach management plan for the north shore of Oahu. The Department of Land and Natural Resources (Department) supports this bill provided that its passage does not replace or adversely impact priorities indicated in our Executive Budget request.

This legislation endeavors to improve understanding and management of beach resources along the fifteen-mile stretch of coastline from Haleiwa to Kahuku Point, which is of primary importance to state residents and visitors from around the world for its beautiful beaches, worldclass surf breaks, and marine resources.

As you know, part of the Department's mission is to manage coastal areas and ocean resources through the Department's Office of Conservation and Coastal Lands (OCCL). A recent study by University of Hawaii and United States (US) Geological Survey researchers¹ finds the 73% of beaches along the north shore of Oahu are undergoing a long-term trend of beach erosion (shoreline retreat). The threat of seasonal erosion and inundation during large waves may be an even greater hazard along many north shore beaches. Management and conservation of north shore beaches is further challenged by a legacy of concentrated development too close to hazardprone shorelines, as well as impacts from intensive public use. Frequency and severity of coastal erosion and coastal flooding events will only increase with increasing rates of sea level rise in the coming decades.

The Department has been especially busy with beach management efforts on the north shore over the last several months with a series of highly publicized coastal erosion events in the Sunset Beach area. The Department is working closely with local residents and county and federal agencies to coordinate and authorize short-term solutions to manage these erosion problems, while also working to protect public beach and marine resources.

The Department, county, and federal agencies that share regulatory oversight of the north shore, as well as the local community and property owners would greatly benefit from improved scientific information on beach processes through a coordinated, community-supported beach management plan guiding future beach management efforts.

The Department has worked closely with UH Sea Grant for over 10 years in support of the OCCL Coastal Lands Program. Collaborative efforts between the Department and UH Sea Grant include development of the Kailua Beach and Dune Management Plan in 2010. UH Sea Grant is ideally suited to develop a north shore beach management plan as a neutral broker and due to the organization's affiliations with UH researchers and expertise in community extension and outreach.

SB 3036 SD1 – RELATING TO BEACH MANAGEMENT FOR THE NORTH SHORE OF OAHU

The UH Sea Grant strongly supports SB3036 SD1 provided that its passage does not replace or adversely impact priorities as indicated in the University's Board of Regents Approved Executive Biennium Budget. This legislation endeavors to improve the scientific understanding and sustainable management of beach resources along North Shore of Oʻahu from Haleʻiwa to Kahuku Point. This heavily used coastal stretch is world renown for its beautiful beaches, world-class surf breaks, and marine resources and warrants a dedicated regional beach and dune management plan to conserve and sustainably manage this unique area.

The North Shore community has expressed strong interest and support for a beach management plan. The development of a regional beach management plan requires the support and participation of the community in order to ensure successful implementation of priority management strategies. In this respect UH Sea Grant also supports and encourages the planned "community conversations" to discuss the objectives of the plan and allow an opportunity for the community to share their comments, ideas and concerns for the management of this community resource.

SB3036 SD1 intends to support the development of a coastal processes study and create a north shore beach management plan, with substantial community and stakeholder input, over a two-year period. The University of Hawai'i is well positioned to carry this out and has successfully developed similar beach and dune management plans in Hawai'i including the Kailua Beach and Dune Management Plan and the Beach Management Plan for Maui.

While UH Sea Grant strongly supports the overall intent of SB3036 SD1, we recommend that the proposed legislation be amended as follows:

1. Page 5, Line 10-11. Remove reference to developing disaster recovery plans as part if this effort in the bill as this may be beyond the initial scope of a beach management plan. This is a more involved process that requires a different set

- of stakeholders and will require its' own plan. Rewording this section to "shall consider and provide a summary...." or similar instead of "shall include..." would help.
- 2. Page 4 line 17. Clarify the type of "scenarios" in this section perhaps "planning and climate change...." would be sufficient. Delete reference to specific planning timeframes of 20 to 100 years. Inclusion of the terms "long and short term" would be more appropriate.

Aloha Committee Members,

I would like to voice my strong support for SB 3036. The North Shore of Oahu from Sunset to Waimea is under considerable threat from the forces of nature. Climate is changing and the seas are most certainly rising as increasing global surface temperatures causes the oceans to expand and the melting of polar ice caps adds large amounts of water to our seas. Major storm surges are already having dramatic effects on our coastlines at Rocky Point and this is only likely to increase as beach erosion on the north shore is accelerated by all the development that was allowed close to the shore in the last 50 years. Comments: Dear Chair Ige, Vice-Chair Kidani, and members of the committee, I write in STRONG SUPPORT of SB3036, which would fund a North Shore Beach Management Plan, through the Sea Grant program at the University of Hawaii. I recommend one key amendment to return to the original intent of the bill: ** broaden the area to be studied to include at least Laniakea/Chun's Reef to Velseyland as part of the beach management plan - so it should read "northwest facing shore, from Laniakea to Velseyland" While I am appreciative that HRE/WAL passed the bill, the committees' amendments that narrowed the scope only to "Sunset to Waimea" do not make policy, scientific, or planning sense. This measure is a wise investment of state resources in ensuring the long-term protection of North Shore beaches that are a vital recreational resource to the entire island. The plan, with extensive community and agency collaboration, would be a model for Hawaii's climate adaptation planning of our shorelines. As the Feb 18 2014 Star-Advertiser Editorial stated (referring to SB3035 and SB3036): "These bills should pass, sending a clear message that further delay is simply intolerable. Government may drag its heels on a highway project, but erosion won't wait forever. The end result we don't want is for the sea to claim Kamehameha Highway."
