In consideration of SENATE BILL 3036 RELATING TO BEACH MANAGEMENT FOR THE NORTH SHORE OF OAHU

Senate Bill 3036 proposes to appropriate funds to the University of Hawaii Sea Grant College Program (UH Sea Grant) to conduct a study and create a beach management plan for the north shore of Oahu. The Department of Land and Natural Resources supports this bill provided that its passage does not replace or adversely impact priorities indicated in our Executive **Budget request.**

This legislation endeavors to improve understanding and management of beach resources along the fifteen-mile stretch of coastline from Haleiwa to Kahuku Point, which is of primary importance to state residents and visitors from around the world for its beautiful beaches, worldclass surf breaks, and marine resources.

As you know, part of the Department's mission is to manage coastal areas and ocean resources through the Department's Office of Conservation and Coastal Lands (OCCL). A recent study by University of Hawaii and United States (US) Geological Survey researchers finds the 73% of beaches along the north shore of Oahu are undergoing a long-term trend of beach erosion (shoreline retreat). The threat of seasonal erosion and inundation during large waves may be an even greater hazard along many north shore beaches. Management and conservation of north shore beaches is further challenged by a legacy of concentrated development too close to hazardprone shorelines, as well as impacts from intensive public use. erosion and coastal flooding events will only increase with increasing rates of sea level rise in the coming decades.

The Department has been especially busy with beach management efforts on the north shore over the last several months with a series of highly publicized coastal erosion events in the Sunset Beach area. The Department is working closely with local residents and county and federal agencies to coordinate and authorize short-term solutions to manage these erosion problems, while also working to protect public beach and marine resources.

The Department, county, and federal agencies that share regulatory oversight of the north shore, as well as the local community and property owners would greatly benefit from improved scientific information on beach processes through a coordinated, community-supported beach management plan guiding future beach management efforts.

The Department has worked closely with UH Sea Grant for over 10 years in support of the OCCL Coastal Lands Program. Collaborative efforts between the Department and UH Sea Grant include development of the Kailua Beach and Dune Management Plan in 2010. UH Sea Grant is ideally suited to develop a north shore beach management plan as a neutral broker and due to the organization's affiliations with UH researchers and expertise in community extension and outreach.

While the Department strongly supports the overall intent of this measure, we recommend that the proposed legislation be amended to clarify the scope and wording of the bill in the following ways:

- 1. Limit the geographic scope of the plan to focus on the heavily-used beaches between Waimea Bay and Velzyland (Waiale'e Beach);
- 2. In addition to the need for participation from the local community, emphasize the need for improved scientific data on short-term (seasonal to decadal) and long-term (decadal to century) beach dynamics on the north shore within the plan to support science-based decision making pertaining to management options, including:
 - a) An updated detailed examination of historical beach changes for the region utilizing existing databases of aerial photographs and historical shoreline positions available from the UH Coastal Geology Group;
 - b) Measurement of seasonal sediment transport directions and volumes through a monthly beach profile (topographic) surveying program; and
 - c) Forecasting and mapping coastal erosion hazard areas using existing methods developed by UH School of Ocean and Earth Science and Technology researchers, considering a range of sea level rise scenarios.
- 3. Remove specific mention of "condemnation of beachfront property and structures" (page 4, line 14). This is just one of a broad range of long-term management and adaptation options that should be discussed in the plan;

- 4. Request that the plan include discussion of short and long-term beach management options, such as:
 - a) temporary and emergency erosion management;
 - b) beach and dune management techniques based on sediment transport,
 - c) shoreline public access management and foot traffic control,
 - d) beach and dune nourishment,

and longer-term coastal land use strategies, such as:

- a) shoreline protection and erosion management,
- b) shoreline setbacks, rolling easements, and land acquisition,
- c) public park expansion, land swaps and transfer of development rights,
- d) disaster recovery plans and other innovative means to adapt to coastal hazards and climate change.
- 5. Remove specific mention of "bike path planning" (page 4, line 17). While the Department supports the concept of a bike path connecting the north shore region, the Department feels this is beyond the scope of a typical beach management plan and probably warrants its own study.

Dear Chair Solomon, Chair Taniguchi, Vice-Chair Galuteria, Vice-Chair Kahele, and Committee Members:

I write in **STRONG SUPORT OF SB3036** introduced by Senator Clayton Hee. This bill will support and fund a North Shore Beach Management Plan under the leadership of the University of Hawai'i Sea Grant College.

The combination of climate change impacts such as sea level rise and coastal erosion have already been particularly damaging to this "northwest" facing stretch of the North Shore, from Hale iwa to Kahuku, which has world famous surf and beaches.

Stretches of Kamehameha Highway near the beach in this area are already obviously undermined and experience wash-over in high surf/tides. Several private homes at Ke Nui Road have recently been hit by high surf events and more heart-breaking impacts on beachfront homeowners are surely coming in the future. More important, the beach itself -- a public trust asset that belongs to everyone – has substantially narrowed in many areas and is not proactively or adequately managed for the long-term. Reacting to acute damage situations with short-term solutions such as hardening the shoreline or seawalls will only lead to further disaster for the common resource.

A NSBMP would ultimately save considerable time and money for the state, city, and community by coordinating and integrating city-state-community planning efforts along this shoreline. The plan can help us all respond to climate impacts and provide a useful planning tool for mitigating over-development of the coastline, for ensuring continued public access to sustainable coastlines, and for increasing the resilience of the invaluable public amenities already along this scenic area (e.g., utilities, lifeguard stations, support parks, comfort stations, recreational access points, bike paths, parking areas).

Sea Grant has considerable expertise in this area, having completed the Kailua Beach and Dune Management Plan in 2010 and is well positioned to lead this community planning effort, which can become a model for future collaborative efforts in other beach areas statewide.

It's time to be *proactive* to protect Hawai'i's critical beaches and coastlines. The NSBMP will be a major step forward for all of us.
