Re: Testimony in Support of SB 3042

Aloha Ladies and Gentlemen of the Committee:

We are in support of SB 3042 as it serves to remove unjustified limits on beer production and create a license class that allows for a producer to create products of several types.

Kauai Island Brewing Company currently employs 30 full and part time employees. We are the only Brewpub on Kauai and have operated as a Class 14 brewpub since July 2012. Over the last 18 months we've experienced double digit sales increases such that we are already looking at expanding our brewing production capacity. We have also realized that many of our customers are extremely sophisticated in their taste preferences and are looking for both local craft beer as well as local craft spirits. We have also seen a trend in other states to offer companion parings of both local craft beer as well as spirits.

As a brewpub, we have the opportunity to personally interact on a daily basis with a significant number of people, both local and visiting tourists. The passage of this bill would allow us to not only affect our immediate customer perception of Kauai but to effect their perception throughout Hawaii.

Further, we take particular exception to other's testimony pertaining to the unfair advantage of the purchase of spirits directly from manufacturers or the restriction of sale to off premise accounts. As a brewpub, we carry an extensive range of mainstream spirits purchased from our Spirit Distributors. Based on our experience in the industry, we do not foresee this sales trend to decline. In other words, we would forecast that an insignificant dollar amount of our Spirit sales will be spent on Boutique Craft Spirits.

Passage of this bill will do nothing but to help out the local Hawaii business owners by allowing greater access to the market and to remove an artificial barrel ceiling currently imposed on Breweries.
