In consideration of SENATE BILL 3063 RELATING TO DISPOSITION OF LANDS IN WAIPIO VALLEY

Senate Bill 3063 proposes an appropriation of general funds for the purchase of land located in Waipi'o Valley, Island of Hawai'i, from the Bernice Pauahi Bishop Museum. The Department of Land and Natural Resources (Department) supports the intent of the bill and recommends the attached amendments.

The Department supports planning and preliminary due diligence for the possible acquisition by the State of lands in Waipi'o as the first step in providing resource management and access for the public's benefit. Acquisition would be subject to regular due diligence procedures of the Department, including the approval of the Board of Land and Natural Resources under Section 171-30, Hawaii Revised Statutes (HRS), and the approval of the Attorney General required under Section 107-10, HRS.

The Department suggests a cooperative effort with the landowner and other appropriate agencies and organizations to consider the next step of planning the protection, management and public access to the parcel, and, provided that additional management funding is not dedicated, suggests alternative management solutions such as acquisition and lease or transfer to an agency or nonprofit organization that can provide public access to the extent feasible in light of public safety and preservation of cultural and natural resource; appropriate preservation and treatment of cultural sites and resources; and active management of natural resources against threats such as invasive species, vandalism, overuse.

To effect these changes, the Department proposes the attached amendments to Senate bill 3063.

A BILL FOR AN ACT

RELATING TO DISPOSITION OF LANDS IN WAIPIO VALLEY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that Waipio valley in the
- 2 district of Hamakua, Island of Hawaii, possesses cultural,
- 3 historic, and natural resources that are of high value to the
- 4 State. These resources are central to the historic, cultural,
- 5 and natural identity of the State of Hawaii, and protection and
- 6 management of these resources will benefit to the people of
- 7 Hawaii.
- 8 The legislature further finds that the acquisition of
- 9 privately owned lands or interests in lands in Waipio Valley
- 10 would further public access and permanent protection of these
- 11 resources.
- 12 The legislature also finds that active management of the
- 13 resources in Waipio valley is necessary to protect them against
- 14 overuse, invasive species, and other threats to their continued
- 15 existence.
- The department of land and natural resources is considering

- 1 Pauahi Bishop Museum. The purpose of this Act is to direct the
- 2 department to cooperate with other appropriate agencies and
- 3 organizations, and to make an appropriation for planning and
- 4 preliminary due diligence for purchase of land located in Waipio
- 5 valley.
- 6 SECTION 2. The department shall establish a working group
- 7 to investigate possibilities for partnerships to acquire lands
- 8 in Waipio valley. The working group shall consist of the
- 9 following members, provided that private parties are willing to
- 10 participate:
- 11 (1) The Chief Executive Officer of the Office of Hawaiian
- 12 Affairs or the Chief Executive Officer's designee;
- 13 (2) The Chair of the Agribusiness Development Corporation
