SB 3065 - RELATING TO LAND EXCHANGE

Chairs Dela Cruz, Solomon, and Nishihara, Vice Chairs Slom, Galuteria, and Kouchi, and Members of the Committees:

Thank you for the opportunity to express concerns on one component of this measure.

Senate Bill 3065 authorizes the State to exchange lands, including University of Hawai'i lands in West O'ahu, for certain agricultural and conservation lands owned by Dole Food Company, Inc.

The Board of Regents respectfully request the University of Hawai'i lands be deleted from this bill. These lands are an asset to the University to help fulfill the vision and mission of UH – West O'ahu and the University as a whole.

We wholeheartedly acknowledge that a master plan for UHWO's future and place within the University system is needed. Recently, the Board of Regents authorized the formation of a task group to conduct the master planning process immediately. The task group will produce a master plan by the end of August 2014. We respectfully request that the University of Hawai'i lands in West O'ahu be deleted from SB 3065 pending the completion of the UHWO master plan. The University is also currently updating its Board policy on land and its statements on their purposes, which include the promotion and support of the University's educational and research mission while advancing the principals of environmental stewardship and sustainability. This legislative measure conflicts with the University in meeting its mission.

Accordingly we request that the University of Hawai'i lands be deleted from this bill.

SB 3065, RELATING TO LAND EXCHANGE

Chair Dela Cruz, Chair Solomon, Chair Nishihara, and Members of the Committees:

The Department of Hawaiian Home Lands (DHHL) provides comments on this bill which proposes a land exchange of state lands in Kapolei for private lands in Central Oahu. The parcel identified by tax map key 91017110 referenced in Section 2 and Section 3 of this bill is currently in the Department of Land and Natural Resources' inventory, but is pending conveyance to DHHL.

While we are willing to continue discussion on this proposed land exchange, there are several factors DHHL must consider prior to supporting this exchange. Since there is very high demand for homesteads on Oahu, and very limited Oahu lands in DHHL's current inventory, we must carefully consider how to use, or exchange, our land holdings on this island. This parcel in question is valuable to DHHL because it is prime for homestead development, it is near
