

# RELATING TO THE PUBLIC-PRIVATE FINANCE INITIATIVE

Senate Bill No. 3066, S.D. 1, establishes the public-private finance initiative (PPIA), requires the PPIA to initiate a pilot project, appropriates funds for the PPIA, and repeals on July 1, 2018.

The Department has technical comments on this bill. This measure in its current form is unclear as to whether the State would be allowed to enter into debt with respect to the PPIA program. If the answer is in the affirmative, then a maximum dollar amount should be authorized under the program to be able to limit the State's liability under the proposed initiative. In addition, please be advised that if such debt is authorized, the amount will need to be reflected as a liability and incorporated into the State's debt limit calculation.
