#### In consideration of SENATE BILL 3077 RELATING TO THE MAALAEA SMALL BOAT HARBOR

Senate Bill 3077 proposes to appropriate funding for a capital improvement project at the Maalaea Small Boat Harbor. The Department of Land and Natural Resources (Department) appreciates the intent of this measure and would support the offer of capital improvement funding as long as the Administration's budget request remains intact.

Initial construction for the Maalaea Small Boat Harbor was in 1952 and the Harbor was built for recreational and commercial fishing vessels. In Fiscal Year 2013, the Harbor had over \$960,000 in revenues, with 75% of that from commercial operators and is the highest grossing harbor in Maui County and the third highest statewide.

The Department estimates that \$4 million is needed to replace seventeen wooden finger piers and associated concrete piles along the south mole of the harbor, where most of the large capacity commercial tour operators are located.
