In consideration of SENATE CONCURRENT RESOLUTION 109/SENATE RESOLUTION 58 REQUESTING THE OFFICE OF HAWAIIAN AFFAIRS AND THE DEPARTMENT OF LAND AND NATURAL RESOURCES TO FORM A TRADITIONAL LAND USE TASK FORCE AND PROVIDE A REPORT TO THE LEGISLATURE ON THE FEASIBILITY OF ESTABLISHING TRADITIONAL LAND USE DISTRICTS

Senate Concurrent Resolution 109/Senate Resolution 58 requests that the Office of Hawaiian Affairs and the Department of Land and Natural Resources (Department) form a traditional land use task force and provide a report to the legislature on the feasibility of establishing traditional land use districts. The Department offers the following comments.

The Department is cognizant of past land management practices during the time before Captain Cook came to Hawai'i, the changes that have occurred since then, and the challenges we face today as it relates to sustainability. The Department fully appreciates its public trust responsibility to protect traditional and customary Native Hawaiian rights.

The Department currently does not have the resources in its budget to support such a work group. In order for the Department to participate in such a work group, funding would have to be appropriated for that purpose.

The Office of Hawaiian Affairs (OHA) offers the following **COMMENTS** on SCR109/SR58, which would urge OHA and the Department of Land & Natural Resources (DLNR) to establish a traditional land use task force, to evaluate the feasibility of a new land use district where the perpetuation of traditional practices involving mālama 'āina may increase the food self-sufficiency and economic resilience of the state.

OHA appreciates these resolutions' description of how traditional land use practices and values can greatly improve the economic and food self-sufficiency of our islands. OHA recognizes the intersection between environmental protection, food security and cultural perpetuation, and has consistently advocated for policies that would promote all three areas. OHA understands that a traditional land use paradigm based on time-tested concepts, infrastructure and practices developed specifically for the unique characteristics of our island home may significantly advance the environmental, cultural and socioeconomic interests of the state.

However, given its size and responsibilities, OHA has concerns regarding the fiscal impacts and efficacy of requiring OHA to administer the task force proposed in these resolutions. Without commensurate financial support, the administrative burden of such a task force may divert resources that OHA currently uses to directly address immediate environmental, cultural and socioeconomic issues and concerns. In addition, OHA does not have any regulatory jurisdiction over land uses and does not own or control the substantial tracts of land necessary to implement the vision of these resolutions on a meaningful scale. **OHA** respectfully suggests that the traditional land use task force be placed within the **DLNR**, which may have the institutional capacity, relationships and regulatory jurisdiction to more appropriately and effectively facilitate and implement the tasks proposed in these resolutions.

REQUESTING THE OFFICE OF HAWAIIAN AFFARIS AND THE DEPARTMENT OF LAND AND NATURAL RESOURCES TO FORM A TRADITIONAL LAND USE TASK FORCE AND PROVIDE A REPORT TO THE LEGISLATURE ON THE FEASIBILITY OF ESTABLISHING TRADITIONAL LAND USE DISTRICTS.

Senate Concurrent Resolution 109 and Senate Resolution 58 reiterates the State of Hawaii's responsibility to the public trust through the Hawaii State Constitution to conserve and protect Hawaii's natural resources for the benefit of present and future generations. This public trust responsibility extends to the protection of traditional and customary native Hawaiian rights including the native Hawaiian tradition of kuleana to malama'aina.

These resolutions also recognize the utilization of the konohiki system; a traditional resource management tool that can be of assistance to the state in their efforts to enforce sustainability and protection of our fragile ecosystem. Traditional resource management is based on the expert understanding of site-specific areas and their resources by konohiki, those versed in the management of resources through expertise handed down by kupuna for generations.

One of the purposes of Act 288, Hawaii Session Laws 2012, under which the Aha Moku Advisory Committee (Committee) is established is to "formally recognize the Aha Moku System, a system of best practices that is based upon the indigenous resource management practices of moku boundaries, which acknowledges the natural contours of land, the specific resources located within those areas, and the methodology necessary to sustain resources and the community."

Under Act 288, the Committee may provide advice on the following:

1) Integrating indigenous resource management practices with western practices in each moku;

- 2) Identifying a comprehensive set of indigenous practices for natural resource management;
- 3) Fostering the understanding and practical use of native Hawaiian knowledge, methodology, and expertise;
- 4) Sustaining the State's marine, land, cultural, agricultural, and natural resources;
- 5) Providing community education and fostering cultural awareness on the benefits of the aha moku system;
- 6) Fostering protection and conservation of the State's natural resources; and,
- 7) Developing an administrative structure that oversees the aha moku system.

The Aha Moku System is inclusive of eight main Hawaiian Islands and forty-three (43) traditional moku districts. Within these districts the konohiki management system still exists but needs to adapt to contemporary times to address current resource issues such as climate change, sea level rise and other current resource problems impacting our groundwater, wetlands, estuaries and agriculture production.

To fulfill the mandates of Act 288, the Committee has begun the templates and discussion on reinstating the traditional konohiki resource management system throughout the pae'aina, but recognizes the enormity of the project if done only by the Committee. We also recognize and support the advantages of partnering and working within a Traditional Land Use Task Force. We welcome the opportunity to share our traditional resource knowledge that is site-specific with the other proposed task force members in the hope that together, we can not only sustain our unique and different ecosystems throughout the Hawaiian islands,, but perpetuate and protect the distinctive cultural heritage of each island through the practices of the konohiki.

We are strongly in support of these measures and urge the Committees to pass S.C.R. 109 and S.R. 58.
