Senate Concurrent Resolution 144 Proposed Senate Draft 1/House Resolution 80 requests that the Senate of the Twenty-seventh Legislature of the State of Hawai'i, Regular Session of 2014, support Hawaii's bid to host the 2016 World Conservation Congress of the International Union for Conservation of Nature. **The Department of Land and Natural Resources (Department) is in strong support of these resolutions and provides the following comments.**

- The Department has been directly involved in the bid to host the 2016 World Conservation Congress (WCC) of the International Union for Conservation of Nature (IUCN) since 2009.
- In 2010 the Department supported a similar resolution.
- In 2012 the Department sent a delegation to the WCC in Jeju, Korea to support Hawaii's bid.
- The Department worked with the Governor's office to host the IUCN WCC Site Selection Committee in February of this year.
- The Department requested legislative support in our 2015 administrative budget request to support the efforts of implementing the Congress.

The Department sees hosting the IUCN WCC 2016 as a unique and valuable opportunity to show the international community that Hawaii is a world leader in sustainability and environmental issues. The IUCN WCC 2016 is expected to bring together over 8000 delegates from 160 different countries. Out of 18 original bids, Hawaii and Turkey remain with the final selection expected in May, 2014.


