I strongly support this bill.

SCR 51 is requesting the administration of a youth risk behavior survey to students in grades six to twelve in order to assess the leading factors of death, disability, and health complications among youth and to improve health education programs.

According to West Hawaii Today "Key indicators of youth suicide (ages 10-24) in Hawaii have dropped since 2005, according to the federal Centers for Disease Control and Prevention's 2011 study of youth behavior. Youth that have seriously considered suicide fell from 18.5 percent of the population to 16.1 percent, and actual suicide attempts dropped from 12 percent to 8.6 percent. But those percentages for Hawaii youth are still higher than national averages in 2011". - See more at:

Dear Chairs Tokuda and Chun Oakland, Vice Chairs Kidani and Green, and Committee Members:

This testimony is submitted support for SCR51, requesting the administration of the Youth Risk Behavior Survey in grades six to twelve.

The Hui for Excellence in Education (HE'E) is a diverse coalition of over 40 parent and community organizations dedicated to improving student achievement by increasing family and community engagement and partnerships in our schools. Our member list is attached.

The Coalition likes the Youth Risk Behavior Survey (YRBS) because it is a federal survey, which is widely viewed and allows Hawaii to be compared with other states and the nation. Further, the questionnaire asks specific questions about risk behavior, which may help inform the Department of Education and the Board of Education on risk behavior trends, and consequently help shape policy and planning decisions. Among the topics that are covered in the survey, bullying, physical fighting, depression and attempted suicide are of particular interest to families, with the feeling that if students do not feel safe they will not be able to learn.

As with all surveys, in order for them to be effective, an adequate response rate is critical. We learned that currently, one obstacle about the YRBS was that a parent would have to give consent for a student to take the survey. This bill allows a student not to take the survey only if there is written permission from the parent. This opt-out clause, we believe, will result in more students being able to take the survey, improving response rates. The Coalition also supports the broadening of participation to include private schools students to allow for a meaningful representation for the students of Hawaii.

Thank you for the opportunity to testify and for your consideration. Our support of this bill represents a 75% consensus or more of our membership.
