Comments: We are in FULL SUPPORT of SCR56. Pacific Shipyards International (PSI) has operated a commercial ship repair facility in Honolulu Harbor since 1920 and our tax revenues and 200+ high-paying jobs are important to Hawaii's economy, maritime community, and port security. Hawaii's marine industry needs and desires PSI's drydock facility in Honolulu Harbor, the state's only drydocks capable of servicing inter-island cargo fleets. There are no replacement companies and Hawaii-based vessels will be forced to go to the mainland for drydocking, significantly increasing costs to Hawaii taxpayers. PSI provides essential drydocking capability for Hawaii at large capital and operating costs. PSI is being forced by the State to move out of Pier 41 and relocate to Piers 24-26 and submerged lands for the property bound by Piers 24-26 are needed for shipyard drydock operations and vessels under repair as part of the lease agreement. PSI has been told by DOT-Harbors that we will be moved by the end of June 2014 and SUBMERGED LANDS ARE CENTRAL AND NECESSARY FOR OUR OPERATIONS. This resolution simply authorizes the Board of Land & Natural Resources the ability to issue the submerged lands lease coextensive with the ground lease. WE HAVE MET WITH BOTH DLNR and DOT AND LANGUAGE IN THIS RESOLUTION WAS AGREED UPON BY ALL PARTIES.
