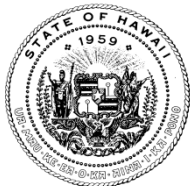

Senate Committee on Ways and Means

The Department of Transportation (DOT) provides the following comments on this resolution to authorize the issuance of a lease covering State submerged lands at Piers 24 to 26 in Honolulu Harbor to Pacific Shipyards International (PSI).

We believe that this resolution is premature as any action that proposes the use of State lands and/or State funds triggers the requirements of Chapter 343, Hawaii Revised Statutes. Further, administrative action to issue a lease for the proposed ship repair facility has not been brought before the Board of Land and Natural Resources for its deliberations.

Presently, the Kapalama Container Terminal and Tenant Relocations, Second Draft Environmental Impact Statement (DEIS) is under environmental review and only after the Final Environmental Impact Statement (FEIS) has been accepted may any proposed lease action be implemented.

PACIFIC SHIPYARDS INTERNATIONAL

Senate Concurrent Resolution 56 requests the authorization to issue a lease covering a portion of state submerged lands at Piers 24 to 26 in Honolulu Harbor, Oahu for shipyard and drydock operations and for vessels under repair, pursuant to Section 171-53, Hawaii Revised Statutes (HRS). **The Department of Land and Natural Resources (“Department”) opposes this concurrent resolution and offers the following comments.**

The Department considers the subject resolution to be premature. The submerged lands at Piers 24 to 26 are under the jurisdiction of the Department of Transportation (“DOT”) pursuant to a Governor’s executive order. Before the subject submerged lands can be leased to Pacific Shipyards International (PSI), DOT would first have to approve the terms and conditions of the lease, and the Board of Land and Natural Resources (“Board”) would have to consent to it, pursuant to Section 171-11, HRS. Once the necessary approval and consent are secured, the proposed lease would then be presented to the Legislature for approval.

Our understanding is that DOT has not yet approved the issuance of lease to PSI, and the Board has not consented to it. As such, there are no lease terms or conditions for the Legislature to consider and approve, and the resolution is therefore premature.

Comments: We are in FULL SUPPORT of SCR56. Pacific Shipyards International (PSI) has operated a commercial ship repair facility in Honolulu Harbor since 1920 and our tax revenues and 200+ high-paying jobs are important to Hawaii's economy, maritime community, and port security. Hawaii's marine industry needs and desires PSI's drydock facility in Honolulu Harbor, the state's only drydocks capable of servicing inter-island cargo fleets. There are no replacement companies and Hawaii-based vessels will be forced to go to the mainland for drydocking, significantly increasing costs to Hawaii taxpayers. PSI provides essential drydocking capability for Hawaii at large capital and operating costs. PSI is being forced by the State to move out of Pier 41 and relocate to Piers 24-26 and submerged lands for the property bound by Piers 24-26 are needed for shipyard drydock operations and vessels under repair as part of the lease agreement. PSI has been told by DOT-Harbors that we will be moved by the end of June 2014 and SUBMERGED LANDS ARE CENTRAL AND NECESSARY FOR OUR OPERATIONS. This resolution simply authorizes the Board of Land & Natural Resources the ability to issue the submerged lands lease coextensive with the ground lease.
