Chairs Espero, Wakai, Vice Chairs Baker, Nishihara, and Members of the Committees:

I am Keone Kali, Chief Information Officer in the Office of Information Management and Technology (OIMT), speaking in support of the intent of S.C.R. 107 (Companion to S.R. 63) to work with the High Technology Development Corporation and Department of Accounting and General Services to Establish a Public Safety Technology Campus and Cyber Security Command Center.

The OIMT is undertaking a multi-year program to improve the reliability, availability, and capabilities of the State's data processing and communications infrastructure which support all State departments, including emergency response and public safety agencies. Specific actions include developing a centralized security operations center that coordinates State cyber security activities; and moving State's data centers and critical network switching centers from the Honolulu Civic Center to locations that will likely survive tsunamis, hurricanes, and other disasters. The OIMT has arrangements with several Oahu commercial data center service providers and with the High Technology Development Corporation and the Pacific Disaster Center on Maui to serve as backup facilities, and is exploring options at the University of Hawaii and County facilities.

The proposed resolutions are consistent with OIMT's objective to create a much needed secure, survivable state-operated facility for the State's data systems and cyber security operations. When building that facility, OIMT will work closely with other named agencies to share its data center, communications, and cyber security planning and operational experience; and OIMT's data center consultants are available to assist. The OIMT defers to DAGS to undertake design and construction tasks; to Budget and Finance about funding options; to the High Technology Development Corporation to operate the facilities; and to the State Department of Defense to work with the first responder and law enforcement agencies who will occupy the facilities.

We thank the Committee for this opportunity to testify in support of the intent of this resolution that supports protecting the State's critical infrastructure, sharing our resources, and improving our public safety.
