In support of <u>S.R. NO.8 S.D.1 Proposed</u>- THE UNITED STATES TO SUPPORT THE REPUBLIC OF CHINA'S (TAIWAN) PARTICIPATION IN THE TRANS-PACIFIC PARTNERSHIP (TPP).

In 2009, President Obama announced *Rebalancing to Asia*. The implications of the policy include not only the political, security and strategic levels; through the Asia-Pacific countries must integrate into the regional economic organizations as well. The US-led TPP is relatively getting important.

In his 2014 New Year Address, President Ma Ying-jeou announced that Taiwan will make its best efforts to participate in TPP and other regional economic integration mechanism for our own and international community's benefits.

Taiwan is full members of WTO and APEC, and it interacts with the member economies equally and positively over the years. It is also committed to multilateral economic development and participates actively in the negotiations and initiatives. However, as you know, APEC is a loose organization and lots of issues and negotiations in WTO are stalled. Instead, bilateral and regional free trade agreements have become the trends of the world.

In 2013, Taiwan has signed economic agreements respectively with New Zealand and Singapore, members of TPP. The scopes of these two agreements are much wider than those of WTO and APEC. Taiwan has a very close relationship with TPP members, and trade between Taiwan and the 12 TPP members account for 35% of its total foreign trade. If Taiwan joins the TPP, it will be the 6th-largest economy in TPP. Taiwan is ready and qualified to join TPP as a member to provide more contributions to the international economic community. We believe that our participation in TPP not only share the fruits of free trade among the TPP members, but also further enhance and strengthen the bonds of businesses between the people of Taiwan and USA.

Hawaii and Taiwan enjoy a closed relationship. I appreciate your long-term support. I also would like to thank you, Chair English and members of TIA to take initiative step in drafting this meaningful resolution to urge the United States to support the ROC's (Taiwan) participation in the Trans-Pacific Partnership (TPP). Thank you.

Comments: Honorable Kalani English and Donovan Dela Cruz I strongly oppose SR8 on the grounds that this resolution is duplicitous and is using both the Philippines and Taiwan to further escalate military tensions between the US and China. It should be known that reestablishing relations between the State of Hawaii and the Province of Ilocos Norte of the Republic of the Philippines includes extending commitments with Governor Imee Marcos, the daughter of deposed President Ferdinand Marcos, and where Clark Air Force base is located. Not coincidentally, there have also been ongoing military skirmishes with China over the long-time contested Spratly islands. We also not want to see Hawaii committed to the militarization of the "Trans Pacific Strategic Economic Partnership." President Ma of Taiwan has close relations to both Washington and Beijing, and although there have been recent protests against Taiwan joining Beijing's Regional Comprehensive Economic Partnership-- China's version of the TPP-- we do not want to see any further escalation of violence in Taiwan over participation in the TPP as this will only further encourage military tensions. Although it may not be so apparent, SR8 is tied to committee hearings recently held in Washington on the "Rebalancing to Asia" by the House Armed Services Committee, and we do not want to use the TPP as a measure to contain China in such a way, that will force China to have to respond to any kind of economic or strategic containment strategy that seeks to choke and militarize China's shipping and trade. Honorable members of the Committee on Transportation and International Affairs, if you are proposing to create these partnerships as a means to show strategic and military support, please do so and we can address those resolutions directly, but I ask that you not use SR8 as a back door for militarization. Also, understanding that the Center for Pacific Command is tasked with providing security to both the US and our allies, SR8 should not be used as a means to escalate regional tensions just because Hawaii is at the center of the Pacific theater. Hawaii needs to uphold the principle of peace in the Pacific and SR8 provokes a very dangerous agenda that threatens regional stability. I strongly oppose SR8.
