#### 1. A brief description of the applicant's background

Celebrating its 100<sup>th</sup> season in 2015, Diamond Head Theatre (DHT) is a theatrical and cultural gathering place that not only entertains, but informs, educates and provides meaningful volunteer opportunities for keiki to kupuna.

A non-profit community theatre founded by New England missionary families in 1915, DHT started out as "The Footlights" and was later re-named "Honolulu Community Theatre. It holds the distinction of being the third oldest continually operating community theatre in the nation.

Diamond Head Theatre offers six theatrical productions each season to over 40,000 theatregoers, presenting the latest musicals, plays and traditional favorites. Our shows are cast, built and produced with the help of hundreds of volunteers, including the actors themselves, who contribute their time, talent and energy under the guidance of our small theatre staff.

DHT also offers comprehensive performing arts training in voice, dance and acting to the community through special workshops and regular class sessions. Over 1,000 children and adults participate in these classes annually. Musical Theatre Experience is our summer musical theatre camp with over 75 children ranging from 7-16 years old attending our 7-week program. Any child is welcome, no prior experience required.

Finally, we are the proud developers of a youth performing ensemble, the Diamond Head Theatre Shooting Stars. The 45-member Stars take weekly classes in all aspects of the performing arts; they entertain at community and charitable functions around Oahu and they appear as seasoned "professionals' in many of our main stage productions.

#### 2. The goals and objectives related to the request

The Diamond Head Theatre facility also known as Fort Ruger Theatre was built in the 1930's as a USO theatre. It has been minimally upgraded over the years but essentially is

the same structure which the Army turned over to the State in the early 1950's. The State then leased the theatre to Honolulu Community Theatre (HCT). HCT became "Diamond Head Theatre" in 1990. The State lease is housed in DLNR and the current agreement ends in 2073.

The building is rapidly decaying. We have shored it up as much as possible over the last 63 years of our residency but the time had come to make a decision on its deterioration. We contracted a professional top-to-bottom building assessment and it was determined that a new theatre was the most viable answer. From that step, we moved to a site development plan and it was found we have room to build a second building while still operating our current facility (which will be torn down once we move into the new theatre). We then hired an architect, Urban Works, and with their designs are now in the process of an Environmental Assessment (EA).

The goal is a new theatre. Our most immediate objective is to complete the entitlements process including the EA. Community response has very positive so we expect that process to be completed by early 2016. The schematic building designs are close to done and renderings are being finalized. The designs portray a theatre with expanded classroom space, one that will be safe and efficient, but retaining the charm of the current intimate space.

Next on tap will be the construction design documents and then bids and construction mobilization. For all of these steps, we need financial help from the community, from corporations, from foundations and from the State of Hawaii. The State of Hawaii would be asked for a 10% match of individual donor, corporate and foundation funds to finance the \$20 million project.

Diamond Head Theatre has not come to the State of Hawaii for any funding for over thirty years. The theatre has operated with a balanced budget, with no deficit for the last twenty years. As DHT is a truly a statewide treasure (we have patrons from every island), we seek the partnership of the State of Hawaii to fulfill the goal to build a new theatre.

#### 3. The public purpose and need to be served

We all know that cultural activity can be transformative; personally enriching and can improve the quality of life. Diamond Head Theatre brings entertainment and joy to Hawaii's community -- whether on stage, in the audience, in a class or as a working volunteer.

Second, our theatre contributes to the economic engine whether by running our \$2 million small business with vendors and operational costs, or by filling the nearby restaurants.

Third, we are contributing to community-building, by nurturing a future cadre of community leaders...leaders who will come from children in our performing arts program who have learned discipline, have learned to balance priorities; have learned how to get

along in a "team" and have learned how to complete a final project such as a show or recital.

Fourth, to maintain the ebb and flow of a city, we need new people and new ideas. The arts draw residents. It has been well documented that symphonies, museums and theatres are critical elements to creating a desirable and livable city. We are Hawaii's theatre.

And last but not least, a happy lifestyle is a healthy lifestyle. Who will take care of those less fortunate? The healthy population. We make people happy and keep them healthy much like any community or wellness center would.

Our theatre is island wide, though largely populated by Oahu residents. Our patrons' ages range from toddlers to super seniors and our volunteer ages mirror that range---from high school students building sets to super senior usher and ticket takers. We target all ages for our performing arts programs--our classes are diverse, from Baby Ballet (5+yrs.) to The Silver (60+yrs.) Stars. Our shows are cast color blind—roles are filled by all ethnicities, and our productions are attended by families, friends, co-workers and neighbors.

To assure the plans would meet the unique needs of the theatre, we have in addition to our highly respected local architect, hired a national theatre design firm. Both of these companies ran charrettes with the staff and Board to determine the best use of the space with respect given to the surrounding neighborhood.

DHT will go through a bid process to hire a licensed developer/construction firm and our project manager, Fray Heath will oversee construction. Close monitoring and evaluation will be the task of the Facilities Committee who will report on progress monthly to the DHT Board of Directors

Both Tammy and Deena will work closely with the Board of Directors who are currently active in all aspects of the theatre. Several Directors have been recruited recently to help with this endeavor.

Deena, the Facility Committee of the Board and the Leadership Council (capital campaign team) will work with Fray Heath of Heath Construction Services, Inc., Urban Works Architects, Schuler Shook Theatre Designers to design and construct the new theatre and Campbell & Co. to raise the necessary funds.


