# I. Background and Summary

1. Description of HUGS (Help Understanding & Group Support for Hawaii's Seriously Ill Children and Their Families)

The mission of HUGS, a 501(c)(3) organization incorporated in 1982, is to improve the quality of life for Hawaii's families as they face the emotional and financial hardships of caring for a seriously ill child. HUGS annually serves over 250 families statewide who have children suffering from a life-threatening medical condition through programs and services that address their emotional, social, physical and financial needs. The overall goal of HUGS is to strengthen the whole family by meeting the needs of each family member from the time of crisis in initial diagnosis and throughout their long, challenging journey to remission or bereavement and beyond.

In its 33 years of experience of working closely with these families, HUGS recognizes that each family member is impacted differently by childhood illness, and has developed supportive programs specifically for each family member – the ill child, mothers, fathers, and siblings. HUGS also utilizes informal, natural strategies to build, facilitate and sustain community-based support networks to provide the information and emotional support that these families need to carry them through their challenges. Our programs and services include:

- Peer to Peer Support activities, such as Family Dinners and Moms and Dads Nights, and Teen groups, which provide a safe environment for affected family members to network, share useful information, express their emotions and reduce social isolation with others in similar situations;
- Monthly and Emergency Respite services to provide children and youth
  with nurturing, positive activities while their parents receive needed relief
  from the stresses of caregiving. Trained volunteers serve as "buddies" or
  mentors to provide individualized attention to each child.
- Weekly Hospital Visits and interactive activities for hospitalized children and youth to relieve the anxiety and stress of long term and/or multiple hospitalizations at HUGS' partner hospitals, Kapiolani Medical Center for Women & Children, Kaiser Medical Center and Tripler Medical Center;
- **Bi-monthly follow up contact** with each family to monitor their child's progress and assess additional family needs;
- Sibling Support activities to assist siblings of seriously ill children to process and understand their own emotions about their siblings' illness; and

 Financial Assistance for emergency airfare from the neighbor islands or to the mainland for specialized medical treatment as well as emergency food or funeral assistance.

No fees are assessed to families for HUGS services due to the financial hardships of the large medical bills that they face.

### 2. Goals and Objectives Related To The Request

Goal 1: To reduce stress, anxiety and social isolation among seriously ill children and their family members.

Objective 1: To provide 4 peer group activities for 15 Moms of HUGS children in West and Central Oahu.

Objective 2: To provide 4 peer group activities for 10 Dads of HUGS children in West and Central Oahu.

Objective 3: To provide 4 Teen group activities for 10 teen ill children and their siblings in West and Central Oahu.

Objective 4: To provide respite services for 25 ill children and their siblings in West and Central Oahu.

Goal 2: To develop long term, sustainable support networks among HUGS families.

Objective 1: To provide 4 peer group activities for 15 Moms of HUGS children in West and Central Oahu.

Objective 2: To provide 4 peer group activities for 10 Dads of HUGS children in West and Central Oahu.

Objective 3: To provide 4 Teen group activities for 10 teen ill children and their siblings in West and Central Oahu.

Objective 4: To provide respite services for 25 ill children and their siblings in West and Central Oahu.

Goal 3: To increase access to HUGS programs by families residing in West and Central Oahu.

Objective 1: To provide 4 peer group activities for 15 Moms of HUGS children in West and Central Oahu locations.

Objective 2: To provide 4 peer group activities for 10 Dads of HUGS children in West and Central Oahu locations.

Objective 3: To provide 4 Teen group activities for 10 teen ill children and their siblings in West and Central Oahu locations.

Objective 4: To provide respite services for 25 ill children and their siblings in West and Central Oahu locations.

Goal 4: To recruit, train and supervise 25 volunteers to assist in implementing peer support and respite activities in West and Central Oahu.

Objective 1: To recruit and train 25 volunteers from West and Central Oahu resources.

Objective 2: To conduct at least 2 volunteer training sessions.

Objective 3: To supervise and evaluate volunteer involvement in project activities.

## 3. The Public Purpose and Need To Be Served

According to the American Academy of Pediatrics (Journal of American Academy of Pediatrics, Shudy, Almeida, et.al., 2006), critical illness in childhood impact the entire family and can "exhaust family finances, relationships and coping abilities." Initial diagnosis is usually very sudden, require immediate treatment and create great stress and confusion on the family. This stress usually continues throughout medical treatment, often several years. These families become at-risk for family dysfunction and individual family members can suffer from depression, chronic anxiety and negative behaviors, especially for siblings who are often 'forgotten'.

Other documented research state that the continual stress and anxiety of dealing with childhood illness place individual family members at high risk of depression, sustained anxiety, emotional exhaustion, negative behaviors which can lead to family dysfunction. The Health Science Journal (Theofanidis, et.al., 2007) reports that establishing and maintaining support systems, such as peer support, is critical for each member of the family to "develop effective coping strategies" that impact their ability to manage their stress levels and psychological well-being as they navigate through the challenges of their child's illness. Numerous research studies have identified that social support is crucial for parents to successfully cope and adapt to the child's serious illness (Mastroyannopoulou, Stallard, Lewis & Lenton, 1997). Parents experiencing stress as a result of their child's serious illness have described the need for informational, emotional and practical support and expressed the view that informal support (e.g. parent to parent) was more significant to them than formal social support (e.g. a professionally-led support group (Beckman, 1991; Cohen, 1999, Mercer & Ritchie, 1997).

Thirty-two (32) years of experience also has taught us that the very best support for families with a child who has a life-threatening illness comes from other families who share a common plight. Families who have lived through their own personal medical crisises with their children offer unique support systems to families with new diagnoses. Children interacting with each other in similar situations have a connection that normalizes their fears and concerns. The results of these facilitated relationships are the long term sustainability and continual supportive relationships that empower families through the progression, remission and sometimes reoccurance of the illness.

HUGS Peer Support Programs are uniquely designed to facilitate and nurture relationships among newly diagnosed families and current family members to build long term community support networks that can be sustained throughout their many challenges of childhood illness. HUGS recognizes that childhood illness impacts each member of the family differently, and therefore, has specific peer support programs for Moms, Dads, Teens and Siblings. These programs provide opportunities for specific family members to meet each other, exchange information, share common experiences and emotions, engage in activities for which they normally do not have financial resources, and enjoy time away from the daily challenges of caring for a seriously ill child in informal settings. Our Respite Program provides needed relief for parents to have time for themselves as a couple while providing opportunities for both the ill child and their siblings to experience play in a safe, nurturing environment without fear or concern for exposure that will compromise their fragile health or insensitive comments from others.

HUGS' current peer support programs for Moms, Dads, Teens and its Respite Program are conducted in community sites in Honolulu or at the HUGS Center in Kaimuki. However, the location of these activities have been difficult to access for many family members. Over 48% of HUGS families reside in Central or West Oahu. Oahu's continual road construction and daily heavy traffic congestion in the area add to the barriers that prevent participation of HUGS families who reside in West and Central Oahu, as expressed in a 2014 survey of families. The proposed program will conduct peer support programs in their communities and address their needs for social connections and building support networks.

#### 4. Target Population To Be Served

HUGS serves children and youth, ages birth to 21 years old, with life-threatening illnesses and their families throughout the State of Hawaii. They suffer from a variety of life-threatening diseases: 25.12% cardiac diseases; 55.45% cancer; and 19.43% other illnesses, including rare diseases. Sixty-six percent (66%) of HUGS families have household incomes at 150% or below federal poverty guidelines. Eighteen percent (18%) of HUGS families are active duty members of the military whose child became suddenly ill and transported to Tripler Medical Center for emergency treatment. These families are most at-risk of isolation as they are away from family and established resources for support.

Families are referred to HUGS by physicians and social workers from its three partner medical facilities – Kapiolani Medical Center for Women & Children, Kaiser Medical Center and Tripler Medical Center. Referrals are also made by other community resources, such as Department of Health and nonprofit agencies, statewide. Seriously ill children from the Neighbor Islands usually are sent to Honolulu medical facilities for in-hospital treatment and follow up treatments.

The target population to be served through this project is children with lifethreatening illnesses, their siblings and family members, including those residing in the West and Central Oahu area.

## 5. Geographic Coverage

HUGS serves seriously ill children and their families who reside on the islands of Hawaii, Maui, Lanai, Molokai, Kauai and Oahu. The proposed project addresses the needs of families residing in West and Central Oahu.

# II. Service Summary and Outcomes

1. Scope of Work, Tasks and Responsibilities & Projected Annual Timeline
Under the supervision of the HUGS Director of Programs and in coordination
with the HUGS Program Manager, one (1) .80 FTE Program Specialist will be
hired to plan, coordinate and implement the proposed peer support and respite
activities in West and Central Oahu. HUGS will seek potential partnerships with
community sites and resources to support this project. The Program Specialist will
be responsible for identifying and securing appropriate venues, resources and
activities in West and Central Oahu for each peer group activity (16 total during
the project period). He/she will also be responsible for recruiting, training and
supervising 25 volunteers to support the proposed activities. He/she will also
create information tools to communicate with families, conduct and document
follow up calls with families to assess their progress, and administer evaluation
tools.

Peer group and respite activities will be held on a quarterly basis in addition to regular programming at the HUGS Center. These events will be open to all family members regardless of the location of their residence in order to maximize the opportunity to establish support networks among a variety of participants.

The HUGS Director of Programs and Executive Director will be responsible for monitoring overall progress of the project and completing required program and fiscal reports.

The following service outcomes will be met through this proposal:

- 80% of participants (Moms, Dads, and Teens) in HUGS' peer support
  programs will report a decrease in their stress and anxiety levels as a result
  of establishing relationships with others who have a child with a serious
  illness
- 80% of the children with a serious illness engaged in HUGS services and programs will report higher self-esteem and improved positive peer relationships.
- 65% of the participating Teens will report an increase in their feelings of self-esteem and improved positive peer relationships.

 20% increase in the number of partnerships between HUGS and community organizations and volunteers.

# 2. Quality Assurance and Evaluation

HUGS conducts an initial assessment of family members upon entry into the program to identify needs of family members, gather baseline data of their emotional, social and financial status as well as to develop service plans if needed. Individual and family member group charts will be maintained and regularly updated. Chart reviews are a regular part of bi-weekly supervision with staff to maintain compliance with agency and best practice standard and to ensure programs goals and objectives are being met. This is also a time in which program staff will monitor and evaluate progress of program goals and service outcomes and to make necessary program adjustments as needed in a timely fashion.

#### 3. Measures of Effectiveness

There are several evaluative tools that HUGS utilizes to measure services and programs.

- Post-Event and Client Satisfaction surveys will be completed by participants. The objective of these surveys is to explore what went well and which areas need improvement. In addition, the survey is designed to review quantitative and qualitative information in order to improve the activity/event.
- Social Connections survey will be completed by parents to assess their stress and anxiety levels at mid-term and at the end of the project period.

Assisting parents to build a social network goes a long way to decreasing their sense of isolation and increasing their parental resiliency. Facilitating parent problem solving, place difficulties and challenges in perspective, and draw on trusting relationships and other resources helps to alleviate stress and anxiety when a family is under stress.

• Rosenberg Self-Esteem Scale will be administered to participating children youth and their siblings. It is a research validated tool with high reliability and validity. It is a self-report scale with scores ranging from 0-30 with higher scores indicating high self-esteem and lower scores indicating lower self-esteem. There are no distinct ranges, and scores between 15 and 25 suggest a normal level of self-esteem. The scale includes 10 items scored from strongly agree to strongly disagree. This instrument will be used to gauge general movement in self-esteem and to assist in program development to ensure progress. Participating ill children and youth will be administered this self-esteem scale at the time of initial assessment, mid-year and after the project period. HUGS tracks the level of participation of each activities. This tracking allows for better planning events and activities.

## A. Necessary Skills and Experience

HUGS has provided supportive programs and services for seriously ill children and their families for the past 33 years. HUGS has an extensive corps of 300 volunteers and a strong community partnership network which include nonprofit organizations, such as Ronald McDonald House of Hawaii, Make a Wish Foundation, and Hospice Hawaii; educational institutions, such as University of Hawaii at Manoa, John A. Burns School of Medicine, Kapiolani Community College and private schools; and for profit corporations, small businesses, and community organizations.

The HUGS Executive Director has 37 years of nonprofit program and administrative experience as well as legislative/government contract management experience. She has managed both City and State government grants for the past 8 years and served as Executive Director for 3 nonprofit organizations. The HUGS Board of Directors Program Committee work directly with staff to ensure the highest program standards are maintained. This Committee includes the Director of Pediatrics and Critical Care at a major medical center and a former chief financial officer of a large nonprofit organization and 3 parents of former HUGS children.

HUGS' Director of Programs has a Masters of Social Work degree with over 20 years of experience working with families and vulnerable children in state government and the nonprofit sector. The Program Manager has a Bachelor's degree in Women's Studies and has over 3 years of experience planning and executing peer support activities at HUGS. Prospective candidates for the proposed Family Specialist I – West and Central Oahu will have a Bachelors in Social Work or related educational degree as well as 2 or more years of experience in working with families and children.

The HUGS offices are located at 3636 Kilauea Avenue in Kaimuki, Oahu in a house formerly occupied by physicians at Leahi Hospital. Over 80% of HUGS

programs are implemented on site; however, community sites are also utilized for some program activities. A small playground and large open area is available for use by HUGS children and families during program activities. HUGS offices and outdoor areas meet ADA compliance standards.

The proposed project will utilize appropriate public and private community locations and facilities for program activities in West and Central Oahu.
