I. BACKGROUND AND SUMMARY

Holy Family Catholic Academy (HFCA) was established in 1956 on unsecured property owned by the U.S. Navy located near the Honolulu Airport and Joint Base Pearl Harbor Hickam (JBPHH) between Valkenburg Street and Main Street to expressly serve the children of military personnel and families of local civilians employed at Pearl Harbor Naval Shipyard and Hickam Air Force Base. The K- 8th private religiously-affiliated elementary and middle school and its Early Learning Center for children ages 3-5 share a 4.4 acre campus with the adjacent Holy Family Catholic Church operating as one entity under the auspices of the Roman Catholic Church in the State of Hawaii. The church and school have owned and maintained the buildings located on the land parcel since inception.

The Diocese, on behalf of Holy Family Catholic Academy and Holy Family Church, purchased the HFCA land parcel from the Federal Government on November 20, 2014. The F-1 zoned property is now subject to the uses and standards of the City and County of Honolulu Land Use Ordinance, P-2 General Preservation District. A proposed zone change from F-1 District to R-5 Residential District and a Conditional Use Permit (CUP-minor) is necessary to implement desired redevelopment and improvements to the campus facilities and grounds.

Over the years and now, the school has served an enrollment of PK-8th students numbering between 550 and 600, 40-50% of whom have military association, and 50-60% from the local community. Approximately 100 faculty and staff members are employed on site to serve the school and parish community of 1,000+ members. Families choosing Holy Family Catholic Academy for their children's educational experience reside in military housing units close to campus, in on-base housing areas, or travel from various neighborhoods and locations all across Oahu to attend classes and participate in year-round activities and services provided by the school and parish.

Holy Family's recent acquisition of the land in an outright purchase of \$1.6M from the Federal Government after nearly a decade provides the long-awaited impetus to plan for and design for the future growth and stability of the site. With assured permanency, Holy Family can aspire to complete Master Planning efforts and Zoning changes that will result in the ability to initiate wide-scale renovations and urgent R & M improvements, eventually undertaking new construction on the property to better serve the community.

Holy Family currently has nearly \$3.5M in assets set aside for development of its campus and parish site to begin funding a multi-phase project to develop a <u>campus master plan</u> and to prepare <u>land use entitlements</u> to address much needed improvements to the campus site in support of the facilities' immediate and future needs. These strategic actions will enable Holy Family to continue to provide for the educational, spiritual, emotional, and social activities and requirements of its broad-based community. Heretofore, restrictions imposed by a tenant lease agreement with the U.S. Government have limited all capital

improvements to less than \$5,000 and made necessary wide-scale renovations and improvements virtually impossible. As landowners, Holy Family is now positioned to work toward the community's long-term sustainability.

Holy Family's immediate goals are two-fold: create a feasible Master Plan; and seek necessary zone changes and permits to renovate existing buildings on campus, and eventually demolish and replace temporary portable school buildings and aging classroom structures that have been added in a piecemeal fashion over the years. Planning for these initial measures will pave the way for new construction of permanent facilities that will likely include a new administration building, cafeteria, and combined parish and school gymnasium/ large gathering space with sufficient parking to better serve the community. It is necessary for the school and church to remain operational and viable during these reconstruction efforts. Phasing construction as a solution is intended as an integral part of the master development plan.

Funding through a Legislative Grant in Aid (GIA) for Capital Improvements will allow completion of all appropriate zoning changes as well as the creation of a well-constructed design plan and long range master plan to serve as a guide to achieve a secure and viable future and safe environment for Holy Family's current families and the many community members from the general public that have been successfully served for nearly 60 years.

Prudent fundraising efforts and visioning over the last decade have enabled the school and church to purchase the land from the U.S. Navy, and to set aside additional capital reserves toward necessary improvements and new construction. The Diocese of Honolulu will be a ready partner to assist in Holy Family's planning and to support its fundraising efforts.

II. SERVICE SUMMARY AND OUTCOMES

Holy Family Catholic Academy (HFCA) wishes to complete a multi-phase development effort that includes:

- A comprehensive development study to plan permanent improvements to the site, to revitalize the infrastructure, and to expand and renovate existing HFCA facilities.
- Preparation of a long range master plan for the 4.4 acre site that will accommodate the growth and vitality of Holy Family Catholic Academy and Early Learning Center and Holy Family Church and meet both current and future needs of the long-standing community.
- Preparation and processing of land use entitlements for the parcel of land recently acquired from the U.S. Navy to make possible permanent improvements within state, city, and county requirements.
- Future new construction of buildings and redevelopment of the site to include the updating and renovation of existing structures and infrastructure.

1. SCOPE OF WORK AND PROPOSED TASKS AND RESPONSIBILITIES

<u>Phase 1</u> – Master Planning Preparation/Proposed Tasks for HFCA's long-range master plan.

- Prepare a series of tasks and plan a schedule of work for much needed repairs and improvements to the campus and site so the school and church can remain operational during remodeling and reconstruction of existing facilities and construction of proposed new buildings to better serve its community and sustain its future viability.
- Assess the spatial requirements for Holy Family's buildings to meet its programmatic needs to include an inventory of existing facilities (primarily the main two-story classroom building and courtyard)—use, occupancy, floor area, age, height restrictions, parking, infrastructure, and other relevant data.
- Evaluate and research environmental site conditions, assess general topography from
 existing data, landscaping, traffic and circulation, historic significance, archaeology,
 existing infrastructure (sewer, water, storm water, power and data), easements, and
 both urgent R & M issues, and long range needs.
- 4. Meet with school administrators, faculty, parishioners, Diocesan personnel and other stakeholders to determine academic program requirements and support facilities for existing grade levels PK-8th, and to understand the functional relationships between the school and the church, and prioritize the needs for phasing the required work efforts.
- Develop a Master Plan schedule for the Holy Family site.
 - a. Prepare a conceptual redevelopment master plan to align with and support Holy Family's projected spatial requirements and its mission with rough costs estimates of new construction and other improvements.
 - Conduct design charrettes with the school and church community and all stakeholders as a baseline to define project aspirations and major goals.
- Prepare a Master Plan Report to concurrently support a zone change and other land use entitlements to guide the design and construction of Holy Family's improvements.

Phase 2 - Entitlements/Proposed Tasks for preparation and processing of land use permits.

- Achievement of Holy Family's approved Master Plan study, optimally followed up with the concurrent completion of the entitlement process requirements.
- Strategize time lines and establish phases associated with master plan ideas and requirements of land use permits and the ability to remain operational as a school and parish during the entire process.
- 3. Meet with City and County Department of Planning and Permitting (DPP) to review plans and land use permit options.
- 4. Make application for a Zone Change to R-5 from P-2 with approved Conditional Use Permit (CUP) (minor) with DPP, the Honolulu Planning Commission, and the Honolulu City Council with consultation with the area Neighborhood Board.
- 5. Prepare and process CUP (minor) with DPP.

2. ANNUAL TIMELINE

Completion of the first two planned phases of Holy Family Catholic Academy's proposed multiphase project which includes:

Phase One Tasks—Facilities Improvements and Programmatic Assessment; Comprehensive Planning Study to Evaluate Uses on the Site; and Development of the Site Master Plan is anticipated taking approximately six months to complete. This schedule is predicated on timely user input, availability of meetings, and timely approvals and decisions.

Phase Two Tasks—Land Use Permitting Services + Zone Change Process will likely take six months to finalize and CUP, (Minor), six months.

Total time for both Phase I and Phase II given a best case scenario is 1-1½ years.

3. QUALITY ASSURANCE AND EVALUATION PLAN

Holy Family Catholic Academy has met with different reputable contractors licensed by the State of Hawaii and has received bids for Master Planning Initiatives and Land Use Planning Services ranging from \$173,520.63 to \$430,718.00 for the nature and scope of the requested proposal, not including cost estimates for any long range new construction dreams. The three companies under consideration at this time have submitted breakdowns of their proposed services for Master Planning and Land Entitlement issues aligned with industry standards. The project includes a management component to provide oversight of the subcontractors' attention to all codes of standards. Subcontractors will report architectural, electrical, engineering, archaeology, and cost estimations. All criteria and requirements of the work will be communicated in writing. The cost of renovations and improvements to existing structures and future new construction has yet to be determined.

4. MEASURE(S) OF EFFECTIVENESS

The Master Planning process will meet salient principles in U.S. Green Building Councils LEED and will include consideration of passive, hybrid, and mixed mode building design options. It will incorporate sustainable campus planning practices from the infrastructure planning through the site planning and ultimately create a feasible plan that is a platform for low-energy, high performance campus building design and operations with sustainability concepts and practices incorporated throughout.

Facilities improvements will correspond directly to the determinations acquired from the buildings' assessments conducted at two levels: urgent R & M needed for direct and immediate support of the project; and midterm/long term R & M aligned with programmatic forecasts for desired new construction.

Planning for architecture, mechanical, electrical, structural, and civil engineering components will be assessed visually. All scheduling and costs for specific repairs and improvements will be estimated and duly reported for approval and authorization.

The outcome of the assessment plan will form the framework of the total deliverables settled upon. Interactively with the contractor, a qualified plan manager and the Diocesan leadership team will provide the collaborative guidance and project oversight required in the areas of finance, construction, fundraising, school and pastoral planning, and real estate to accomplish the church's and school's planned objectives for the site's future.

- 3. No other sources of funding are sought for fiscal year 2016. Holy Family has monies in reserve to support the beginning phases (Phase I and Phase II) of the multiphase project.
- 4. Holy Family has not been granted any state and federal tax credits that pertain to any capital project.
- 5. Holy Family has not received program funding from any government contracts or grants nor has funding been requested here-to-date.
- Holy Family's unrestricted current assets as of December 31, 2014 are \$3,051,993.96 (see attached)

IV. EXPERIENCE AND CAPABILITY

A. Necessary Skills and Experience

Holy Family Church and Holy Family Catholic Academy and Early Learning Center began operating as an educational and religious organization during WWII to render numerous services to Hawaii-based military families assigned to Oahu's Pearl Harbor Naval Base and Hickam Air Force Base. Numerous benefits such as quality education, childcare, spiritual guidance, individual and family counseling, support for dependents of deployed military, and various charitable and outreach causes, locally, nationally and globally have been

provided during this timeframe specifically to address the particular needs of Holy Family's large and transient military population. All members of the community and public derive the long-term benefits traditionally associated with Catholic education in a strong moral and values-rich Christian environment.

As a successful school and church Holy Family has a strong reputation for attracting both the local and military populations of Oahu. It is a major element in the religious, social, and educational lives of Oahu's military community and compatible as a good neighbor for the surrounding local community. For nearly 60 years the organization has provided exceptional and vital services that directly impact the morale and welfare of the extended community within a supportive environment. As a quality educational institution, the facility also serves as a host site for an extensive number of extracurricular activities and services, including a comprehensive Before School Care Program and After School Care Program maintained for the convenience of families and students. Sports, robotics, tutoring, reading clubs, homework help, and craft classes are a select few of the offerings.

B. Facilities

Holy Family consists of multiple school buildings for its PK-8th Grade classrooms, and a large church and adjacent rectory that date back to 1956. The site serves nearly 600 students and 100 staff members. The Quonset hut that originally housed the church was replaced with the current sanctuary built in 1966 which accommodates approximately 1000 parishioners each week for religious services. In any given year, the school's population consists of nearly 50% military-affiliated dependents. The Academy maintains an operating budget of 3.6 million dollars. The Early Learning Center, with a budget of \$700,000, built in 1995 serves children ages 3-5 and consists of three large classrooms and separate office space. A large grassy playground area available for student use is equipped with developmentally-appropriate play equipment installed on a padded safety surface.

Additional structures include an aging cafeteria, band room, library, media resource center, supply room, faculty lounge, restrooms, offices and meeting rooms. Several classrooms are in portable temporary buildings surrounding a large blacktop courtyard. Parking is available both on and off campus.

Capacity-wise, the classroom space in the two main wings of the building is adequate to support present student enrollment, but the general condition of the main facility with its enclosed hallways and wood louvered windows is aging and the infrastructure outdated and in need of repair. The buildings are not energy efficient and administrative and data storage areas are minimal at best. The site lacks a large enclosed gathering/meeting space, other than the church to accommodate its community members. A multipurpose gymnasium and stage performance area would offer usable activity space for both the church and school.

V. PERSONNEL: PROJECT ORGANIZATION AND STAFFING

A. Proposed Staffing, Staff Qualifications, Supervision and Training

Qualified Consultants and licensed Contractors with strong track records and reputable histories and experience in working closely with churches and schools will be secured for the project. Oversight will be provided by a lay quality assurance leader and members of a Diocesan team with expertise and capabilities in the areas of education, finance, construction, fundraising, and land processes.

B. Licensure or Accreditation

The Academy and Early Learning Center are fully accredited by the Western Association for Schools and Colleges (WASC) and the Western Catholic Education Association (WCEA) for a six-year term expiring in 2019. The Before and After School Care Programs are licensed with a Certificate of Approval by the State of Hawaii (#013832) for a two-year period ending January 31, 2017. Holy Family Catholic Academy was recognized as a National Blue Ribbon School of Excellence by the U.S. Department of Education in 2000-2001.

The Academy's diversified comprehensive curriculum, its technological focus, and its support of 21st century initiatives enables students to be successful as global members of society and digital citizens. Experiences in Performing Arts through Hawaiian music and ukulele, band, glee, and art classes provide multiple learning experiences to foster a sound educational foundation and enable students to realize their individual learning potential. Students traditionally do well academically on national and local Diocesan scales for standardized testing, and are competitive in extracurricular endeavors, such as robotics (First Lego League), math (Math-a-thon), spelling (District & State Bees), geography (State Bee) and sports (volleyball, basketball and track).

C. Federal and County Grants

No federal and county grants have been previously awarded to the organization.

D. Private Educational Institutions

Holy Family Parish and Holy Family Catholic Academy and Early Learning Center operate under the auspices of the Bishop, Most Reverend Clarence (Larry) Silva, Diocese of Honolulu, as a sectarian educational institution and Roman Catholic Church.

E. Future Sustainability Plan

Holy Family Catholic Academy and Early Learning Center, and Holy Family Church have set aside monies in reserve for the foreseeable costs associated with the Master Planning Project and Land Entitlements for future sustainability. Essentially, the school and church have no outstanding debts beyond routine and current operating costs, and will continue to conduct annual fundraising efforts to accomplish the community's short and long-term goals consistent with a viable future. Accrued funds maintained as reserve are available and will be drawn upon to accomplish this purpose as needed for project completion. Fundraising efforts for major renovations and future new construction will be ongoing under Diocese guidance.




