A brief description of the applicant's background;

St. Francis Healthcare Foundation of Hawaii, incorporated in 1984 to coordinate all fund development efforts, is an entity of St. Francis Healthcare System of Hawaii. St. Francis Healthcare System (St. Francis) is sponsored by the Sisters of St. Francis of the Neumann Communities of Syracuse, New York. The Sisters' rich history began in Hawaii in 1883 with the arrival of Mother Marianne Cope and six Sisters from Syracuse, at the request of King David Kalakaua and Queen Kapiolani to care for those afflicted with Hansen's disease. The Sisters have been following the legacy of caring for Hawaii's people begun by Saint Marianne, who was canonized by the Vatican in October 2012. Since their arrival, they have initiated numerous programs and services in line with their mission of creating healthy communities in the Spirit of Christ's healing ministry.

The Sisters have administered several hospitals including Malulani Hospital (now Maui Memorial Medical Center) and Hilo Hospital (now Hilo Medical Center) and are most known for founding St. Francis Hospital in 1927 to care for the poor and needy. In addition, they have led the health care industry with the introduction of numerous health care services that include: home health services on Oahu and Kauai; renal dialysis throughout the islands; organ transplants; cancer rehabilitation; hospice care; a bone marrow donor registry; intergenerational adult day care; outpatient palliative care; and telehealth monitoring on Kauai and Oahu. The Sisters' continuum of care model achieves excellent health outcomes for those who entrust their care to them.

2. The goals and objectives related to the request;

To adequately provide for the nutritional needs and dietary restrictions of its skilled nursing and hospice patients, as well as seniors and families who access programs and services at the Liliha campus, St. Francis plans to renovate the existing 40-year-old commercial kitchen/dining area. The estimated \$3 million cost includes renovations and upgrades that will modernize the space, make it more energy efficient, and comply with all requirements to obtain certification through the Hawaii State Department of Health.

The public purpose and need to be served;

According to HMSA's Health Trends in Hawaii, 1 in 5 people will be 65 years or older by 2030, compared with 1 in 17 in 1970, representing an unparalleled shift in demographics. As the baby boomer generation reaches retirement age, the population of seniors aged 85 and over will rise rapidly between 2030 and 2050. According to the University of Hawaii-Manoa's Center on the Family in collaboration with the State Executive Office on Aging, the current life expectancy in Hawaii is 79.8 years.

While the state enjoys the greatest longevity in the nation, it has only half as many nursing home beds per capita compared to the national average. As the demand for skilled nursing facilities (SNF) rises to meet a growing elder population, the need will far exceed existing facilities on Oahu. To adequately address the health needs of Hawaii's growing and aging population, the number of available long-term care beds will need to be expanded.

Without an SNF, patients—the majority of whom are seniors—would have no other place to stay and recuperate other than acute care facilities. St. Francis Healthcare System is almost finished with constructing a new SNF at its Liliha campus that would enable these individuals to receive a more appropriate level of care in a homelike setting.

St. Francis must now upgrade its 40-year-old commercial kitchen/dining area to serve the nutritional needs of patients in the SNF, as well as the nutritional needs of its hospice patients so they may live out their last days with dignity and comfort. Proper nutrition, taking into account dietary restrictions, is widely recognized as an important source of health and healing, and an integral component of the recovery process. The dining room will also be used as a venue for educational training on healthy cooking and nutrition and other topics to benefit seniors and families who access programs and services at the Liliha campus.

Describe the target population to be served; and

The commercial kitchen/dining area will serve the nutritional needs of low- to moderate-income seniors, the majority of whom will be residents of the St. Francis Skilled Nursing Facility. The majority of these seniors are 62 years of age and older and need full-time medical attention or rehabilitative services before they can return home. The kitchen/dining area will also serve terminally ill patients who have been given a diagnosis of six months or less to live, as well as seniors and families who access programs and services at the Liliha campus.

3. Describe the geographic coverage.

The commercial kitchen and dining area will directly serve SNF patients, inpatient hospice patients, and seniors and families from all parts of Oahu who access programs and services at the Liliha campus.

Lauri Rasmussen

Vice President - Operations, St. Francis Healthcare System of Hawaii

Lauri Rasmussen, project manager, will oversee the renovations and certification of the commercial kitchen and dining area. She will work with the architect and a subcontracted kitchen consultant to ensure the commercial kitchen meets all certification requirements prior to obtaining certification through the Hawaii State Department of Health. Rasmussen most recently oversaw the construction of the SNF on the St. Francis Liliha campus.

Rasmussen's primary role at St. Francis Healthcare System is overseeing the operational functions that include information technology and communications, facilities and grounds maintenance, risk management, and safety.

Gregg Maedo & Associates

Since 1988, Gregg Maedo & Associates, an architectural firm, has successfully completed hundreds of projects every year, ranging from skilled nursing facilities, medical office buildings, sub-acute and dementia wing conversions, to healthcare campuses with child day care, adult day care, assisted living and skilled nursing facilities that provide a continuum of care for the residents.

If State GIA funds are awarded, the project will be ready to start and draw down funds to complete renovations and upgrades to the commercial kitchen and dining area within 12 months from the notice to proceed.

Key measures of effectiveness and major milestones will be built into the performance expectations included in the bid requirements for the subcontracted kitchen consultant. The project manager will oversee renovations and upgrades to ensure the project is completed on time and within budget, reporting progress to the President & Chief Executive Officer of St. Francis Healthcare System and President of St. Francis Healthcare Foundation. St. Francis Healthcare Foundation will work with Finance and Corporate Compliance to ensure all aspects of the State Grant-in-Aid contract are followed and funds are expended in a timely manner.

The Sisters of St. Francis and their staff have been caring for Hawaii's people since 1883. Since their arrival 131 years ago, the Sisters have remained committed to following the example of Christ's healing ministry and the teachings of St. Francis of Assisi, caring for the sick, the homeless and the abandoned, with kindness, respect, and concern.

St. Francis Healthcare System has and continues to be at the forefront of preparing to meet the needs of Hawaii's growing elder population. As part of an extensive 20-year strategic plan, St. Francis divested its two acute hospitals in January 2007, specifically to focus on home- and community-based care, a sector of the healthcare continuum that has emerged as the single most important area of growth to meet the needs of older adults.

The hospital assets at the East and West campuses were returned to St. Francis five years later after Hawaii Medical Center filed for bankruptcy twice and subsequently closed. With the sale of the West hospital campus to The Queen's Health Systems in December 2012, St. Francis Healthcare System has launched a new, exciting chapter at its East campus.

- St. Francis has been the recipient of federal funds for two projects. In 2013, St. Francis completed construction of an \$8 million, 15,000-square-foot, single level intergenerational center in Ewa Villages to address the need for services for both the elderly and preschool populations living in West Oahu. Opened in February 2013, the intergenerational center enables families in the sandwich generation to drop off their aging parents who need assistance during the day and their young children in one convenient location.
- St. Francis also has the experience of overseeing the management and operations of a vibrant, affordable senior independent living community. Franciscan Vistas Ewa, a 149-unit complex that is 100 percent leased, features amenities typically found only in luxury living centers. St. Francis is leveraging its experience from these two facilities in Ewa Villages to build on this success at the Liliha campus.

B. Facilities

The original 20,000-square-foot skilled nursing facility (SNF) at the Liliha campus was built nearly 40 years ago and was recently upgraded and renovated to meet American with Disabilities (ADA) standards and building codes for today's SNFs. Plans call for modernization of the 40-year-old kitchen for State and City certification compliance once the SNF is fully operational in spring 2015. The commercial kitchen is housed in another existing building on the St. Francis Liliha campus, with the dining area adjacent to the kitchen.

Sister William Marie Eleniki, OSF

St. Francis Healthcare Foundation of Hawaii

Since 2007, Sister William Marie Eleniki, OSF has served as President of St. Francis Healthcare Foundation, responsible for all fund raising efforts for St. Francis Healthcare System, its entities and programs and managing investments. As Board President of St. Francis Residential Care Community, she was directly involved in overseeing the development of the \$40 million Franciscan Vistas Ewa affordable senior living community and the St. Francis Intergenerational Center that was partially constructed with community development block grant (CDBG) and State grant-in-aid funds.

For 40 years, she was an educator at schools in New York and Hawaii. She served in Hawaii as a junior school teacher at St. Francis, vice principal at St. Joseph's in Hilo, and principal at Our Lady of Good Counsel and St. Michael's schools on Oahu. In addition, Sister William Marie was regional minister of the Sisters of St. Francis in Hawaii for seven years.

Born and raised in Honolulu, she received her Bachelor's degree from D'Youville College in Buffalo, New York, and Master's degrees in education with a minor in counseling from the University of Hawaii-Manoa and in private school administration from the University of San Francisco.

Lauri Rasmussen

Vice President - Operations, St. Francis Healthcare System of Hawaii

Lauri Rasmussen oversees asset management at St. Francis Healthcare System, overseeing construction of the Skilled Nursing Facility and Senior Community Center at the St. Francis Kupuna Village to ensure all projects are completed on time and to specifications. As VP-Operations, she is responsible for the administrative functions that include information technology and communications, facilities and grounds maintenance, risk management, and safety for the organization.

Rasmussen previously served as the Client Executive for Revenue Cycle Solutions, Dell Services (aka Perot Systems), and Director of Admissions and Quality Control, Information Services for both Hawaii Medical Center and St. Francis Healthcare System. Certified as a Coder (CCS), Rasmussen's experience is extensive in the health information, medical records, and coding aspects within hospitals in Hawaii and on the mainland.

A graduate of the University of Hawaii and Skyline Community College in California, she is presently completing her Business Administration Program through Ashworth College.

Kevin Nishida

Chief Financial Officer, St. Francis Healthcare System of Hawaii

Kevin Nishida has extensive experience in finance, accounting and auditing for large organizations in Hawaii and on the West Coast. Prior to joining St. Francis, Nishida had been with Sky River Management, LLC, a Honolulu company that provides aviation, security, property and financial management, and concierge services to high net worth individuals. He started with Sky River Management in September 2008 as controller and was promoted to vice president in May 2013.

From 2000 to 2008, Nishida had served as controller for Dowling Company, Inc., a Maui-based real estate development company that focuses on residential projects ranging from affordable housing to high-end luxury homes. In this role, he worked with lenders and partners to secure debt and equity financing for development projects and oversaw the financial transactions of acquisitions. His experience also includes serving as controller for the real estate division of Public Storage, Inc. in Glendale, California. While serving as supervising senior accountant for KPMG LLP in Honolulu, St. Francis Healthcare System was on one of his audit clients at the time.

Nishida graduated from Maui High School, received a bachelor of science degree in accounting from Purdue University and an MBA from W. Olin Graduate School of Business, Babson College in Babson Park, Massachusetts.


