I. Background and Summary

1. A brief description of the applicant's background;

I, Michele David, Board President, have been involved with Hawaii's Volcano Circus (HVC), housed in the building known as SPACE (the Seaview Performing Arts Center for Education), for over 3 years. I have served as both a volunteer and an employee. I am currently working towards a Masters Degree in Global Leadership and Sustainable Development at Hawaii Pacific University, with an expected graduation date of May 2016. I am also a single mother to a 15 year old son who is an active participant in the circus arts programs offered by HVC, which are held at SPACE.

Hawaii's Volcano Circus (HVC), incorporated in 1991 is a 501(c)3 non-profit organization founded to provide quality culture and arts enrichment programs in Hawaii. The flagship program of HVC, has been the Hawaii Island Community Circus Unity Project (HICCUP). The HICCUP Circus directly supports HVC's vision "to promote the healthy development of children and the community through the time honored skills of the circus." Since 2007, SPACE has served as the physical home of HVC and the HICCUP Circus. Our SPACE Performing Arts Center is equipped, with respect to our facility, equipment and instructors, in ways that is unmatched on Hawaii Island for circus arts training and performance. Currently, classes are offered to local and visiting youth each weekday afternoon focusing on various disciplines of circus and performing arts. We also organize and tour with our young performers to many festivals and events around the island. SPACE provides a safe, colorful and exciting environment where youth and adults alike can learn (amongst many other circus skills...) stilt walking, unicycling, juggling, magic, balloon twisting, tumbling, and aerial dance as well as basic performance arts skills such as theatre, dance, costuming and music. The HICCUP curriculum is also offered as an extracurricular activity for the 'Ohana School' of the Hawaii Academy of Arts and Sciences (HAAS), an elementary-age classroom housed weekdays at SPACE.

HVC provides educational, cultural and recreational benefits for a rural community that has the most social, economic and educational problems in all of Hawaii and has been recognized by many authorities as being in great need of positive input on all levels. Our activities have always

developed as a response to the expressed needs of our local community. Many times, our community has come to us requesting services, such as the HAAS school and the Farmers Market. Adult dance and aerial classes have also been suggested and have been very popular; SPACE is now the leading aerial dance training facility in Hawaii. In addition to meeting these community needs and desires, SPACE has provided disaster relief services. When Hurricane Iselle hit East Hawaii Island, just 17 months ago, SPACE served as both a community meeting place and distribution center. Soon after the hurricane recovery was underway, the lava started flowing towards Pahoa town, threatening much of lower Puna with geographical isolation. These disasters made SPACE an even more important community asset. HVC also models and promotes sustainability practices in accordance with the PCDP, the 2050 State Sustainability Plan, and the more recent goals of Hawaii Green Growth's Aloha+ Challenge.

2. The goals and objectives related to the request;

This grant would help HVC with the following 3 objectives:

★Expanding current circus arts-education programs to serve a greater number of children: Our current Executive Director is also the Circus Director and teaches most of the classes. We have been able to hire some previous students to assist and teach classes as well, but we need to hire additional staff to help the director with teaching classes and with administrative duties, specially if we are to extend the circus program and develop a teen program to serve more area youth.

Over the past year, we have been quite successful in acquiring new students by defining our after-school circus program as a Club, the Hiccup Circus Club. Every afternoon of the school week is a different circus theme: acrobatics, magic and balloon twisting, aerial dance, juggling, and performance troupe. The average number of kids in each weekday class is about 8 students. In addition to our circus classes, our seasoned performers troupe (8-10 students) have been hired or invited to perform around the island about 15 times this past year. Because we keep student fees low, our director's pay is low and his hours are long. We are asking for funding for the following:

- Our director needs assistance from two more qualified instructors and an office
 administrator. We hope that with additional funding for staff, we can extend our afterschool program to start earlier and end later. This will mean that the club will be more than
 just a circus class by including more free time for exploring circus skills, building stage
 sets, props and carnival games, and watching circus movies on a new projector.
- Funding for scholarships is also needed as many of our kids come from poor single parent families.
- We are also in need of funding to improve our materials and equipment to keep students safe and inspired, and funds for a new laptop computer
- We would also like a trailer to haul our circus equipment and to serve as a mobile stage for festival performances

We have been having both summer and winter day camps, and would now like to expand to
provide residential camp experiences, which will entail funding for 6 large tents and
sleeping cots

★Developing a teen program of classes, and a supervised circus-arts clubhouse for teens: Similar to our kids program, but more of a social club for teens, we hope to provide SPACE for an after-school clubhouse in conjunction with classes and outings. A local teen program unofficially began in January, 2015 when the program director created a 2-day workshop for teens on relationships, intimacy, and sexuality. She is a teacher at an elementary school, and many of the children that she has had as students in her Japanese class, math class, or even in the kindergarten class, are now teen-agers. The parents were very appreciative that she, someone who'd been in most of their children's lives for many years, was talking to their teen-agers about these important topics.

She stated that she loved what she saw happening with the kids that weekend as they were bonding with each other and learning about themselves, while having older-non-parental folks in the community to talk to them about deep subjects. It reminded her of experiences in her church youth group as a teen, something that was beneficial for all at that crucial age. In addition to just any teen-agers benefitting from this type of group, she especially felt like the kids in our community needed this. It's a rural area; and like so many rural areas, there's not much for teenagers to do. Also it's a place where marijuana is pretty available, she wanted to give the kids fun, wholesome activities that made them 'naturally high,' and helped them know that there's more to life than just getting stoned.

The teen program has had such a wonderful year, that in order to keep it on-going, it needs the oversight of HVC and the facilities of SPACE. So far, they have had lots of activities ranging from a pizza party where everyone brought an ingredient, to service work in a local forest. They went to Volcano National Park, and also did trail work in a nearby rainforest. An elder in our community performed a rites of passage ceremony for the kids out by the ocean, and then they walked along the coast to a night market and split into groups for dinner, followed by a yummy donation of vegan ice cream by local gelato makers, Niccoco. Their most recent trip was to the Imiloa Astronomy Center, then to a beautiful park for dinner and team-building games, and then to the Onizuka Visitors Center for star gazing. In addition to activities, the director tries to provide time for guided meditation.

★Re-opening the SPACE Farmers Market:

The farmers market was much needed and it was a great success story. It needs to be brought back! Approximately 18 months ago, the market was closed at SPACE and moved to a location over 5 miles away with hopes that people would drive to gather at the new location. However, this has not occurred. Ever since SPACE market closed the community it mainly served has suffered. Only a few vendors remain at the outer location, and the Seaview community inparticular has seen an increase in crime, prompting the creation of a fear-based neighborhood

watch group. This group is in dark contrast to the fun and informal gatherings at SPACE market, which kept residents engaged and abreast of what's going on in the community.

In addition to all of the health and economic benefits that SPACE market provided via local food exchanges, SPACE market also served as a business incubator, a meeting place with internet service, and a forum for networking. The Tin Shack Bakery in Pahoa began at SPACE market, as did Nicoco Hawaiian Gelato, which is now stocked at various restaurants and stores throughout Hawaii.

The market was also a model of sustainability: we had a zero-waste coordinator who helped us recycle and compost nearly all of the waste generated during the market. We also held a swap meet during the second Saturday market where people could recycle their used goods and wares. Having a market in the community also saves gas and time. The average trip to Pahoa town for groceries is 15 miles or 20 minutes each way. The local residents who can walk, bike, or drive a short distance to SPACE to shop at the farmers market will not need to go to town as often for groceries -this is better for our wallets, our cars, and our environment.

The market was nearly self-sustaining in that the vendor fees paid for the staff, but without pushing greater fees onto the vendors there was no money left to support the management of HVC or the infrastructure of SPACE. For much of the time since SPACE market opened in 2007, HVC gifted time, energy, and the SPACE building to the farmers market. The market was closed because the maintenance of SPACE and the HICCUP circus program needed greater attention. We hope that the State will provide funding to support the re-opening of SPACE market. In addition to funding for a part-time market manager, we also request funding for a new lap-top computer, and a golf cart for use by our parking staff.

3. The public purpose and need to be served;

There are very few services provided by government agencies or businesses in the (approximately) 15 mile area surrounding SPACE. Additionally, there is a lack of adequate transit to allow people to travel outside the community for services.

HVC's after-school circus arts program offers low-cost classes and performance opportunities for Puna's youth. The rigors of performance arts training require that one maintain a strong, healthy, substance-free body. SPACE offers safe, fun, and regularly scheduled classes to engage Puna's youth. There are few, if any, other activities for young people to attend in this area. SPACE provides a venue to keep kids off the streets.

SPACE also hosts an elementary school-age classroom for the Hawaii Academy of Arts and Science (HAAS) charter school. This classroom is an important resource because the nearest DOE school is in Pahoa which is 15 miles away. If kids need to ride the school bus, they must leave home at close to 6am and return around 4:30pm, for a school day that runs from approx. 8am – 2pm.

SPACE previously hosted a weekly Farmer's Market from 2007 to 2014, which with assistance from this grant will re-open this year. The market was a beloved and necessary community asset. With the lack of jobs available in this broadly rural area, resident vendors started their own handicrafts and food businesses to generate income for themselves. By bringing the abundance of food and artistic ingenuity in this rural area to a market-place, these vendors have helped to provide a livelihood for themselves and their families while increasing food security and the consumption of healthy, local foods in the area. With Pahoa town being at least a 15-mile drive away, SPACE is located in an area designated as a "food desert" by the USDA, making our weekly Farmer's Market a critical resource for area residents. It is also essential that our market accept EBT. In an area where 56.4% of the local population is on EBT, a large percentage of food purchased in the Puna area is bought with food stamps. The previous EBT program at SPACE Market increased the ability of EBT recipients to buy primarily locally-grown produce, thus improving sales and income of local farmers. It helps to decrease the need for imported produce and create a shift to a greater balance in food imports and exports in Lower Puna.

Opening the market back up again will afford us the opportunity to utilize our Mobile Commercial Kitchen. We expect that offerings at the Farmer's Market will improve by growers expanding into value-added products from ingredients that they are already producing. We also anticipate the kitchen to make a positive impact on the local economy as new small food businesses are formed and supported by being able to rent the facilities at a reasonable rate.

- 4. Describe the target population to be served; and
- Describe the geographic coverage.

Hawaii's Volcano Circus (HVC) serves the population of Puna Makai on the East side of Hawaii Island. The area is economically depressed, rural and geographically isolated. According to the 2010 U.S. Census, the current population of the Lower Puna area (Pahoa-Kalapana Census district) is less than 8,000, and approximately half of these people live in the 3 subdivisions located within walking or biking distance to SPACE. The population of the entire Puna district was reported at 45,326, an increase of roughly 13,991 people (over 40%) since 2000. The State Department of Health has ranked Puna number one among Hawaii Island's districts for numbers of families at 'socioeconomic risk' with 29.4% of the Lower Puna population being below poverty level. The median household income for Pahoa-Kalapana District was reported at \$34,750, roughly \$20,000 below county levels; and per capita income was \$17,929, \$10,000 below county levels (U.S. Census, 2010). Unemployment for the county of Hawaii was reported in July 2013 at 7.5% (Hawaii Dept. of Labor and Industrial Relations), 2.9% higher than unemployment for the state average of 4.6%. Nearly fifty percent of the district population as a whole is below 200% of federal poverty level, and 56.4 percent of Puna District residents receive food stamps. In June 2013, the Hawaii Tribune Herald reported that the nearest DOE public school, Pahoa High and Intermediate, led the Big Island in the number of cases of serious misconduct committed by students over the last 5 years.

II. Service Summary and Outcomes

Describe the scope of work, tasks and responsibilities;

For the children's circus and teen programs, the expected outcomes are to double the number of youth participating in the after-school HICCUP circus clubs (for children and teens). We also expect the residential camp program to succeed as there is already interest from other circus troupes to come to Hawaii to train and perform. The teen program has already been successful off-site over the past year. With a home at SPACE (the teen club) will provide a venue similar to that of the highly successful Boys and Girls clubs of America. The current director of the teen program is a instructors assistant for the 'Ohana school' classroom at SPACE for the Hawaii Academy of Arts and Sciences (HAAS). Her assistant is also a HAAS instructor at the main campus in Pahoa. With such dedicated and qualified personnel involved, including the Executive and Circus Director who has been working for HVC for over 5 years, the expansion of the youth programs at SPACE are bound to be successful.

For the farmers market, the outcomes are expected to be similar to the farmers market held at SPACE for over 7 years (2007-14). The weekly artists/farmers market attracted and average of 50 vendors and over 300 patrons every Saturday morning. To re-open the market will entail greater time spent by a market manager for the first few months, but after 6 months of the market running smoothly, the vendor fees, parking fees, and other on-site fundraising events will be able to cover the market manager's ongoing part-time salary along with other staffing expenses. Grants and donations will continually be sought for the 'wear and tear' impacts to the SPACE building, parking lots, and associated infrastructure. We believe that these expenses are worth the plethora of positive impacts that the market will have on the community. The mission of this market is to promote sustainability and be a vital part of the local economy by providing a safe, village-based marketplace for the community to buy and sell goods and services produced on the Big Island.

All three of the services we seek to provide can begin as soon as funding is secured.

The youth programs (teen and children's circus) are already established, and will be expanded as soon as additional staff is hired.

Month 1: hire and train 3 new part-time staff members (2 instructors and 1 administrative assistant), create plans, and advertise our expanded programs to families in Puna

Month 2-3: design and outfit rooms to befit both the children's and teen's clubs Month 4-6: build the residential camp tent site

Month 7-8: re-evaluate programs for effectiveness and make changes as needed Month 9-12: continue to refine programs and expand outreach to make sure that all the youth we can serve, are being served

The farmers market can be re-opened within 3 months of securing 6 months of funding for a part-time market manager:

Month 1: design the market layout based on the previous vendor placement map, apply for EBT (food stamps) acceptance machine, hire 5 market staff persons: 1 parking attendant/security, 2 EBT cashiers/cleaning crew, 1 zero-waste coordinator, 1 assistant manager

Month 2-3: plan for a grand re-opening celebration with entertainment by the HICCUP circus troupe

Month 3-4: open the market as planned, open the second Saturday swap-meet in conjunction with the market

Month 4-6: re-evaluate for effectiveness and make changes as needed, survey staff and vendors for suggestions

Month 6-9: conduct a satisfaction survey

Month 9-12: continue to refine the market systems so that vendors, consumers, and staff are highly satisfied

In order to bring the community what it most needs, HVC evaluates data from local surveys -including both surveys that we conduct and those conducted by community groups with whom we collaborate. The KAPONO (Kalapana to Kapoho) Red Road neighborhoods organization created and administered an extensive community survey in 2012 (results at www.kapono.org). One of the main purposes of the survey was to determine the services our community would like to see offered in our area. More recently in December of 2015, KAPONO

published another survey in relation to the Corridor Management Plan for the newest State Scenic Byway, Highway 137 (The Red Road), which is the coastal road for the communities that SPACE serves. HVC has used the survey information along with the Puna Community Development Plan, and the State Sustainability Plan to guide our own planning. The first KAPONO survey showed that the number one community desire is for a local farmers market, and the next survey showed that most people care about the implementation of sustainability practices as Steward of Red Road. Finally, we use feedback received from people attending activities at SPACE, suggestions from members of our SPACE advisory board, and the general planning suggestions from the Hawaii County - Puna Community Development Plan (PCDP), which states that,

"within Puna, the vision is to reshape the development pattern by moving away from the sprawl effects of the existing subdivisions and toward the formation of village and town centers. Over the long term, this will improve the feasibility of developing supporting infrastructure for populated areas, give residents better access to public and commercial services, stimulate local employment opportunities, and reduce dependence on the automobile for transportation."

The PCDP approach supports the mission of HVC to "promote sustainable local community in Puna Makai". Additionally, one of the stated goals of the Puna Community Development Plan is "facilitating the development of farmers markets and community gathering places" for which SPACE and HVC are ideally suited. SPACE informally serves as the neighborhood village center for the most populous area of the lower Puna Red Road community, which is made up of 3 subdivisions: Kalapana Seaview Estates, Puna Beach Pallisades, and Kehena Beach Estates.

Technically, all programs will be tracked using a computer spreadsheet software programs, quickbooks and google sheets. We already have an accountant/bookkeeper to employ to assist us.

This is the largest grant we have attempted to receive for our operations thus far. We plan to continue to write grants for funds not provided, and for smaller grants to fund special programs, and for needs such as costumes, circus equipment, building maintenance, and fun outings or events for our youth programs. We will also seek funding to send our circus troupe to train or perform on other islands or on the mainland. Last year, 4 low-income teen boys and the circus director formed a troupe called the Junkyard Jugglers, so named because they up-cycle plastic bottles and other trash into juggling clubs and props. They were funded by Recycle Hawaii to do 12 shows. And, with funding from the Storybrook theater, they did a show on the island of Kauai. They also raised enough money from performing at local farmers markets to attend the International Juggling Festival for a week in Indiana.

Our Executive/Circus Director, Tristan Graham, was trained under the founder of the HICCUP Circus and was his main assistant for over 5 years. Since the founder's resignation over a year ago, Tristan has maintained quality circus arts programs, has shown business savvy by maintaining a steady income stream nearly equal to the expenses, and he has developed good community relations. He is also the maintenance technician for the SPACE building. We are fortunate to have such a dedicated director who knows not only how to perform, teach, and keep financial records, but also knows the structural needs of the building, our technical equipment, and our van, and he can "fix" most anything. He has a BA in Biology and over 15 years of teaching experience. Tristan is also a member of the American Youth Circus Organization (AYCO).

While HVC programs are limited to afternoon classes and some outside performances at venues such as the Palace Theater, the Kohala Aina Festival, and the Lilikoi Festival, Tristan has proved more than able to handle these activities. He also supervises the evening adult classes, taught by local experts who have been teaching these movement/dance, including aerial dance, at SPACE for over 5 years.

The current board of directors is made up of seven community members, three are long time circus arts actors who have regularly performed and taught at SPACE, two are educated and enthusiastic parents of circus kids, and two are website and technical support guru's with a love for circus and our community.

Our 6,000 sq ft SPACE Performing Arts Center is equipped, with respect to our facility, equipment and instructors, in ways that are unmatched on Hawaii Island for circus arts training and performance. SPACE is also the leading aerial dance training facility in Hawaii. While the facility is in need of repair, it functions well for the current activities we offer. The building was designed to be environmentally sustainable. Its features include: a 10kw solar system, rainwater catchment, solar water heating, natural airflow ventilation, and maximum natural light. We have an extensive recycling program. The majority of the waste from the charter school and HICCUP circus classes is recycled, in fact, much of it never leaves our land. When the farmers market was open, we had a zero-waste coordinator who reduced our weekly landfill contributions from 6 large bags to less than one half a bag. We compost all of the food waste and all of the paper products. The remainder of eligible items are recycled through County programs and local recycling businesses. SPACE seeks to be a model of sustainability and will continue to use green

building practices in its improvements. HVC is currently in the process of applying for a Hawaii Green Business Program Award.

V. Personnel: Project Organization and Staffing

A. Proposed Staffing, Staff Qualifications, Supervision and Training

For the HICCUP circus and teen program: with secured funding for salaries for one year, we plan to hire 2 instructors: 1 program manager for the teen program, and 1 instructor for both the teens and kids classes. The instructors we plan to hire are both qualified teachers who currently work for the Hawaii State Department of Education at the HAAS charter schools. The administrative assistant should have basic office experience for 1+ years.

We also plan to increase the salary of our Executive and Circus Director from a mere \$750/month to \$1250/month. Our director is serving from the heart as his salary barely reaches the State mandated minimum wage for all the hours he works to maintain the quality of circus arts programs he currently manages. He served as the assistant director and maintenance technician for SPACE for nearly 5 years before stepping up over 1 year ago to become to our sole paid staff member, which was prompted by the previous director resigning and moving to the other side of the island. We are thrilled to have such a dedicated and competent director, and we look forward to being able to increase his salary and hire additional staff under his direction.

For the Farmers Market, the qualifications of the market manager will include the following minimums:

BA degree or higher

3+ years of management experience

1+ years of non-profit experience

1+ years of food industry/handling experience

and 1+ years of cash handling experience

The entry level staff positions for which the market manager will supervise, can be filled by anyone over the age of 16 and whom have their parent's authorization for employment. The parking lot attendant and driver must be over the age of 24 due to the need to transport people in our van or golf-cart.

B. Organization Chart

Even though there will be a management hierarchy, we plan to work together towards our common goals. The Executive/Circus Director will supervise the 2 instructors and administrative assistant and will work in tandem with the Farmers Market Manager whom will supervise 5 entry level staff on market days.

C. Compensation

The applicant shall provide the annual salaries paid by the applicant to the three highest paid officers, directors, or employees of the organization by position..

Executive Director / Circus Director: \$15,000 exempt salary, plus additional compensation for off-site tours and residential camp stays with a limit equal to his standard salary of \$15,000/year.

2 Circus/Teen program instructors: each will be paid \$15/hr for 15hrs/week, totaling \$11,700/year each (\$23,400 for both persons)

1 administrative assistant: \$10/hr for 20 hrs/week, totaling \$10,400/year

Farmers Market Manager: for the first year the salary will be higher because for the first 6 months to re-open the market, the rate will be \$15/hr for 25/hrs/week. After 6 months, the hours will decrease to 20/hrs/week, totaling \$17,550 for the first year. In the second year the hourly rate will increase to \$16hr for 20 hrs/week, totaling \$16,640/year.

5 market staff: \$10/hr for 8 hrs/week, totaling \$4160/year each (\$20,800 for 5 persons)

Total staff salaries for the first year of our expand programs and re-opened farmers market will be \$87,150.

It is because we wish to expand our current after-school circus arts program, develop a new program for teens, and re-open our farmers market, that we need grant funding. Because we are located in a socio-economically depressed area, it is important to keep our fees as low as possible while striving to maintain quality programs and a livable wage for our employees. We may always seek grants for improvements, special projects, and scholarships, but once the programs are up and running, they will be sustainable for the foreseeable future.

For example here is an outline for the income and expenses for the farmers market, which will be sustainable after we are able to maintain an average of 50 vendors each week. We averaged this number of vendors for 3 years prior to the market closure in July 2014.
