Hui Malama o Kanetolouma is a 501 (e) (3) non-profit organization that was incorporated in Hawaii 4/1/2069 and received our LR.S. determination 4/28/2010. On 7/23/2010, we signed a 10 year stewardship agreement with the County of Kauai for the Kaneiolouma Heiau complex located at the Poipu Beach Mauka Preserve. The Po o (President) of our organization, Rupert Rowe, along with other volunteers have been performing volunteer vegetation clearing and maintenance of the heiau complex since 1998.

The goals and objectives related to the request;

The goal is to install an irrigation system to water the grassed areas outside of the perimeter security wall around the heiau complex.

The objective is to reduce dust and provide an attractive walking and viewing area for the general public outside of the perimeter security wall and along the public roadway.

The public purpose and need to be served;

The public purpose is to improve a public right-of-way, help prevent soil erosion during periods of heavy rain and provide an attractive entrance into the Poipu Beach Park.

The side of the roadway outside of the perimeter security wall is subject to a lack of water during normal months and susceptible to erosion during periods of heavy rain.

Describe the target population to be served; and

Describe the geographic coverage.

The target population is the general public, both residents and visitors. The geographic coverage is primarily the Koloa/Poipu area, however, the Poipu Beach Park is heavily visited by many visitors and residents from all over the island.

We are currently working on completing a grant of \$350,000.00 from the County of Kauai for additional work on the security wall and viewing platform areas. The visible accomplishments at the beiau attest to our skill and experience to complete a project.

Although there are no permanent facility structures, the heiau itself is the facility. All activities at the heiau currently take place in the open and the installation of the irrigation system would be outdoors.
