Kauai Economic Opportunity, Incorporated (KEO) is a private non-profit agency, incorporated on March 16, 1965. The agency began as a local community action program created after the passage of the 1964 Economic Opportunity Act by the U.S. Congress. KEO is committed to promoting grassroots participation to create social and economic self-sufficiency among low-income families through an array of proven programs and services. The agency serves as a catalyst in encouraging effective local advocacy among the poor, enabling public officials and the general community to understand their needs and issues, and to mobilize resources to impact on poverty.

KEO is a multi-purpose organization with funding from a variety of sources. Over the past 50 years, the agency has fiscally administered millions of dollars of Federal, State, County, and private funds. The agency is the only human services organization on Kauai, whose purpose is to provide a wide range of services and activities that alleviate the conditions of poverty and allow low-income families and individuals to attain social and economic self-sufficiency.

As a private, non-profit agency, KEO has been able to operate with a reduced overhead and has been able to accomplish tasks that are difficult for government agencies. KEO has been creative in utilizing its resources, is cost conscious and maintains a high level of accountability of funds (stringent reporting requirements, contracts outside audits annually, and is periodically audited by the State of Hawaii).

2. The goals and objectives related to the request;

The main goal of the Early Learning Center is to help pre-school age children make a smooth transition from home to school. In addition, it provides childcare so families can obtain or maintain employment.

The main goal of this request is to acquire the **land** where the Lihue Early Learning Center building is located. KEO acquired the building in May 2001 and KEO currently leases the land thru Nalu Aio, LLC. The monthly lease has been constantly going up every year. KEO would like to maintain the affordability of its preschool services by lowering expenditures and one of the major expenditures of the center right now is for the land lease, a \$3,137 per month when calculates to \$37,644 annually.

We are currently a very affordable childcare program on the Island of Kaua'i. With the proposed acquisition of the Lihue Early Learning Center (LELC) land, we are hoping to ensure the affordability that we are currently able to provide in a secure environment for the children and families in our community that attend our childcare program. With the purchase of this parcel, we could also save that money and to enhance the program for the children and for parental activities, replace old furniture, replace and remodel our kitchen and bathroom to better serve our children.

3. The public purpose and need to be served;

Parents need to work to become self-sufficient and need reliable childcare to satisfy that need.

4. Describe the target population to be served; and

The target population includes working families who need affordable and dependable childcare.

5. Describe the geographic coverage.

The geographic coverage includes the entire County of Kaua'i.

KEO is applying to the State of Hawaii for funding in the amount of \$842,400 to be able to acquire the land where the LELC is built and will be able to reduce expenditures and maintain the affordability that we are currently providing to the parents of the children enrolled at our pre-schools. The purchase will be made via a bonafide escrow company to assure legal and quality conveyance. Evaluation will be the legal title transfer of fee ownership from Nalu Aio, LLC to Kaua'i Economic Opportunity, Inc in fee simple ownership.

IV. Experience and Capability

A. Necessary Skills and Experience

As an agency, KEO has administered a variety of community service programs such as: Emergency Food Pantry, elderly Nutrition Congregate Program, Food Services, Emergency Food and Shelter Program, Transitional Housing, Housing Placement Program, Child Care, Alcohol and Drug Abuse Prevention After School Program, Employment Core Service for Immigrants and for Low-Income, Persons-In-Need Grants, Mediation Program, Group Homes for the Physically Challenged Adults, LIHEAP, WAP and other programs.

For over 51 years Kaua'i Economic Opportunity, Inc has been in operation in most of those years and has successfully provided daily, quality childcare year round for children ages 2 years and 9 months to 8 years old, for low income and working families. There are currently 48 enrolled at our Lihue Early Learning Center (LELC). We provide children the opportunity for social, physical, emotional and cognitive development, individually and in a group. All activities are planned by the center staff. A staff ratio of 1-12 (1 Staff to supervise 12 children) is maintained at our center. (Per State of Hawaii Licensing). We provide childcare Monday through Friday from 7:00 a.m. to 5:00 p.m. for a low monthly fee of \$575. The Lihue Early Learning Center offers healthy meals to all enrolled children as part of our participation in the U.S. Department of Agriculture's (USDA) Child and Adult Care Food Program (CACFP). Each child is provided an a.m. and p.m. snacks at no cost and may purchase a lunch. Children from households with income less than or equal to the reduced price Income Eligibility Guidelines are eligible for free or reduced price lunches.

The Head Teacher/Director has the skills, abilities and knowledge to direct and deliver the requested services. She has 26 years working in a preschool setting. There is one (1) Teacher who works under the supervision of the Head Teacher/Director in assisting in managing the classroom operation for the Child Care Program. Two (2) Teacher's Aide also work under the supervision of the Head Teacher in implementing a developmentally appropriate program that includes daily activities in education, such as language arts, music, art, science, manipulative exercises and outdoor play.

B. Facilities

Kaua'i Economic Opportunity, Inc Administration Office is located at 2804 Wee Road, Lihue, and Kaua'i HI 96766. Located in the office is the central intake where the preliminary process is done for all KEO service program applicants. Lihue is the main town on Kaua'i and it is the central location for other special resources to meet the needs of the community. The building meets Americans with Disabilities Act (ADA) requirements. The office hours are 7:45 a.m. To 4:30 p.m. Monday to Friday except when closed in observance of State and Federal Holidays.

KEO operates the KEO Lihue Early Learning Center (LELC) located at 4360 Payee Street. The LELC was built in 1993 and the building was purchase by KEO back in May 2001. The center is wheelchair accessible and meets ADA requirements.

The Lihue Early Learning Center is the center of which KEO owns the building and leases the land.

V. Personnel: Project Organization and Staffing

A. Proposed Staffing, Staff Qualifications, Supervision and Training

At the LELC there is one (1) Head Teacher/Director; one (1) Teacher; and two (2) Teacher's Aide.

The Head Teacher/Director possesses an AS degree in Early Childhood, Assistant Teacher possesses a CDA Certificate. The Teacher possesses a BA in Education, one Teachers Aide is in the process of attaining her CDA certificate and one newly hired Teachers Aide is attending PATCH classes. All are certified as per DHS-State of Hawaii License requirements.

At the LELC, the Head Teacher/Director has over 25 years of teaching experience; the additional staff has a combined experience of over 12 years.

The Early Learning Center is approved by Hawaii Child Nutrition Program to serve USDA, Required Daily Allowance meals. The staff attends USDA trainings to comply with the Hawaii Child Nutrition Programs guidelines. In addition, staff members are certified in CPR and First Aid.

The Chief Executive Officer (CEO) is responsible for the administration of the over-all legal, financial and program operations of the agency. The Fiscal Officer, Administrative Officer, Head Teacher/Director and most of the Program Directors report directly to the CEO.

The Fiscal Officer is responsible for the administration of all financial operations of the agency, providing the fiscal support for all KEO programs and the supervision of the fiscal staff. All financial transactions are approved by the Fiscal officer and the CEO.

The Administrative Officer supervises the human resources operation of the agency and along with the administrative staff, provides administrative support to KEO programs.

Plan for essential staff training for proper program management will include KEO's monthly evaluation, planning, and in-service training. In addition, the staff will attend training for job-related subjects such Hawaii Association for the Education of Young Children (HAEYC) - Kaua'i Chapter

Conference and Hawaii Nutrition Program yearly updates.

In this particular project, the administration staff is familiar in acquisition of property, as well as construction and they are very well qualified to execute the conveyance/transaction as such. If needed, the agency also has accessibility to legal counsel.

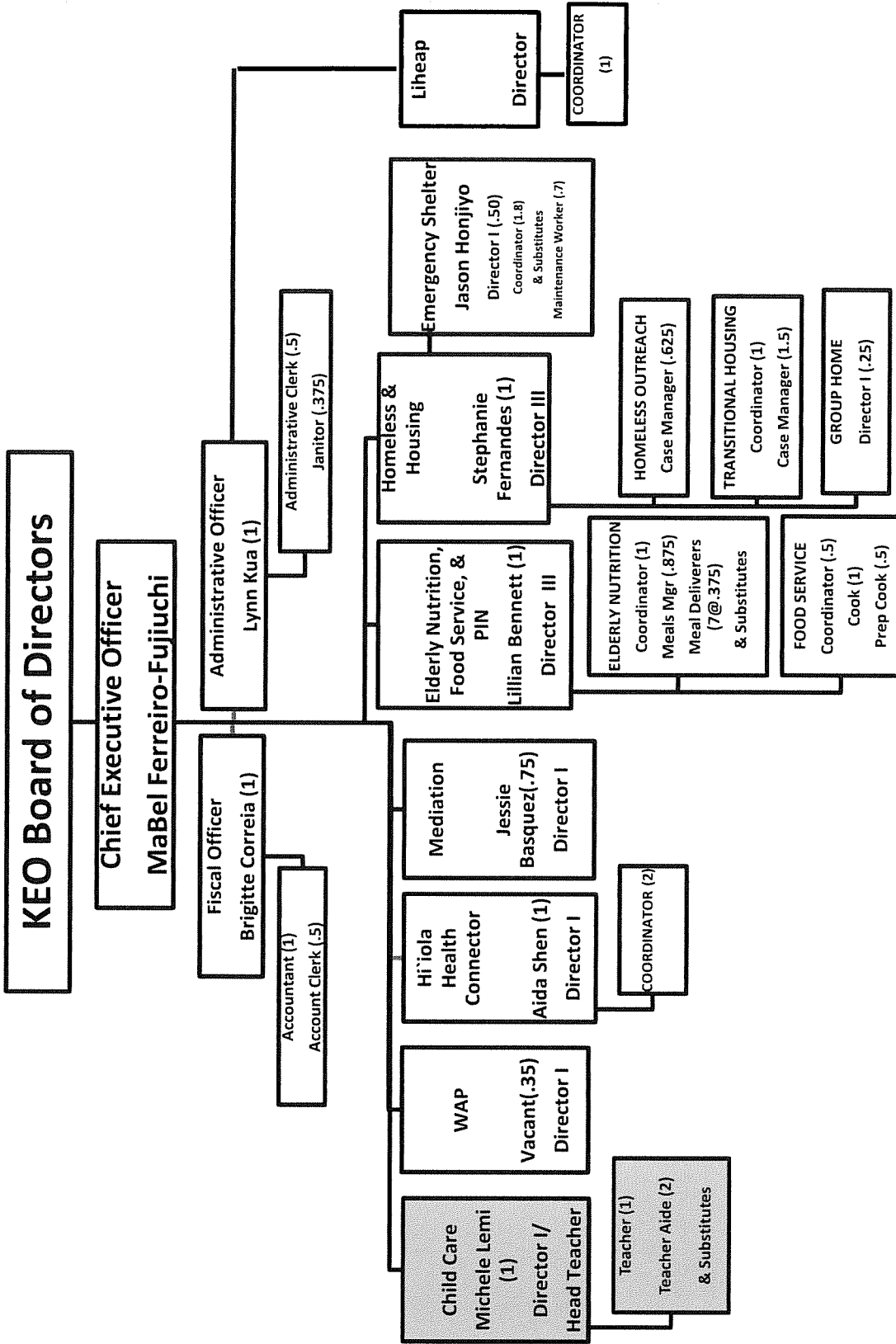

Dear MaBel :

August 19, 2015

Mr. Kurisu, Member of Nalu Aio, LLC (the Seller) has given me a listing agreement to represent him and his company in the sale of the fee interest in real property located in the Kukui Grove area of Lihue. The list of properties includes your pre-school property located at 4360 Pahee St. This letter is to ask if your organization would have an interest in purchasing the entire fee interest in the improved real property located at this address.

The purchase price offered is the appraisal value ordered by American Savings Bank utilized to provide the basis for the purchase price between the former fee interest owner and the Seller plus a margin of 8.0%. As with virtually all bank ordered commercial real estate appraisals, the Seller had no control over the choice of the commercial appraisal company. In this case, the Appraisal firm chosen by the Bank to perform the appraisal was Colliers. As you might know, this is one of Hawaii's very largest commercial appraisal firms, with years of experience in determining fee interest values on properties where the improvements are owned by the lessee. The Appraiser who signed off on the appraisal was Robert Hastings, who has a MAI appraisal designation and approximately 20+ years of commercial appraisal experience. The appraisal is dated May 1, 2014

The fee interest price offered to your AOAO is \$842,400. This figure is the sum of the appraisal value of \$780,000 plus the 8.0% margin of \$62,400, totaling the offering price of \$842,400. Should you choose to enter escrow to purchase your organization's fee interest, a copy of that portion of the "master" appraisal related to your property will be provided to you. Please note that there is a strong likelihood that since the master appraisal was done more than a year ago, the fee interest value has probably increased as the maturity date of the individual leases comes closer and given the strong increase in commercial values in Lihue in the past year. For this reason, this fee interest purchase option is available only now and in the very near future. 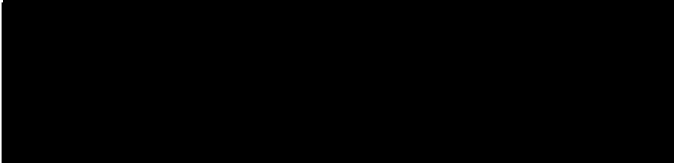


