## I. Background and Summary

### 1. Applicant Background

This proposal establishes a public, private partnership for the SHADE Institute Community Design Workshop (CDW). The CDW will provide community design assistance to state and county agencies to help improve Hawaii's built environment.

SHADE is seeking funding to conduct the SHADE Institute Community Design Workshop (SHADE CDW) similar to the successful 2015 SHADE Summer Institute, which provided pro-bono intern and professional training in community-based urban design in Honolulu's Chinatown. SHADE is the acronym for "Sustainable Humanitarian Architecture and Design for the Earth." SHADE envisions the SHADE Institute Community Design Workshops as a vehicle for augmenting the work of public agencies in improving the quality of the public realm, quality of life, and sustainability and resilience of Hawaii's communities.

The SHADE Institute is the public interest design practice component of SHADE Group LLC, a registered business in the State of Hawaii. Dean Sakamoto, FAIA, LEED AP, is SHADE Institute's director and the principal investigator of this grant application. He is a Hawaii-born practicing architect, university educator, and community organizer, and has practiced architecture and urban design professionally since 1986 in Europe, North America, and Hawaii.

The 2015 SHADE Summer Institute's Chinatown Urban Acupuncture Project developed a Vision Map and project recommendations to help prepare this district for rail transit. SHADE Interns and Mentors worked in direct collaboration with members of the Chinatown Community, AIA Honolulu's Regional and Urban Design Committee and the City and County of Honolulu Department of Planning and Permitting's TOD Planning Team. Intern stipends were funded by the City and County of Honolulu City Council and project expenses were funded by a private donor. The Hawaii Heritage Center provided in-kind sponsorship through use of its Chinatown space for events. HonBlue provided a limited amount of printing at no charge. SHADE Group provided instructional and work space at no charge. Dean Sakamoto provided his time and effort pro-bono. For more information on the Chinatown Project, see attached Vision Map and Summary.

#### 2. Goals and Objectives

As an economy dependent on tourism and a society which stands by the Spirit of Aloha, the quality of our cities and towns — mainly our streets, parks, public spaces and buildings — need sustainable and humanitarian design. This grant application offers an alternative approach to community design and professional training with the public's interest as its priority.

Public interest design is a proactive service-based method of delivering environmental planning and design services to underserved sectors of society. It addresses issues and places of need where conventional planning and design practice cannot or do not. The SHADE CDW brings together interns and professional mentors in the environmental planning and design fields to do pro-bono/at cost projects for communities and non-profit organizations in the State of Hawaii

#### Mission:

Provide statewide assistance to State and county agencies through finer grain planning and community design in areas impacted by State land and infrastructure development, particularly related to public transportation-oriented development and transitional and affordable housing needs.

#### Goals:

- a. Enhance the service capacity of the State and county planning agencies by providing community-based design support and sustainable design services.
- b. Conduct community design engagement for communities with an emphasis on creating more sustainable, humane, and livable communities in conjunction with State and County agency planning efforts. This process will include training/ professional development, public outreach/facilitation and visualization of planning and design concepts.
- Assist in the development of a physical design strategy to reduce the State's homeless problem, which is most evident in its public spaces, streets and parks.

#### **Objectives:**

- a. Initiate community design services for a minimum of two communities through the Summer Institute's community design projects and continue to work with these communities throughout the year to develop a community-based implementation strategies.
- b. Train 20 interns and provide continuing education for 20-40 professionals in the physical planning and design fields through the Summer Institute and throughout the year. Interns will earn a SHADE Institute certificate. Professionals who are AIA and APA members can earn continuing education units.
- c. Work with community leaders and stakeholders through outreach and facilitation to create community-based action plans, design concept plans and proof-of-concept demonstration projects (i.e. realized Chinatown demonstration projects).
- d. Increase awareness and public knowledge of sustainable and humanitarian urban planning and environmental design.

FY 2016-17 (July 1, 2016 – June 30, 2017)

### 3. Public Purpose and Need

Community-based urban design fills the gap between urban planning and building design. It requires participation from community stakeholders, government officials and consultants related to a project vicinity. The following needs are served:

- Engagement of communities in the process of shaping their own communities and neighborhoods.
- Greater attention and use of community design that increases sustainability, resilience and serves the needs of communities impacted by State and county projects.
- c. Intern training and professional development directed toward community-specific urban planning and design projects.

#### 4. Target Population

Three target populations will be served by these projects: 1) communities, their residents, businesses, and institutions - by enabling them to participate in community design in coordination with State or county agencies; 2) university students and interns who need hands-on training in land development, planning, and design practices; and 3) practicing professionals in related fields who will obtain continuing education units and participate in community service. In Fiscal Year 2016-2017, SHADE intends to work with the City and County of Honolulu, Kauai County, and their targeted communities in conjunction with numerous professional organizations. For more specific information on projects, see Scope of Work below. Professional organizations who have agreed to work with SHADE include the American Planners Association Hawaii (APA), American Institute of Architects Honolulu Chapter (AIA), American Society of Landscape Architects Hawaii (ASLA), and the Urban Land Institute Hawaii Chapter (ULI). With the University of Hawaii at Manoa Department of Urban and Regional Planning (DURP), the SHADE Institute CDW will deliver disaster and resilience training programs to its target populations through DURP's National Disaster Preparedness Training Center (NDPTC).

## 5. Geographic coverage

The geographic coverage is statewide on a prioritized-need basis as determined by the collaborating State and County agencies.

## II. Service Summary and Outcomes

#### 1. Scope of Work, Tasks and Responsibilities

### a. Scope of Work

Plan, organize, and implement SHADE Institute summer program and follow through with intern/professional training and community project implementation.

The 2016 SHADE Summer Institute is planning to initiate work with Honolulu's Department of Planning and Permitting on the Waipahu Transit Oriented Development (TOD) district on Oahu and the Lihue Town Core Revitalization project on Kauai. Chinatown demonstration projects developed during the 2015 Summer

Institute will also be worked on until they are realized. The 2017 Summer Institute work plan will be developed during the evaluation period of the 2016 Summer Institute (September 2016).

#### b. Tasks

- Plan and coordinate with State Office of Planning, in conjunction with County agencies and program partners as necessary.
- Meet with potential community partners (beneficiaries of the service).
- Recruit/interview/hire staff which includes a Program Manager and Instructors.
- Invite/schedule guest speakers for series of lunch time talks.
- Solicit interest from potential intern applicants; review applications/notify acceptance or non-acceptance of applicants.
- Develop a training curriculum for interns and professional mentors.
- Create and schedule courses and events that are specific to the community project.
- Conduct multiple weekly meetings with interns and mentors during the project implementation period.
- Seek and establish partnerships with community organizations and individuals.
- Register continuing education units with appropriate organizations.
- Monitor progress and follow-up with collaborating State and Local agencies.

## c. Responsibilities

The State Office of Planning will provide guidance to the SHADE Institute. The Director of the SHADE Institute will coordinate with State agencies and county government leadership. The Director will lead and oversee the Institute's activities and staff. The SHADE Institute staff is outlined in the organizational charts, their descriptions are outlined below.

The Fiscal Administrator will manage accounts received and payables and implement other business-related tasks. The Policy Advisor will research regulatory issues related to projects. The Program Manager will handle specific community projects and be the liaison between the stakeholders and project team (Mentors and Interns). SMEs (Subject Matter Experts) will advise the project team and give at least one lunchtime or seminar talk. Instructors will implement training workshops for the project team. Mentors will be practicing professionals who will volunteer their time for continuing education units (APA and AIA) and advise interns throughout the project. Interns will be recruited from professional university programs and firms nation-wide. They will participate in training, engage with community stakeholders and conduct research and project design work under the supervision of the Program Manager and Mentors.

## IV. Experience and Capability

### A. Necessary Skills and Experience

Dean Sakamoto has extensive experience in community based urban design and workshop delivery. In 2015, he initiated and directed the first SHADE Summer Institute, the Chinatown Urban Acupuncture project which worked with community members to create a Vision Map and project recommendations which supplemented and complimented the City's TOD Neighborhood Plan.

He is the author and urban designer of the Chapel West Special Services District, Vision and Strategic Plan (2004-2005) and the architect of the Farmington Canal Greenway Phase IV, multi-use recreational trail and interpretive design (2009-present) both in New Haven, Conn. Since 2011, he has delivered community-based urban resilience workshops in the States of Hawaii, Florida, Mississippi, Alabama, Georgia, Illinois, New York, Massachusetts and Connecticut for the University of Hawaii at Manoa, Department of Urban and Regional Planning's National Disaster Preparedness Training Center (DURP-NDPTC) under contract with the Pacific International Center of High Technology and Research (PICHTR). Mr. Sakamoto is a faculty affiliate at UHM DURP.

Mr. Sakamoto is also the editor and author of the internationally acclaimed book and exhibition, *Hawaiian Modern: The Architecture of Vladimir Ossipoff* (2007, Honolulu Museum of Art and Yale University Press). He served on the faculties of Yale University, Pratt Institute, University of Hawaii at Manoa, and Chaminade University of Honolulu. As a community organizer, he has initiated, organized and implemented numerous community-based planning, design and arts projects in the Northeast and Hawaii over the past 25 years. In 2015, he founded the SHADE Institute as part of the SHADE Group LLC.

SHADE's capacity to provide services proposed in this application will also be enhanced by the participation of subject matter experts, instructors and professional mentors from the fields of urban planning, landscape architecture and architecture.

## B. Facilities

SHADE Group's 2,000 SF studio in Iwilei provides a professional setting for interns to work and meet with mentors. However, when working with communities, having an onsite meeting facility is very productive for planning workshops and meetings. For example, for the Chinatown Project, the Hawaii Heritage Center's storefront space on Smith and Hotel Street served this purpose during the summer of 2015.





### D. Future Sustainability Plan

This grant opportunity will provide seed money to build an institution for global public service with a Hawaii base. This grant application would serve two purposes. First, in the short term, it would provide start-up operational funding to continue current projects generated through the Chinatown project (2015) and the forthcoming Summer Institutes (2016 and 2017). Second, for longer term sustainability, this grant may also fund SHADE's 501(c)(3) application process and the development of additional funding sources through private foundations and businesses. Currently, the SHADE Institute is administered by SHADE Group LLC; private donations are administered by the Oahu Economic Development Board (previously known as Enterprise Honolulu), SHADE's fiscal sponsor.

SHADE's long range plan is to create a Hawaii-based institution to provide training and service to cities and communities. Based on its record of achievement from FY 2016-2017 projects in Hawaii, SHADE will apply for funding from national and international sources. Partnerships with the national offices of the professional organizations who are already local collaborators such as the APA, AIA, ASLA and ULI, as well as the U.S. Green Building Council and National League of Cities are strong possibilities. SHADE will also develop partnerships with universities and other training centers in Hawaii (i.e. UHM DURP-NDPTC) and abroad throughout the Asia-Pacific Region.

Locally, the Hawaii Community Foundation has expressed interest in matching SHADE Institute with potential donors once its non-profit status is achieved (early 2017 expected). Project specific funding through the counties and local businesses will also be continuously sought.



## Summer Institute 2015

Chinatown Urban Acupuncture Project Executive Summary

From June to August, twelve SHADE interns from three universities in Hawaii and the U.S. mainland and ten professional mentors from the fields of urban planning, architecture and landscape architecture participated in the Urban Acupuncture Project. Working with members of Honolulu's Chinatown Community, the interns assessed Chinatown's current conditions and began the process of planning a vision for its future. Preparation for the forthcoming Downtown Transit Oriented District (TOD) and rail station on Kekaulike Street was the stimulus for this project after a year of informal discussion among the Chinatown community and its area legislators.

SHADE interns and mentors participated in three community planning workshops, eight lunchtime talk stories with guest speakers, and weekly meetings with SHADE mentors. The interns served as volunteer facilitators at the Chinatown Action Summit, organized by the City Department of Planning and Permitting's TOD Planning Team on June 27<sup>th</sup> at the Golden Palace Restaurant. Following the Summit, SHADE led two of its own community design workshops on July 11<sup>th</sup> and 25<sup>th</sup> at the Hawaii Heritage Center in Chinatown. In addition to the workshops, talk stories and weekly meetings at SHADE, many Chinatown stakeholders were engaged through field surveys and informal conversations.

The final work products of the Project include the following recommendations: a Vision Statement, Design Strategies and 12 Project Concepts. These recommendations are supported by a 372 page report, a District Vision Site Plan, and room-sized scale model of the Chinatown District. Ultimately, these work products and recommendations will provide the basis for proof of concept project implementation (i.e. funded execution of specific projects and further planning). Ultimately, the establishment of a Chinatown Community Planning organization with dedicated funding, staff and a program will ideally follow-up this effort. Funding of the Summer Institute was made possible primarily by the City and County of Honolulu, City Council; Bento Box LLC; Hawaii Heritage Center, the Oahu Economic Development Board and Dean Sakamoto Architects LLC. ## SHADE throws a light on Chinatown

Honolulu architect Dean Sakamoto has launched a new venture called SHADE - Sustainable, Humanitarian. Architecture & Design for the Earth.

An umbrella group currently seeking nonprofit status. SHADE is intended to bring together architects, urban designers and engineers from private practice to collaborate with government entities and the public on issues with a strong public policy component.

Sakamoto kicked off the initiative Tuesday night at the AIA Honolulu's Center for Architecture, SHADE's first big project? Something Sakamoto calls "Chinatown Urban Acupunture."

the dozen interns participating in the SHADE Summer Institute 2015. who are documenting the present condition of the 11 streets of Honolulu's Chinatown. He hopes that experienced design professionals will step forward to serve as mentors for the interns.

Sakamoto also wants the public to turn out for the workshops and activities coming up in the Chinatown Urban Acupuncture project. The first major workshop will be the Chinatown Action Summit from 8:30 a.m. to 1 p.m. Saturday at the Golden Palace Seafood Restaurant at 111 N. King St. Harrison Rue, transit oriented development administrator for the City & County of Honolulu, noted that 250 people already had registered for the event and said the city wants to hear what residents

need, even blue-sky ideas.

"It could be as simple as a bench that's needed or as big as a festival promenade," he said.

Other events through Aug. 15 Include lunchtime talk stories with architects, planners and representatives from the Honolulu Authority for Rapid Transportation.

State and city governments were both represented at the SHADE reception. State Sen. Suzanne Ghun Oakland, whose district includes Chinatown, noted that Honolulu's Chinatown is the nation's oldest. Honolulu City Council Chair Ernle Martin said of the SHADE Chinatown initiative, "We're looking for outcomes we can guide with legislation."


