I. Background and Summary

1. A brief description of the applicant's background.

The Wahiawa Center for Community Health (WCCH) was incorporated in 2012 and recognized as an IRS 501(c)(3) with the mission: "In the spirit of Aloha and compassion, the WCCH provides access to affordable, quality health care and wellness services to promote a healthy community." The WCCH is a 'Senator Inouye Legacy Project', whose vision was to ensure this geographically isolated area was adequately served with primary medical care.

WCCH has worked diligently with partners to: conduct extensive needs assessments of the service area; obtain U.S. Department of Agriculture (USDA) designation as a 'rural' community; and have the population designated by the U.S. Department of Health and Human Services (HRSA) as a Medically Underserved Population (MUP). This work lays the foundation for WCCH to secure status as a Federally Qualified Health Center (FQHC), and receive ongoing base funding from HRSA to serve uninsured and underinsured residents.

When fully operational, WCCH's services will consist of primary care, (including pediatrics and OB/GYN), behavioral health, oral health care, care coordination, and on-site pharmacy services. By the end of the second year of operations, WCCH will serve around 6,000 unduplicated patients.

2. The goals and objectives related to the request.

The goal for this project is to develop facilities and clinical capacity to serve Wahiawa's low-income residents. The objective of this project is to purchase, renovate and revitalize 5,535 square feet in the Wahiawa Medical Building at 302 California Avenue. This space is currently occupied by two medical practices comprised of physicians (Dr. Abundo and Dr. Perlas) that are scheduled to retire in 2016. WCCH will absorb their patient base of 6000.

Built in 1977, the medical building is well situated in downtown Wahiawa, along the major bus line that runs through town. The offices are modestly serviceable and in dire need of improvements: infrastructure, equipment and fixtures are past their useful life; and the interior desperately needs renovation. WCCH intends to demolish the interior and outfit the space for comprehensive primary care services as the main clinic and administrative offices. The design will support the Patient Centered Heath Care Home model.

3. The public purpose and need to be served.

WCCH will improve access to healthcare for most or all of its vulnerable populations. The area's MUP designation is a result of the inadequate number of primary care clinicians and the area's poor socio-economic indicators. This is the only MUP in Hawai'i that is not within the immediate service area (or served by) an existing FQHC – a gap WCCH is going to fill.

Currently, Hawai'i DOH is working to designate the Wahiawa – Waialua areas as a Health Professional Shortage Area (HPSA) by HRSA. The number of health care providers in the Wahiawa area continues to decline even as the population of low to moderate income and homeless in the area is increasing. All of the area's primary care providers are at capacity, none are accepting new patients, and there are only three practicing pediatricians in Wahiawa, all of whom intend to retire in 2016.

4. Describe the target population to be served.

The WCCH service area is home to about 43,000 residents, with these demographic characteristics:

Racial and Ethnic Diversity. The area is home to both ethnically and racially diverse populations. The racial/ethnic groups report themselves as White (43.5%), Asian (34%), Two or More races (19%), Hispanic (17%), Black or African American (11%), and Native Hawaiian and Other Pacific Islander (9%). (US Census Bureau, 2015). 25.3% speak another language than English at home, which is greater than the national rate (21%) and in line with the rate in the state of Hawaii (25%). 44 percent of those who spoke some other language reported that they did not speak English "very well". (US Census Bureau, 2015) In recent years, there has also been an increase of limited English proficient Micronesian immigrants to the area.

Population and Age. Minors (18 and under) in the region make up 24.1% and seniors (65 and older) make up over 17% of the population (US Census Bureau), 2015. Youth and seniors comprise nearly 41% of the population whom are considered among the most medically vulnerable populations in a given community (CDC 2014). 57% of elementary students participate in free or reduced meal programs (Kids Count Data Center, 2012) and 35% are on Medicaid.

Poverty. A total of 44% of Wahiawa's population are at or below 200% of poverty (2010 U.S. Census), placing them at a greater risk of health disparities and pre-mature death. Many lack transportation, are underinsured and in need of accessible and affordable primary care.

Health Indicators. Data from the 2012 State of Hawai'i Primary Care Needs Assessment Data Book provides additional insight to the service area:

- 1. Wahiawa has the most pregnancies with "less than adequate prenatal care" in Honolulu County 29.4% versus county at 25.8%.
- 2. 27.5% of Wahiawa adults are obese, the fourth highest rate in the state and compared to the state average of 21.9%
- 3. 21% of residents smoke (15.3% county; 16.1% state)
- 4. 11.2% are adults with diabetes, the third highest in the state (9.0% county; 8.8% state)
- 5. The number of adults with high blood pressure (29.1%) is relatively consistent with county and statewide rates (29.0% and 28.4% respectfully).
- 6. The stroke mortality, 48.0/100,000 rate is 10% higher than county and state rates (37.7% and 38.2%), a possible link to insufficient preventive and primary care and geographical barriers.
- 7. Wahiawa has the third largest population of unsheltered homeless men, women, and children (2013 State of Hawai'i Department of Human Services, Homeless Programs Office Point in Time Count)

5. Describe the geographic coverage.

The WCCH Service Area includes all the residents of Wahiawa, an area defined as ZIP Code 96797. This includes Census Tracts 90-95 plus Tract 100 Block 9. The geographic area includes: Wahiawa, Helemano; Whitmore; Wilikina; Schofield Barracks (Census Tract 90); and Wheeler Air Force Base (Census Tract 95). For the purposes of this application 'Wahiawa' will be used as an inclusive term for all of these geographic areas.

II. Service Summary and Outcomes

1. Describe the scope of work, tasks and responsibilities

Scope of work and tasks. Access to State GIA Funds is vital to establish facilities that are needed for WCCH's rural and medically underserved communities. The renovation and construction project will create the first patient centered medical home for the Wahiawa Center for Community Health (WCCH). It will be located inside the Medical Arts Building at 320 California.

WCCH will purchase the following medical practices and facilities.

Unit 106 will become the main medical clinic. It has not had any major renovations or improvements since it was built 39 years ago. It will be demolished, renovated and equipped with up-to-date infrastructure, communication and medical equipment. Unit 208 will serve as the administration office and will receive adjustments to air-conditioning for proper maintenance of IT and computer systems.

Renovation to Unit 106 will enhance office space, registration, hallways, and examination areas to ensure ideal multi-disciplinary workflow for WCCH's integrated care approach.

New medical equipment, practice management systems, electronic medical records and new IT infrastructures and telecommunications will provide efficiencies in health care while controlling costs over the long term.

Tasks. These tasks will be completed in the project:

Architectural, engineering services and permitting - Architect to provide interior design and project management services. Also, schematic design, design development, construction documents and bidding review. Mechanical, plumbing, fire protection, electrical, structural, IT acoustics and permit processing will be completed.

Construction: Main Medical Clinic (Unit 106)

- Demolition. Complete demolition and removal of all existing HVAC, plumbing, electrical, walls, ceiling, flooring and finished goods. HAZMAT Survey and assumed abatement and disposal of asbestos containing materials. Lead containing paint mitigation.
- Construction of new 4743 sq.ft. Medical Clinic: Framed interior walls, acoustical tile
 ceiling, new HVAC system and refrigerant system; new dedicated split system for server
 room; new plumbing to 15 sinks and 4 restrooms; excavation and backfill for new

plumbing, new power, lighting, communication rough-in; flooring wall cabinets in exam rooms and casework for offices, and waiting room; commercial toilets, commercial window shades, metal door frames and wood doors, interior paint and permits.

Communications: IT Cabling Infrastructure

 Wall phone, wi-fi and data outlets, Category 6 cabling for computer network access and VOIP communications, overhead paging, interior distribution (security) and interior communication room build-out.

Responsibilities

Bev Harbin, Executive Director (ED) will be in charge of the project to serve as the Facilities Project Manager. She will provide overall management and oversight of the renovations, contracts and progress. She will approve additional work and changes to plans as needed and oversee communication and convene weekly/bi-weekly status meetings.

Jim Ellsworth, Chief Financial Officer (CFO) will manage procurement and ensure funds are expended on a timely basis and approve invoice payments. Accounting procedures will be compliance, applicable to WCCH's policy of control and County, State and Federal regulations. Jim will attend weekly or bi-weekly status meetings with the architect, ED and Construction Committee, and prepare and submit budget and progress reports to the WCCH Board.

David Bylund and Gary Marshall of Architects Hawaii Limited (AHL) have been contracted to lead the project. Mr. Bylund heads AHL's Healthcare Studio and designed several health facilities across Hawaii, including the John A. Burns School of Medicine. AHL will be responsible for the design, drawing plans and working with the general contractor, structural, mechanical and electrical engineers. AHL will prepare a detailed schedule for the project in logical steps and budget time required to meet deadlines, and for obtaining necessary permits and licenses.

AHL will hire a *General Contractor* for the project; the architect will direct the work of the Contractor. The Contractor will have the authority to hire and direct all subcontractors and staff retained for the project, and participate in status meetings.

A bookkeeper (TBA) will be hired to track financial data, invoices and the activities of the architect, general contractor and other consultants retained for this project. He/she will address patient, visitor and employee safety during the project and attend status meetings.

3. Quality assurance and evaluation plans for the request.

ED Bev Harbin, the architect and contractor, are responsible for monitoring and evaluating the renovation project. Quality assurance includes the following:

- A construction committee will meet bi-weekly to monitor the project. It is comprised of 7
 WCCH board members including Board President, Mary Talon; Treasurer, June Jones;
 Doug Aton; Scott Harada; Jay Raymundo, Joy Mahiko and the WCCH ED, Ms. Harbin.
- WCCH will conduct weekly or bi-weekly status meetings of the ED, CFO, architect, project manager and general contractor, and the members of the Construction Committee.
- ED will provide monthly reports to the WCCH Board of Directors to ensure that the
 project is proceeding in the forecasted timeframe and within the budget and scope
 approved by the Board of Directors.
- Ongoing oversight and evaluation by the general contractor to ensure that construction standards are as required by the State of Hawaii and applicable code and that the facility is being constructed per specifications.
- CFO oversight will serve to ensure compliance proper documentation of expenditures and accounting procedures.
- In addition to the ongoing monitoring of the project the WCCH will conduct a financial audit to ensure that the organization complies with Generally Accepted Accounting Principles.

4. List the measure(s) of effectiveness.

The effectiveness of the WCCH project will be determined by the completion of tasks within the projected timeline, as evaluated by the ED, Construction Committee and the Architect. See the timeline contains more details.

Previous funding: Over the past 3 years, WCCH has received \$500,000 in grants from foundations and donors such as HMSA, Atherton, AlohaCare, Kaiser Permanente, United Health Alliance and the State GIA.

IV. Experience and Capability

A. Necessary Skills and Experience

WCCH ensures that the design and construction professionals are licensed and experienced to successfully complete a renovation the size and scope of this project. See the qualifications of key staff for the renovation in the section below, *V. Personnel: Project Organization and Staffing*.

Board Governance. The Board of Directors has a Construction Committee comprised of seven board members, which includes the President and Treasurer. They meet at least biweekly and are responsible for evaluating all matters regarding facilities, and for reporting to the full Board.

B. Facilities

WCCH intends to acquire the medical practices and facilities of Drs. Manuel Abundo, MD, located at 302 California Avenue, Suite 106 and of Dr. Danilo Perlas, MD, located at 302 California Ave, Suite 208 in Wahiawa (the Medical Practices and the Facilities, respectively).

WCCH is entering into a contract to acquire, subject to appropriate due diligence, for the acquisition of the assets of the Medical Practices and to lease the Facilities for up to three years. It is anticipated that the employees, physicians, nurse practitioners of the private practices will be retained for patient continuity of care. In addition, the Facility owners are providing an exclusive three-year option to purchase the Facilities.

Upon execution of the acquisition agreements, immediate remedial work will begin at both sites to prepare them for interim operations (pending the renovations expected to take place between 2017-18). Remedial work will include providing compliant patient access and normal new tenant improvements such as flooring and wall coverings.

Full renovation will transform the facilities layout to better suit a medical home delivery model and using care teams for effective, patient centered care. As WCCH executes its startup plan, it will grow in terms of expanding its clinical capacity and increasing the number of patients significantly. WCCH anticipates to be operating at the full capacity of the Facilities by 2018. The renovated facilities' new layout and the new operating equipment and the adoption of patient centered medical home care models will be sufficient to provide a high quality medical home that is accessible to most or all of the underserved or underinsured people of Wahiawa.

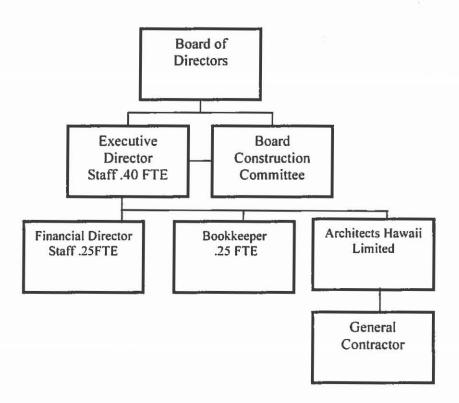
V. Personnel: Project Organization and Staffing

A. Proposed Staffing, Staff Qualifications, Supervision and Training

Executive Director, Bev Harbin: Ms. Harbin will lead this project as WCCH's ED and Facilities Project Manager. Bev has been involved with the WCCH, literally, from the beginning and has been successful in securing grant monies, developing contractual arrangements for leasing and purchase agreements, successful collaborative partnerships.. She has experience in overseeing construction as a private entrepreneur and has recruited, developed, and retained WCCH's Board of Directors and provides organizational leadership and training. Bev has also initiated and monitored the Wahiawa service area's the various recognitions and designations necessary to move the development of WCCH forward and to become eligible for federal funds. She has 30 years of experience in leading health, education and a spectrum of development projects.

James Wm. Ellsworth (CFO) began his career as a Certified Public Accountant; he has provided consulting services for start up health care organizations from 2012 through 2015. Mr. Ellsworth also served as Executive Director of Capitol Health Network, a consortium of federally qualified health centers, behavioral health and other community health service providers. During his tenure he tripled the safety net primary care capacity, created a clinically integrated behavioral health network, and adopted population health management tools within the medical home setting. Previously, Mr. Ellsworth served as Executive Director of El Dorado County Community Health Center. From 2004 to 2012, Mr. Ellsworth helped develop EDCCHC from a start-up community clinic into a self-sustaining federally qualified community health center providing integrated primary medical care and behavioral health services to over 11,000 low-income residents of the region.

C. Compensation

A contract for \$55,280.95 was paid to Project Development Coordinator (Bev Harbin) in 2015. WCCH currently has no paid staff.

VI. Other

A. Litigation

WCCH is not involved in any litigation and does not have any outstanding judgments.

B. Licensure or Accreditation

WCCH is a nonprofit 501(c)3 organization as designated by the U.S. Internal Revenue Service and will apply for a HRSA New Access Point Grant to become a Federally Qualified Health Center as designated by the U.S. Department of Health, Health Resources and Services Administration in 2016 which posting has been anticipated since November 3, 2015 according to the HRSA website.

C. Private Educational Institutions

Not applicable.

D. Future Sustainability Plan

WCCH has identified two paths to achieve the status as a Federally Qualified Health Center (FQHC), via a New Access Point (NAP) award or through an administrative qualifying process that designates an organization as a FQHC – Look Alike. Recently, HRSA announced that it would likely be accepting applications for New Access Points (NAP) in the near future. These applications are highly competitive and require the health center to be compliant with all FOHC requirements.

Successful selection gives a health center the FQHC designation along with an enhanced reimbursement methodology including operating costs and substantial, ongoing grants for providing services to underinsured patients. WCCH is determined to compete in this NAP competition and is preparing its application. Alternatively and in addition to the NAP application (in case WCCH is unsuccessful in its application), WCCH will be seeking FQHC Look Alike status. The process for receiving FQHC Look Alike status is rigorous and time consuming. There are many prerequisites, including six months of prior operations as a health center with audited financials. All of the required services and structures of a FQHC are required to be in place at the time of application.

Additional sources of revenue are expected. The WCCH 3iii Capital Campaign has begun and will continue to bring in funding from health insurers, donors and other foundations, including the McInerny Foundation and the Harry and Jeanette Weinberg Foundation.
