The YMCA of Honolulu was founded in 1869 and incorporated under the laws of the Kingdom of Hawai'i in 1882. Every year, we serve more than 100,000 individuals in a variety of programs. YMCA programs and services are open to children, teens, women and men of all ages, faiths and backgrounds. In all our programs, we promote our core values of caring, honesty, respect and responsibility. We are a fellowship of people helping each other to learn, grow and improve our own lives as well as the lives of others. Our programs and services center around three areas of focus: Youth Development, Healthy Living and Social Responsibility.

The goals and objectives related to the request;

Funding is requested to restore the Smokestack in Waipahu. The existing structure poses a safety hazard for the immediate area in which it resides at the YMCA Leeward Branch. The YMCA contracted with a private company to provide an estimate and assessment of what is needed to restore the smokestack. There is surface damage from years of exposure to the elements and the age of the historical site. Repair work will shore up the base to prevent future structural issues.

3. The public purpose and need to be served;

Oahu Sugar Company was organized in 1897 and the Waipahu Mill was constructed the following year in 1898. After nearly 100 years of operation, it has served as the focal point of Waipahu's economic and cultural life as a plantation town. The YMCA of Honolulu purchased two acres of the site in 1997 as a new home for its Leeward Branch. In 1998, Oahu Sugar donated two additional acres on the condition that the original generator building and remaining smokestack be preserved. The YMCA took on the challenge of readapting and building the new Leeward YMCA and preserving the landmark of the community. The preservation of the iconic 175foot smokestack and the new Leeward facility demonstrate the use of different preservation treatments: preservation, adaptive reuse, rehabilitation and new construction that is sensitive to the history and architecture of the original buildings. In 2007, the Historic Hawaii Foundation presented the project with a Preservation Honor Award.

The YMCA of Honolulu serves children and families in Honolulu and across Oahu. The Leeward Branch is located in close proximity to the Waipahu Transit Center, the Filipino Community Center, elderly housing and the Waipahu Public Library, which are all active centers, along with the YMCA, for people in the community. The smokestack can be seen for miles and represents a bygone era in Hawaii that residents across the Island can relate to.



Pursuant to Section 42F-103, Hawai'i Revised Statutes, for grants used for the acquisition of land, when the organization discontinues the activities or services on the land acquired for which the grant was awarded and disposes of the land in fee simple or by lease, the organization shall negotiate with the expending agency for a lump sum or installment repayment to the State of the amount of the grant used for the acquisition of the land.
