
A BILL FOR AN ACT

RELATING TO FUNDING FOR PARKING FOR DISABLED PERSONS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that the statewide
2 parking program for persons with disabilities, as established
3 under part III of chapter 291, Hawaii Revised Statutes, pursuant
4 to the federal Uniform System for Handicapped Parking Act, and
5 administered by the disability and communication access board,
6 provides individuals with mobility disabilities the ability to
7 travel and park in accessible parking stalls. The purpose of
8 this Act is to fund the disabled person parking program with
9 revenues from a portion of the motor vehicle registration fee.

10 SECTION 2. Section 249-31, Hawaii Revised Statutes, is
11 amended to read as follows:

12 "**§249-31 State registration fee.** (a) All vehicles and
13 motor vehicles in the State as defined in section 249-1,
14 including antique motor vehicles, except as otherwise provided
15 in sections 249-4 and 249-6, shall be subject to a [~~\$45~~] \$46
16 annual vehicle registration fee. The fee shall be paid each
17 year together with all other taxes and fees levied by this

1 chapter on a staggered basis as established by each county as
 2 authorized by section 286-51, and the state registration for
 3 that county shall likewise be staggered so that the state
 4 registration fee is due and payable at the same time and shall
 5 be collected together with the county fee. The state
 6 registration fee shall be deemed delinquent if not paid with the
 7 county registration fee. The respective counties shall collect
 8 this fee together with the vehicle registration tax collected
 9 for the county and shall transfer the moneys collected under
 10 this section to the State.

11 (b) From each annual motor vehicle registration fee, the
 12 director shall deposit \$40 into the state highway fund [~~and~~], \$5
 13 into the emergency medical services special fund[-], and \$1 into
 14 the disability and communication access board special fund
 15 established pursuant to section 348F-7."

16 SECTION 3. Statutory material to be repealed is bracketed
 17 and stricken. New statutory material is underscored.

18 SECTION 4. This Act shall take effect on January 1, 2016.
