
A BILL FOR AN ACT

RELATING TO CAPITAL IMPROVEMENT PROJECTS FOR THE DEPARTMENT OF
WATER, COUNTY OF KAUAI.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The director of finance is authorized to issue
2 general obligation bonds in the sum of \$12,450,000 or so much
3 thereof as may be necessary and the same sum or so much thereof
4 as may be necessary is appropriated for fiscal year 2015-2016
5 for the purpose of financing capital improvement projects for
6 the department of water, county of Kauai, as follows:

7 1. To be expended by the department of water, county of Kauai:

8 A. Hanapepe/Eleele transmission waterline improvement
9 project, Kauai

10 Acquisition of land, plans and
11 design, and construction of a
12 three thousand foot, fifteen inch
13 water main along Kaumualii highway
14 and a three thousand foot, twelve
15 inch water main along Hanapepe
16 road. This project will provide



1 larger sized transmission mains to
 2 connect the Hanapepe two hundred
 3 twelve foot sub-system and Eleele
 4 system together. Eleele schools,
 5 Port Allen, Eleele shopping
 6 center, the county's affordable
 7 housing initiatives, as well as
 8 customers in the area will benefit
 9 from this project.

14 B. Kapaa storage improvements, Kauai
 15 Construction of two, five hundred
 16 thousand gallon storage tanks with

 19 hydraulic zone.

21	Total funding	\$ 8,000,000






1 SECTION 2. The appropriation made for the capital
2 improvement project authorized by this Act shall not lapse at
3 the end of the fiscal biennium for which the appropriation is
4 made; provided that all moneys from the appropriation
5 unencumbered as of June 30, 2018, shall lapse as of that date.

6 SECTION 3. The sums appropriated shall be expended by the
7 designated expending agency for the purposes of this Act.

8 SECTION 4. This Act shall take effect on July 1, 2015.
