
A BILL FOR AN ACT

MAKING AN APPROPRIATION FOR A WAR MEMORIAL.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature enacted Act 139, Session Laws
2 of Hawaii 2013, directing the office of veterans services, with
3 the assistance of the department of accounting and general
4 services, the department of defense, and the state historic
5 preservation division, to develop a plan to establish a memorial
6 honoring the veterans of the Persian Gulf War, Operation Desert
7 Storm, Operation Iraqi Freedom, Operation Enduring Freedom,
8 Operation New Dawn, Global War on Terrorism, Homeland Defense,
9 and Operation Noble Eagle, and those who have protected our
10 borders by land, sea, and air.

11 The purpose of this Act is to appropriate moneys for the
12 planning, design, and construction of the memorial honoring
13 these veterans, as proposed and submitted by the Gulf War
14 Memorial task force to the legislature in January 2014.

15 SECTION 2. There is appropriated out of the general
16 revenues of the State of Hawaii the sum of \$5,000,000 or so much
17 thereof as may be necessary for fiscal year 2015-2016 and the



1 same sum or so much thereof as may be necessary for fiscal year
 2 2016-2017 for the planning, design, and construction of a
 3 memorial honoring the veterans of the Persian Gulf War,
 4 Operation Desert Storm, Operation Iraqi Freedom, Operation
 5 Enduring Freedom, Operation New Dawn, Global War on Terrorism,
 6 Homeland Defense, and Operation Noble Eagle, and those who have
 7 protected our borders by land, sea, and air, and for replicas of
 8 the memorial on each neighbor island, as recommended by the Gulf
 9 War memorial task force pursuant to Act 139, Session Laws of
 10 Hawaii 2013.

11 The sums appropriated shall be expended by the office of
 12 veterans services for the purposes of this Act.

13 SECTION 3. This Act shall take effect on July 1, 2015.
