1	(c) The county surcharge on transient accommodations tax		
2	shall apply to the occupant of a resort time share vacation		
3	unit. Every plan manager shall be liable for and pay to the

6	manager who shall be subject to this section.		
7	(d) Each county surcharge on transient accommodations tax		
.8	that is adopted or extended shall be levied beginning in the

11	(e) Within ten days after collection all county surcharge

17	report and remit the county surcharge on transient
