BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 Section 102-2, Hawaii Revised Statutes, is SECTION 1. 2 amended by amending subsection (b) to read as follows: The bidding requirements of subsection (a) shall not 3 apply to concessions or space on public property set aside for 4 5 the following purposes: For operation of ground transportation services and 6 (1) 7 parking lot operations at airports, except for motor vehicle rental operations under chapter 437D; 8 For lei vendors: 9 (2) For airline and aircraft operations; 10 (3) For automated teller machines and vending machines, 11 (4) except vending machines located at public schools 12 operated by blind or visually handicapped persons in 13 accordance with section 302A-412; 14 For operation of concessions set aside without any 15 (5) 16 charge;

4	(10)	For operation of concessions that furnish goods or
5		services for which there is only one source, as
6		determined by the head of the awarding government
7		agency in writing that shall be included in the
8		contract file;
9	(11)	For any of the operations of the Hawaii health systems
10		corporation and its regional system boards;
11	(12)	For airport operation of concessions providing
12		electronic communication services;
13	(13)	For airport operation of concessions consisting solely
14		of advertising;
15	(14)	For the stadium authority operation of concessions
16		providing electronic communication services; [and]
17	(15)	For the stadium authority operation of concessions
18		consisting solely of advertising[-]; and
19	(16)	For the operations of the natural energy laboratory of
20		Hawaii authority."
