### A BILL FOR AN ACT

RELATING TO THE WEST MAUI OCEAN RECREATION MANAGEMENT AREA.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that increased 2 recreational and commercial activities in Hawaii's nearshore 3 waters have led to safety concerns, and in some cases, tragic 4 The legislature also finds that given the popularity 5 of ocean activities in Kaanapali on the island of Maui, the 6 department of land and natural resources should establish a west 7 Maui ocean recreation management area advisory committee 8 comprised of users of the ocean to work with the department on 9 issues arising relating to the area, particularly the waters of 10 Kaanapali. 11 SECTION 2. (a) Not later than September 1, 2016, the 12 department of land and natural resources shall establish a west 13 Maui ocean recreation management area advisory committee that 14 shall advise the department of land and natural resources on
