# A BILL FOR AN ACT

RELATING TO AGING.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	PART I
2	SECTION 1. The legislature finds that the kupuna care
3	program was enacted in 1999 to address the needs of Hawaii's
4	aging population and the issues arising from those needs. The
5	kupuna care program is considered to be an alternative to
6	traditional long-term care options. The goal of kupuna care is
7	to enable Hawaii seniors to lead independent, meaningful, and
8	dignified lives in their own homes and communities. The
9	legislature further finds that the kupuna care program provides
10	access to affordable and quality home- and community-based
11	services, including hot meals, transportation, case management,
12	and personal care assistance. Services offered by the kupuna
13	care program provide a safety net for all kupuna and their
14	caregivers.
15	SECTION 2. There is appropriated out of the general
16	revenues of the State of Hawaii the sum of \$ or so much
17	thereof as may be necessary for fiscal year 2016-2017 for the

- 1 kupuna care program; provided that the sum appropriated shall be
- 2 in addition to the base budget of the executive office on aging.
- 3 The sum appropriated shall be expended by the department of
- 4 health for the purposes of this part.
- 5 PART II
- 6 SECTION 3. The legislature finds that the State's aging
- 7 and disability resource center is a navigational tool intended
- 8 to streamline access to long-term supports and services for
- 9 older adults, individuals with disabilities, and family
- 10 caregivers. The legislature additionally finds that proper
- 11 funding for the aging and disability resource center is
- 12 essential to ensure the center is an effective single point of
- 13 entry for individuals seeking information about appropriate
- 14 long-term care options. Ensuring the availability of services
- 15 once a consumer receives a referral, such as those offered
- 16 through the kupuna care program, is also critical to the success
- 17 of the aging and disability resource center.
- 18 SECTION 4. There is appropriated out of the general
- 19 revenues of the State of Hawaii the sum of \$ or so much
- 20 thereof as may be necessary for fiscal year 2016-2017 for the
- 21 aging and disability resource center.

- 1 The sum appropriated shall be expended by the department of 2 health for the purposes of this part. 3 PART III 4 SECTION 5. The legislature finds that every year in 5 Hawaii, on average eighty-five seniors die, 1,960 are 6 hospitalized, and 8,700 are treated in emergency departments as 7 a result of falls. Falls among the elderly also result in 8 almost \$1,200,000 in hospital and physician charges. 9 recognition of this critical public health issue, Act 153, 10 Session Laws of Hawaii 2014, established a fall prevention and 11 early detection services coordinator position within the 12 department of health's emergency medical services and injury prevention system branch. This position enables the department 13 14 of health to support a coordinated statewide approach to prevent 15 and reduce the impact of falls among older adults. Act 153
- The legislature further finds that access to fall prevention services and programs would significantly reduce costs associated with falls in the elderly by expediting

- 7 point for statewide injury prevention and detection efforts to
- 8 ensure multidisciplinary support, coordination of prevention and
- 9 detection efforts, and continuity of implementation and
- 10 accountability.
- 11 The purpose of this part is to assure a continued focus on
- 12 fall prevention in Hawaii, which will ultimately result in
- 13 longer, healthier lives for the State's aging population.
- 14 SECTION 6. There is appropriated out of the general
- 15 revenues of the State of Hawaii the sum of \$ or so much
- 16 thereof as may be necessary for fiscal year 2016-2017 for fall
- 17 prevention and early detection services for the elderly.
- 18 The sum appropriated shall be expended by the department of
- 19 health for the purposes of this part.

1	PART IV
2	SECTION 7. The legislature finds that the Hawaii healthy
3	aging partnership program was established in 2003 to improve the
4	health status of older adults by empowering residents to make
5	healthy decisions and engage in healthier lifestyles. Since its
6	formation, the healthy aging partnership has successfully
7	adapted evidence-based health promotion programs and disease
8	prevention programs for the multicultural population in Hawaii.
9	The legislature further finds that participants who complete
10	workshops offered by the healthy aging partnership feel better,
11	are less limited by their health conditions, and often spend
12	less time at their doctor's office.
13	The legislature also finds that the healthy aging
14	partnership received the 2013 Multicultural Aging award from the
15	American Society on Aging. This award brought national
16	recognition for the healthy aging partnership's critical role in
17	improving the health of Hawaii's multiethnic elderly population.
18	The purpose of this part is to provide funding to support
19	the healthy aging partnership program and its important role in
20	improving the health and well-being of Hawaii's kupuna.

1 SECTION 8. There is appropriated out of the general 2 revenues of the State of Hawaii the sum of \$ or so much 3 thereof as may be necessary for fiscal year 2016-2017 for the 4 healthy aging partnership program of the department of health's 5 executive office on aging. 6 The sum appropriated shall be expended by the department of 7 health for the purposes of this part. 8 PART V 9 SECTION 9. The legislature finds that the Hawaii 2025: 10 State Plan Alzheimer's Disease and Related Dementias, published 11 by the executive office on aging, identifies goals and key 12 strategies to improve the lives of the numerous families 13 affected by the disease. The legislature further finds that 14 Alzheimer's disease is the sixth leading cause of death in the 15 United States and that it affects twenty-six thousand Hawaii 16 residents, a number that will increase by forty per cent by the 17 year 2025. The legislature also finds that an estimated sixty-18 five thousand unpaid caregivers in this State provide seventy-

1 caregiver, and the substantial projected increase by 2025, there 2 is a need for a coordinated and prepared support system to 3 address the multitude of issues arising from addressing the 4 disease. While the Hawaii 2025: State Plan Alzheimer's Disease 5 and Related Dementias identifies strategies to address the 6 disease, the services and activities require coordination at a 7 systemic level, such as through a coordinator position. 8 The legislature further finds that the public awareness and 9 communication subcommittee of the statewide task force on **10** Alzheimer's disease and related dementia made the key 11 recommendation calling for a public awareness campaign that 12 utilizes various media sources to positively promote adults with **13** Alzheimer's disease and related dementia with dignity and 14 respect and highlight caregivers as compassionate individuals 15 who champion the health and well-being of their loved ones. 16 The purpose of this part is to make an appropriation for an 17 Alzheimer's disease and related dementia services coordinator 18 position and to make an appropriation for a campaign to raise 19 public awareness about Alzheimer's disease and related dementia.
