

### A BILL FOR AN ACT

RELATING TO HEALTH SCREENINGS.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- SECTION 1. The legislature finds that vision and hearing
  - 2 are critical to speech and language development, communication,
  - 3 and learning. Research indicates that eighty per cent of
  - 4 learning during a child's first year is obtained through vision,
  - 5 and those unable to read well by the end of grade three are more
  - 6 likely to drop out of school or be held back. More importantly,
  - 7 most undetected or undiagnosed vision issues can become
  - 8 permanent if untreated before age six. Hearing is also critical
  - 9 to learning and child development, and hearing screenings can
- 10 generate a return of \$112 for every \$1 spent.
- To ensure the health of the children of Hawaii, the
- 12 legislature enacted Act 312, Session Laws of Hawaii 1992, which
- 13 established a systematic hearing and vision program for children
- 14 to detect and identify hearing and vision deficiencies in school
- 15 children and recommend to parents or guardians the need for
- 16 appropriate evaluation. The department of health successfully
- 17 implemented the program, but a lack of funding for the program

- 1 caused the program to become and remain inactive for quite some
- 2 time.
- 3 The legislature further finds that there are some isolated
- 4 community screening programs offered by local nonprofits in some
- 5 areas of the State. However, not all children have access to
- 6 these screenings, which inhibits accurate statewide data
- 7 collection and assurance for the quality of the screening.
- 8 The purpose of this Act is to appropriate funds to
- 9 establish a position within the department of health to
- 10 implement a systematic vision and hearing program for the
- 11 children of Hawaii and to cover operating expenses for the
- 12 program.
- 13 SECTION 2. There is appropriated out of the general
- 14 revenues of the State of Hawaii the sum of \$ or so
- 15 much thereof as may be necessary for fiscal year 2016-2017 for
- 16 one full-time equivalent (1.0 FTE) position to implement a
- 17 systematic vision and hearing program and for operating expenses
- 18 of the program, including administrative oversight, support in
- 19 vision and screening implementation, follow-up, and aggregate
- 20 data collection and reporting.

- 1 The sum appropriated shall be expended by the department of
- 2 health for the purposes of this Act.
- 3 SECTION 3. This Act shall take effect on July 1, 2016.
