
A BILL FOR AN ACT

MAKING APPROPRIATIONS FOR COLLECTIVE BARGAINING COST ITEMS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 PART I

2 SECTION 1. There are appropriated or authorized from the
3 sources of funding indicated below to program planning,
4 analysis, budgeting (BUF 102) the following sums, or so much
5 thereof as may be necessary, to fund for fiscal biennium 2015-
6 2017 all collective bargaining cost items in the agreement
7 negotiated with the exclusive bargaining representative of
8 collective bargaining unit (8):

9 by chapter 89C, Hawaii Revised Statutes, for state officers and
10 employees excluded from collective bargaining unit (8):

3 SECTION 6. Funds appropriated or authorized by this Act
4 that are not expended or encumbered by June 30, 2016, and June
