A BILL FOR AN ACT

RELATING TO SPORTS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that, in 2007, sports was 2 a \$213,000,000,000 industry in the United States. In addition 3 to spectator fees, the sports industry generates revenue in 4 advertising, endorsements, media broadcast rights, and 5 licensing. Hawaii hosts at least ten major national and 6 international sporting events each year, including the National 7 Football League's Pro Bowl, Honolulu Marathon, Vans Triple Crown 8 of Surfing, Sheraton Hawaii Bowl, Molokai Hoe, XTERRA World 9 Championship, Ironman World Championship, Maui Jim Maui 10 Invitational, and the PGA Sony Open.

11 From 1979 to 2008, Hawaii hosted the highly-successful
12 annual match-up known as the National Football League Pro Bowl,
13 the all-star game currently played before the Super Bowl.
14 Hawaii's streak of hosting thirty consecutive Pro Bowls at Aloha
15 Stadium was broken in 2009 when the game moved to Miami,
16 Florida. However, the Pro Bowl returned to Hawaii in 2010. In
17 2004, a National Football League-commissioned study found that

1 the Pro Bowl was worth \$12,100,000 in advertising for Hawaii. 2 In addition, the 2003 Pro Bowl brought eighteen thousand 3 visitors to Hawaii, which accounted for \$28,070,000 in spending 4 and \$2,720,000 in state taxes, according to the Hawaii tourism 5 authority. In Hawaii, the National Football League and its players donate to charities, visit at-risk and disabled youth, 6 7 and support the military with special gatherings, among many other activities. 8

9 Soccer is also an attractive sport for Hawaii, which has 10 several prime venues, including the Waipio Peninsula Soccer 11 Complex. Soccer is played by more than two hundred fifty 12 million players in more than two hundred countries, making it 13 the world's most popular sport. In 2008, Hawaii hosted the Pan-Pacific Championship competition, a combination of top teams in 14 15 Major League Soccer, the J-League, and A-League. The 16 tournament's championship round at Aloha Stadium, which featured 17 international soccer star David Beckham and Kamehameha Schools 18 alumnus Brian Ching, drew 23,087, reportedly the largest soccer 19 crowd ever to see a game in Hawaii. Fueled by the appearance of 20 Beckham, the tournament brought considerable media attention, 21 including global telecasts, to Hawaii.

1 Hawaii has also embraced mixed martial arts, a full-contact 2 combat sport that allows the use of both striking and grappling 3 techniques; involves both standing and on-the-ground 4 competition; and blends boxing, wrestling, Brazilian jiu-jitsu, 5 muay Thai, kickboxing, karate, judo, and other styles. Mixed 6 martial arts events have drawn capacity crowds to the Blaisdell 7 Center Arena. A Rumble on the Rock card featuring Hilo's BJ 8 Penn against Rodrigo Gracie in 2004 drew a standing-room-only 9 crowd of more than eight thousand. The prestigious Ultimate 10 Fighting Championship organization has never staged a match in 11 Hawaii, but the idea has been floated many times.

12 The legislature believes that there is significant room for 13 growth in the Hawaii sports industry and that attracting more 14 sporting events to use Hawaii as a venue will increase visitor 15 arrivals and expenditures.

16 The purpose of this Act is to create the Hawaii sports task 17 force within the department of business, economic development, 18 and tourism to plan and coordinate efforts to keep the Pro Bowl 19 in Hawaii and to establish Hawaii as a host site for a National 20 Football League preseason game, world-title soccer tournaments

3	SECTION 2. (a) There shall be established within the
4	department of business, economic development, and tourism, the
5	Hawaii sports task force. The task force shall plan and
6	coordinate efforts to:
7	(1) Keep Hawaii as the host site for the National Football
8	League's annual Pro Bowl; and
9	(2) Establish Hawaii as a host site for a National
10	Football League preseason game, world-title soccer

14	The task force shall make recommendations to the
15	legislature on addressing any issue the task force determines is

17	(b) The Hawaii sports task force shall meet quarterly at a
18	place and time to be determined by the chair of the task force.

19 The task force shall be dissolved on January 5, 2017.

No member shall be made subject to chapter 84, Hawaii Revised Statutes, solely because 9 10 of that member's participation as a member of the task force. 11 The Hawaii sports task force, in conjunction with the (e) 12 department of business, economic development, and tourism, shall submit a report with findings and recommendations, including 13 14 proposed legislation, if any, to: 15 Keep Hawaii as the host site for the National Football (1)16 League's annual Pro Bowl; and Establish Hawaii as a host site for a National 17 (2) 18 Football League preseason game, world-title soccer tournaments at Aloha Stadium, and mixed martial arts 19 20 Ultimate Fighting Championship tournaments at Aloha
