
A BILL FOR AN ACT

RELATING TO CAPITAL IMPROVEMENT PROJECTS FOR THE BENEFIT OF THE
THIRTY-FIFTH REPRESENTATIVE DISTRICT.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The following sums, or so much thereof as shall
2 be sufficient to finance the projects listed in this Act, are
3 hereby appropriated out of the general revenues of the State of
4 Hawaii for fiscal year 2015-2016:

5 1. Waipahu High School, Oahu
6 Design, construction, and equipment for a classroom
7 building with a parking lot at the ground floor;
8 ground and site improvements; equipment and
9 appurtenances.
