
A BILL FOR AN ACT

MAKING APPROPRIATIONS FOR COLLECTIVE BARGAINING COST ITEMS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 **PART I**

2 SECTION 1. There are appropriated or authorized from the
3 sources of funding indicated below to collective bargaining
4 statewide (BUF 102) the following sums, or so much thereof as
5 may be necessary, to fund for fiscal biennium 2015-2017 all
6 collective bargaining cost items in the agreement negotiated
7 with the exclusive bargaining representative of collective
8 bargaining unit (14):

 3 statewide (BUF 102) the following sums, or so much thereof as
 4 may be necessary, to fund for fiscal biennium 2015-2017, the
 5 salary increases and other cost adjustments authorized by
 6 chapter 89C, Hawaii Revised Statutes, for state officers and
 7 employees who are excluded from collective bargaining and belong
 8 to the same compensation plans as those officers and employees
 9 within collective bargaining unit (14):

4 SECTION 6. Funds appropriated or authorized by this Act
5 that are not expended or encumbered by June 30, 2016, and June
6 30, 2017, of the respective fiscal years, shall lapse as of
7 those dates.

8 SECTION 7. This Act shall take effect on July 1, 2091.
