## A BILL FOR AN ACT

RELATING TO BOARD MEMBER TERMS FOR THE BOARD OF NURSING AND THE BOARD OF SPEECH PATHOLOGY AND AUDIOLOGY.

## BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The board of nursing and the board of speech 2 pathology and audiology are the only two boards among the 3 professional and vocational licensing division's twenty-five 4 boards and commissions to have three-year terms for board 5 members. Although members may be reappointed and serve two 6 three-year terms consecutively, possibly serving a total of six 7 years, this time is short compared to the other boards and 8 commissions that allow for two four-year terms.

9 In addition to being consistent with other board member 10 terms, longevity and continuity are key for board members to 11 learn and acclimate themselves in order to become effective 12 board members. Also, finding members who are willing to 13 volunteer and give up time away from their paying jobs is often 14 difficult. So once an individual is willing to devote the time 15 and energy to being a board member, that member should be 16 allowed to serve as much time as possible.

12	"§457-3 State board of nursing; appointment; term of
13	office. The board shall consist of nine members as follows:
14	(1) Six shall be registered nurses, one of whom shall be
15	licensed as an advanced practice registered nurse in
16	this State;
17	(2) One shall be a licensed practical nurse; and
18	(3) Two shall be public members.
19	Both nursing education and direct providers of nursing services
20	shall be represented on the board. The term of office for
21	members of the board shall be [three] four years. No member

shall be appointed to more than two consecutive terms or serve
 more than [six] eight consecutive years. Six members of the
 board shall be residents of the city and county of Honolulu and
 three shall be residents of counties other than the city and
 county of Honolulu."

6 SECTION 3. Section 468E-6, Hawaii Revised Statutes, is
7 amended by amending subsection (c) to read as follows:

8 "(c) Members shall serve for a term of [three] four years.
9 Terms shall begin on the first day of the fiscal year and end on
10 the last day of the fiscal year."

SECTION 4. This Act shall apply to the terms of members currently serving on the board of nursing and to the terms of members currently serving on the board of speech pathology and audiology.

15 SECTION 5. Statutory material to be repealed is bracketed16 and stricken. New statutory material is underscored.

SECTION 6. This Act shall take effect upon its approval.
