
A BILL FOR AN ACT

RELATING TO THE HAWAII INTERAGENCY COUNCIL ON HOMELESSNESS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. Section 346-382, Hawaii Revised Statutes, is
2 amended by amending subsection (a) to read as follows:

3 "(a) The Hawaii interagency council on homelessness shall
4 be composed of the following members or the member's designee:

5 (1) Governor's coordinator on homelessness, who shall
6 serve as chair;

7 (2) Director of human services;

8 (3) Administrator of the homeless programs office of the
9 department of human services;

10 (4) Director of health;

11 (5) Director of labor and industrial relations;

12 (6) Director of public safety;

13 (7) Director of business, economic development, and
14 tourism;

15 (8) Chairperson of the board of land and natural
16 resources;

17 (9) Director of transportation;

15 president of the senate, of whom one member shall be
16 designated by the president of the senate to serve as
17 an alternate member on the Hawaii interagency council
18 on homelessness to serve in the other member's
19 absence;
- 20 [~~(15)~~] (17) A representative of the Hawaii public housing
21 authority;

- 3 programs in each county, to be designated by the
- 4 respective mayors;

- 6 of Veterans Affairs who shall be requested to serve by
- 7 the governor;
- 8 ~~[-19-]~~ (21) A representative from the Office of Community
- 9 Planning and Development, United States Department of
- 10 Housing and Urban Development, who shall be requested
- 11 to serve by the governor;
- 12 ~~[-20-]~~ (22) A representative of a faith-based organization
- 13 with interfaith relationships, to be designated by the
- 14 governor; and
- 15 ~~[-21-]~~ (23) A representative of the business community, to be
- 16 designated by the governor."



