
A BILL FOR AN ACT

RELATING TO WORKS OF ART SPECIAL FUND.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. Section 103-8.5, Hawaii Revised Statutes, is
2 amended by amending subsection (a) to read as follows:
3 "(a) There is created a works of art special fund, into
4 which shall be transferred one per cent of all state fund
5 appropriations for capital improvements designated for the
6 construction cost element; provided that this transfer shall
7 apply only to capital improvement appropriations that are
8 designated for the construction [~~or renevation~~] of state
9 buildings. The one per cent transfer requirement shall not
10 apply to appropriations from the passenger facility charge
11 special fund established by section 261-5.5 and the rental motor
12 vehicle customer facility charge special fund established under
13 section 261-5.6."

14 SECTION 2. Section 103-8.5, Hawaii Revised Statutes, is
15 amended by amending subsection (b) to read as follows:

16 "(b) [The] Fifty per cent of the expenditures of the works
17 of art special fund shall be used solely to support art



1 facilities, equipment, and supplies in department of education
2 schools and fifty per cent of the expenditures of the works of
3 art special fund shall be used solely for the following
4 purposes:

- 5 (1) Costs related to the acquisition of works of art,
6 including any consultant or staff services required to
7 carry out the art in public places and relocatable
8 works of art programs;
- 9 (2) Site modifications, display, and interpretive work
10 necessary for the exhibition of works of art;
- 11 (3) Upkeep services, including maintenance, repair, and
12 restoration of works of art; and
- 13 (4) Storing and transporting works of art."

14 SECTION 3. The auditor shall conduct an audit of the works
15 of art special fund and the state foundation on culture and the
16 arts on:

- 17 (1) The price paid for each art object acquired pursuant
18 to section 103-8.5, Hawaii Revised Statutes, and
19 currently owned by the State;



- 1 (2) An assessment of the current value of each art object
- 2 acquired pursuant to section 103-8.5, Hawaii Revised
- 3 Statutes, and currently owned by the State;
- 4 (3) A comparison of the price paid for each art object in
- 5 paragraph (1) to the current value of that art object
- 6 in paragraph (2); and
- 7 (4) An evaluation of how art objects are acquired by the
- 8 State.

9 The auditor shall submit a report of its findings and
 10 recommendations, including any proposed legislation, to the
 11 legislature no later than twenty days prior to the convening of
 12 the regular session of 2017.

13 SECTION 4. There is appropriated out of the general
 14 revenues of the State of Hawaii the sum of \$ or so much
 15 thereof as may be necessary for fiscal year 2016-2017 for the
 16 auditor to contract for the services of art appraisers to assist
 17 in producing the data for the audit required by this Act.

18 The sum appropriated shall be expended by the auditor for
 19 the purposes of this Act.

20 SECTION 5. Statutory material to be repealed is bracketed
 21 and stricken. New statutory material is underscored.



1 SECTION 6. This Act shall take effect on July 1, 2050;
2 provided that the amendments made by section 2 of this Act to
3 section 103-8.5(b), Hawaii Revised Statutes, shall take effect
4 on July 1, 2050.



Report Title:

Works of Art Special Fund; State Foundation on Culture and the Arts; Auditor; Appropriation

Description:

Deletes appropriations for capital renovations, as a source of funds for the Works of Art Special Fund. Requires 50% of the Special Fund expenditures to be used for art education at DOE schools effective July 1, 2050. Requires the Auditor to audit the Special Fund and the State Foundation on Culture and the Arts with respect to the price, value, and method of acquisition of the art objects purchased by the Special Fund. Appropriates funds for appraisal services. (HB2618 HD1)
