
A BILL FOR AN ACT

PROPOSING AN AMENDMENT TO THE CONSTITUTION OF THE STATE OF
HAWAII RELATING TO THE STATE EDUCATIONAL FACILITIES
IMPROVEMENT SPECIAL FUND.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. Article VII, section 11 of the Constitution of
2 the State of Hawaii is amended to read as follows:
3 **"LAPSING OF APPROPRIATIONS**
4 **Section 11.** All appropriations for which the source is
5 general obligation bond funds or general funds shall be for
6 specified periods. No such appropriation shall be made for a
7 period exceeding three years [~~; provided that appropriations from~~
8 ~~the state educational facilities improvement special fund may be~~
9 ~~made for periods exceeding three years to allow for construction~~
10 ~~or acquisition of public school facilities]~~. Any such
11 appropriation or any portion of any such appropriation that is
12 unencumbered at the close of the fiscal period for which the
13 appropriation is made shall lapse; provided that no
14 appropriation for which the source is general obligation bond
15 funds nor any portion of any such appropriation shall lapse if
16 the legislature determines that the appropriation or any portion

1 of the appropriation is necessary to qualify for federal aid
 2 financing and reimbursement. Where general obligation bonds
 3 have been authorized for an appropriation, the amount of the
 4 bond authorization shall be reduced in an amount equal to the
 5 amount lapsed."

6 SECTION 2. The question to be printed on the ballot shall
 7 be as follows:


8 "Shall the exemption from the requirement that no
 9 appropriation be made for a period exceeding three years that
 10 presently exists for appropriations made from the state
 11 educational facilities improvement special fund be repealed?"

12 SECTION 3. Constitutional material to be repealed is
 13 bracketed and stricken.

14 SECTION 4. This amendment shall take effect upon
 15 compliance with article XVII, section 3, of the Constitution of
 16 the State of Hawaii.
