## A BILL FOR AN ACT

RELATING TO HEALTH.

**BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:**

1           SECTION 1. The legislature finds that Puna community  
2 residents on the island of Hawaii are in great need of an  
3 additional advanced life support ambulance to augment the  
4 current Hawaii county fire department's emergency medical  
5 services system. Puna has become the fastest growing district  
6 in the State, with a current population of more than forty-five  
7 thousand individuals and a projected population to surge to  
8 approximately seventy-five thousand individuals within the next  
9 fifteen years. Because of the economic and transportation  
10 challenges of the Puna community, the Hawaii county fire  
11 department's emergency medical services has become the access  
12 point for health care to many in Puna.

13           Recent analysis of Hawaii county fire department data shows  
14 that there have been approximately one hundred eighty emergency  
15 medical services incidents per month over the past five years  
16 within that area.



1           Currently, the Hawaii county fire department has three  
2 ambulances based at the Keaau and Pahoa fire stations, including  
3 an emergency medical services unit located at the Pahoa village  
4 fire station, which was created in anticipation of the impending  
5 lava flow inundation area.

6           The legislature finds that the ongoing lava flow has  
7 exacerbated the need to serve the nearly ten thousand residents  
8 within the projected impact area. Critical transportation  
9 infrastructure continues to be affected, which will result in  
10 delayed emergency medical care for the residents of Puna if  
11 additional resources are not provided. The travel time to Hilo,  
12 once the flow crosses Highway 130, is expected to increase from  
13 the current average of thirty minutes to two hours.

14           The legislature further finds that an additional advanced  
15 life support ambulance will help reduce death and disability  
16 among residents and visitors on the island of Hawaii. A timely  
17 response to a 911 call is critical to increase the likelihood of  
18 successful outcomes for injured or sick individuals.

19           The purpose of this Act is to appropriate funds to  
20 establish an advanced life support ambulance to be based in Puna  
21 on the island of Hawaii, including through acquiring a vehicle

1 and equipment and funding personnel costs for state-certified  
2 emergency medical services personnel.

3 SECTION 2. There is appropriated out of the emergency  
4 medical services special fund the sum of \$ or so much  
5 thereof as may be necessary for fiscal year 2015-2016 to  
6 establish an advanced life support ambulance based in Puna on  
7 the island of Hawaii, including acquisition of a vehicle and  
8 equipment and personnel costs for state-certified emergency  
9 medical services personnel.

10 The sum appropriated shall be expended by the department of  
11 health for the purposes of this Act.

12 SECTION 3. This Act shall take effect on July 1, 2015.

**Report Title:**

Emergency Medical Services; Advanced Life Support Ambulance;
