
HOUSE CONCURRENT RESOLUTION

AFFIRMING THE STATE OF HAWAII'S SUPPORT OF PLANNED PARENTHOOD,
RECOGNIZING ITS VITAL ROLE IN PROVIDING HEALTH CARE, AND
DENOUNCING VIOLENCE TOWARDS ABORTION PROVIDERS AND THEIR
PATIENTS.

1 WHEREAS, article 25 of the Universal Declaration of Human
2 Rights states that everyone has the right to medical care; and

3
4 WHEREAS, Planned Parenthood of the Great Northwest and the
5 Hawaiian Islands, an affiliate of Planned Parenthood Federation
6 of America (Planned Parenthood), is a non-profit organization
7 providing medical care and education for women, men, and
8 families throughout the diverse communities of Hawaii; and

10 WHEREAS, Planned Parenthood offers cancer screenings,
11 pregnancy testing and counseling, testing and treatment for
12 sexually transmitted infections, comprehensive sexual health
13 education, preventive health care services, birth control for
14 men and women, emergency contraception, and abortion services;

17 WHEREAS, Planned Parenthood also offers guidance and
18 counseling on relationships, consent, body image, and other
19 general health issues; and

20
21 WHEREAS, Planned Parenthood provides resources on a variety
22 of issues that impact children, families, and young adults,
23 including sexual health education resources; and

25 WHEREAS, Planned Parenthood of the Great Northwest and the
26 Hawaiian Islands provides more than ten thousand services to
27 Hawaii residents each year, including teenagers and individuals
28 with limited income or in personal crisis; and

1 WHEREAS, in 2016, Planned Parenthood of the Great Northwest
2 and the Hawaiian Islands celebrates its fiftieth year of
3 providing high-quality, affordable health care in Hawaii; and
4

5 WHEREAS, Planned Parenthood has been under attack in recent
6 months due to a series of manipulated and misleading videos
7 released by an anti-reproductive health organization; and
8

9 WHEREAS, Planned Parenthood has been subjected to numerous
10 politically motivated and misguided investigations that have
11 failed to reveal any wrongdoing by Planned Parenthood; and
12

13 WHEREAS, these attacks have led to extreme and demonizing
14 rhetoric and a hostile climate that leads to violence, threats,
15 and harassment of health care providers and patients; and
16

17 WHEREAS, since 1977 nearly seven thousand violent acts
18 against abortion providers have been reported, including
19 bombings, arsons, death threats, kidnappings, and assaults, and
20 more than one hundred ninety thousand acts of disruption against
21 abortion providers have been performed, including bomb threats
22 and harassing calls; and

24 WHEREAS, since 1993, there have been eleven murders of
25 individuals associated with abortion care, most recently on
26 November 27, 2015, when a gunman attacked a Planned Parenthood
27 health center in Colorado Springs, Colorado in which three
28 people were killed and nine people were injured; and

30 WHEREAS, Planned Parenthood is a trusted health care
31 provider for one in five women in the United States and provides
32 crucial health care services to people across the country and in
33 Hawaii; now, therefore,

35 BE IT RESOLVED by the House of Representatives of the
36 Twenty-eighth Legislature of the State of Hawaii, Regular
37 Session of 2016, the Senate concurring, that the Legislature
38 expresses its gratitude to the Planned Parenthood Federation of
39 America and Planned Parenthood of the Great Northwest and the
40 Hawaiian Islands for providing health care to millions of people
41 annually, including teenagers, persons with limited income, and
42 other vulnerable populations; and
