## HOUSE RESOLUTION

URGING THE DEPARTMENT OF LAND AND NATURAL RESOURCES TO PRESERVE PUEO HABITAT AREAS ACROSS THE STATE AND CONDUCT AN EXTENSIVE PUEO HABITAT INVENTORY.

WHEREAS, Honouliuli Ewa Plain Pueos, the Disappearing 1 Sacred Guardians of Native Lands on The Ewa Plain, are listed by 2 the State of Hawaii as an endangered species on the island of 3 Oahu; and 4 5 WHEREAS, pueo, the Hawaiian owl and "bird of wisdom", have 6 a special place in Hawaii's mythology, known for offering 7 guidance and protection, and have silently sailed over the 8 Hawaiian Islands for well over one thousand years; and 9 10 WHEREAS, pueo, scientific name Asio flammeus sandwichensis, 11 are an endemic species of owl, which evolved in the Hawaiian 12 Islands with no fossil record before the Polynesians arrived in 13 14 the islands; and 15 WHEREAS, there are Pueo Awards, Pueo Scholars, Pueo 16 Programs, Pueo Pride, the University of Hawaii-West Oahu pueo 17 mascot, and yet, the real pueo that once thrived in great 18 numbers has been forgotten; and 19 20 WHEREAS, throughout Hawaii, streets, areas, and valleys 21 bear the pueo's name, with many such places having an intriguing 22 legend attached to them, and yet, our society and culture today 23 might let this great, beautiful, endangered species, which is 24 25 greatly loved in the islands, die off; and 26 WHEREAS, the guardian pueo belongs to heaven and earth, and 27 it was believed that after the death of an ancestor, the spirit 28 could still protect and influence the remaining family acting 29 through the body of the pueo; and 30

1 WHEREAS, the pueo was revered by the ancient Hawaiians as an aumakua, or ancestral guardian of many Hawaiian families and 2 3 was associated with skill in battle, and that an encounter with 4 the pueo is considered to be an omen; and 5 WHEREAS, pueo truly fly without as much as a whisper of 6 sound, the owl's lethal talons and beak are hidden in a cloak of 7 soft, attractive thick feathers, their eyes, big and round, seem 8 human but deeply penetrating; and 9 10 WHEREAS, the pueo, unlike most owls, is mostly active 11 during the day and loves to fly at high altitude above open, 12 grassy areas, and is often seen hunting at dawn and sunset, 13 hovering over their prey before diving down for the kill; and 14 15 WHEREAS, pueo nest right on the ground, in grassy areas, 16 laying three to six eggs over a few months with the eggs 17 hatching at different times, and the young may fledge from the 18 nest on foot before they are able to fly, depend on their 19 parents for approximately two months, and are vulnerable to 20 feral cats, dogs, rats, and mongoose; and 21 22 WHEREAS, the pueo once flew in great numbers in the late 23 1800s on Oahu, but is rarely seen any more on the Ewa Plain due 24 to its need for an established habitat protection plan 25 specifically for the pueo; and 26 27 WHEREAS, pueo can also benefit from State and privately-28 supported management activities designed to conserve other 29 endangered birds, and can benefit from game bird management as 30 densities of pueo occur on lands where game birds also are 31 common; now, therefore, 32 33 BE IT RESOLVED by the House of Representatives of the 34 35 Twenty-eighth Legislature of the State of Hawaii, Regular Session of 2016, that the Department of Land and Natural 36 Resources is urged to preserve pueo habitat across the State and 37 conduct an extensive pueo habitat inventory; and 38
