# A BILL FOR AN ACT

RELATING TO CAPITAL IMPROVEMENT PROJECTS FOR THE BENEFIT OF THE  
THIRD SENATORIAL DISTRICT.

**BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:**

1 SECTION 1. The director of finance is authorized to issue  
2 general obligation bonds in the sum of \$103,000,000 or so much  
3 thereof as may be necessary, and the same sum or so much thereof  
4 as may be necessary is appropriated for fiscal year 2015-2016  
5 for the purpose of capital improvement projects for the third  
6 senatorial district, as follows:

7 1. Kona judiciary complex

8 A. Design, engineering, and  
9 construction

10 Total funding \$55,000,000

11 2. West Hawaii community college

12 A. Construction of new classroom  
13 complex, Phase 2

14 Total funding \$20,000,000

15 3. Kona community hospital

5                    SECTION 2.    The appropriations made for the capital  
6 improvement projects authorized by this Act shall not lapse at  
7 the end of the fiscal year for which the appropriations are  
8 made; provided that all moneys from the appropriations that are  
9 unencumbered as of June 30, 2018, shall lapse as of that date.

10                    SECTION 3.    The sums appropriated for the respective  
11 capital improvement projects set forth in section 1 shall be  
12 expended by the appropriate expending agency for the purposes of  
13 this Act.

14                    SECTION 4.    This Act shall take effect on July 1, 2015.
