MAKING APPROPRIATIONS FOR COLLECTIVE BARGAINING COST ITEMS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

7 agreement negotiated with the exclusive bargaining
8 representative of collective bargaining unit (14):

13 SECTION 18. Funds appropriated or authorized by this Act
 14 that are not expended or encumbered by June 30, 2016, and
 15 June 30, 2017, of the respective fiscal years, shall lapse as of
 16 those dates.

17 SECTION 19. This Act shall take effect on January 7, 2059.
