# A BILL FOR AN ACT

RELATING TO MOTOR VEHICLES.

**BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:**

**PART I**

1  
2 SECTION 1. Chapter 291C, Hawaii Revised Statutes, is  
3 amended by adding a new section to be appropriately designated  
4 and to read as follows:

5 "§291C- Operation of a motor vehicle near a bicycle  
6 prohibited. The driver of a motor vehicle shall not operate the  
7 motor vehicle within one yard of a person operating a bicycle."

**PART II**

8  
9 SECTION 2. There is appropriated out of the state highway  
10 fund established pursuant to section 248-8, Hawaii Revised  
11 Statutes, the sum of \$ or so much thereof as may be  
12 necessary for fiscal year 2015-2016 and the same sum or so much  
13 thereof as may be necessary for fiscal year 2016-2017 for a  
14 grant-in-aid to the department of transportation services of the  
15 city and county of Honolulu to operate a van pool program on the  
16 island of Oahu; provided that:

- 17 (1) The city and county of Honolulu department of  
18 transportation services shall submit to the state



1 department of transportation and legislature a plan  
2 for the use of the grant-in-aid before any expenditure  
3 or obligation is made for the van pool program. The  
4 plan shall be submitted at least thirty days prior to  
5 the city and county of Honolulu department of  
6 transportation services expending or obligating any  
7 portion of the grant-in-aid; and

- 8 (2) The city and county of Honolulu department of  
9 transportation services shall submit two reports to  
10 the state department of transportation and legislature  
11 on the use of the grant-in-aid with statistics on  
12 expenditure, usage, benefits, and costs. The first  
13 report shall cover the period from July to December  
14 2015 and shall be submitted prior to the convening of  
15 the regular session of 2016. The second report shall  
16 cover fiscal year 2016-2017 and shall be submitted at  
17 least twenty days prior to the convening of the  
18 regular session of 2018.

19 The sums appropriated shall be expended by the department  
20 of transportation for the purposes of this Act.

2 SECTION 3. New statutory material is underscored.

3 SECTION 4. This Act shall take effect on July 1, 2050.



**Report Title:**

Motor Vehicles; Bicycles; Proximity; Highway Fund; Grant-in-Aid;  
Van Pool

**Description:**

Prohibits a motor vehicle from being operated within one yard of a person operating a bicycle. Appropriates highway fund moneys for a grant-in-aid to the city and county of Honolulu to operate a van pool program on Oahu; subject to certain reporting requirements. Effective 7/1/2050. (SD2)
