A BILL FOR AN ACT

RELATING TO THE CULTURAL EXCHANGES BETWEEN HAWAII AND AFRICAN AMERICANS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that people of African
- 2 descent have contributed significantly to many phases of
- 3 Hawaii's development. The rich culture and proud heritage of
- 4 people of African descent have been and continue to be positive
- 5 influences upon life in Hawaii. However, little of this history
- 6 is known or preserved due to a lack of understanding and racial
- 7 divides. Recognition of the contributions of people of African
- 8 descent and their culture is important to the promotion and
- 9 awareness of Hawaii's diverse and multicultural society.
- 10 The purpose of this Act is to establish a commission on the
- 11 history and culture of people of African descent to recognize
- 12 the contributions of people of African descent in Hawaii and
- 13 educate Hawaii's citizens.
- 14 SECTION 2. (a) There is established a commission to be
- 15 known as the Hawaii commission on the history and culture of
- 16 people of African descent.

- 1 (b) The commission shall be temporarily placed within the
- 2 department of accounting and general services for administrative
- 3 purposes. The commission shall be dissolved on June 30, 2017.
- 4 (c) The Hawaii commission on the history and culture of
- 5 people of African descent shall consist of eleven members to be
- 6 appointed by the governor without regard to section 26-34,
- 7 Hawaii Revised Statutes. The members shall include:
- 8 (1) Two members representing the African American
- 9 Diversity Culture Center Hawaii;
- 10 (2) Two members representing the National Association for
- 11 the Advancement of Colored People;
- 12 (3) One member representing the University of Hawaii; and
- 13 (4) Six at-large members.
- 14 (d) The chair of the commission shall be selected by a
- 15 majority vote of the commission members.
- 16 (e) The members shall not receive compensation for their
- 17 services but shall be reimbursed for necessary expenses,
- 18 including travel expenses, incurred in the performance of their
- 19 duties under this section.
- 20 (f) The Hawaii commission on the history and culture of
- 21 people of African descent may:

1	(1)	Initiate, direct, and coordinate projects and events
2		to further the understanding of the history and
3		culture of people of African descent;
4	(2)	Educate residents and visitors to the State about the
5		significance and impact of the experience of people of
6		African descent in Hawaii; and
7	(3)	Publish an annual report to the legislature with
8		recommendations to honor and recognize the
9		contributions of people of African descent in Hawaii.
10	SECT	ION 3. This Act shall take effect on July 1, 2030; and
11	shall be	repealed on June 30, 2017.
