A BILL FOR AN ACT

RELATING TO RECYCLING.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. Section 342G-101, Hawaii Revised Statutes, is
2 amended by amending the definition of "deposit beverage" to read
3 as follows:

4 "Deposit beverage" means beer, ale, wine, or other drink
5 produced by fermenting malt, mixed spirits, mixed wine, tea and
6 coffee drinks regardless of dairy-derived product content, soda,
7 or noncarbonated water, and all nonalcoholic drinks in liquid
8 form and intended for internal human consumption that is
9 contained in a deposit beverage container.

10 The term "deposit beverage" excludes the following:

11 (1) A liquid that is:

12 (A) A syrup;

13 (B) In a concentrated form; or

14 (C) Typically added as a minor flavoring ingredient
15 in food or drink, such as extracts, cooking
16 additives, sauces, or condiments;

- 1 (2) A liquid that is a drug, medical food, or infant
- 2 formula as defined by the Federal Food, Drug, and
- 3 Cosmetic Act (21 U.S.C. §301 et seq.);
- 4 (3) A single serving of one ounce or less of a dietary
- 5 supplement as defined in the Dietary Supplement Health
- 6 and Education Act of 1994 (P.L. 103-417);
- 7 (4) A liquid that the department finds to be the sole item
- 8 of a meal or diet;
- 9 (5) Products frozen at the time of sale to the consumer,
- 10 or, in the case of institutional users such as
- 11 hospitals and nursing homes, at the time of sale to
- 12 the users;
- 13 (6) Products designed to be consumed in a frozen state;
- 14 (7) Instant drink powders;
- 15 (8) Seafood, meat, or vegetable broths, or soups, but not
- 16 juices; and
- 17 (9) Milk and all other dairy-derived products, except tea
- 18 and coffee drinks with trace amounts of these
- 19 products."

20 SECTION 2. New statutory material is underscored.
