
A BILL FOR AN ACT

RELATING TO WAILUKU PROPERTIES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. (a) The department of accounting and general
2 services shall develop a comprehensive Wailuku state office
3 master plan to address the shortage of space in the Wailuku
4 state office building and old courthouse building. The master
5 plan shall include:

6 (1) An analysis of the existing uses of the facilities and
7 office space in the Wailuku state office building and
8 old courthouse building;

9 (2) The identification of any issues or problems
10 encountered by state agencies as a result of the lack
11 of facilities and office space and a determination of
12 the space needed to resolve these issues; and

13 (3) The identification and evaluation of all land and
14 buildings adjacent to and surrounding the Wailuku
15 state office building and old courthouse building,
16 including land and buildings owned by Hawaiian Telcom,
17 Bank of Hawaii, and Maui county, to determine if the
18 land and buildings may be used to reduce the shortage



1 of space in the Wailuku state office building and old
2 courthouse building.

3 (b) For the purposes of subsection (a), the department of
4 accounting and general services shall consult with the
5 appropriate stakeholders, including the Maui county judiciary
6 and Maui redevelopment agency.

7 (c) The department of accounting and general services
8 shall submit the Wailuku state office master plan to the
9 legislature no later than twenty days prior to the convening of
10 the regular session of 2017.

11 SECTION 2. There is appropriated out of the general
12 revenues of the State of Hawaii the sum of \$ or so much
13 thereof as may be necessary for fiscal year 2016-2017 for the
14 Wailuku state office master plan.

15 The sum appropriated shall be expended by the department of
16 accounting and general services for the purposes of this Act.

17 SECTION 3. There is appropriated out of the general
18 revenues of the State of Hawaii the sum of \$ or so much
19 thereof as may be necessary for fiscal year 2016-2017 for the
20 purpose of purchasing certain properties in or near Wailuku,
21 identified as follows: TMK: 03-04-013-024; TMK: 03-04-013-090;



1 TMK: 03-04-013-091; TMK: 03-04-013-011; TMK: 03-04-013-023; and
2 TMK: 03-04-013-010.

3 The sum appropriated shall be expended by the department of
4 accounting and general services for the purposes of this Act.

5 SECTION 4. This Act shall take effect on July 1, 2050.
