
A BILL FOR AN ACT

RELATING TO TAXATION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. Hawaii is vulnerable to soaring prices or
2 disruptions of its energy imports, which can hinder, cripple, or
3 even devastate the State's economy and the well-being of its
4 inhabitants. As the most isolated land mass on earth, Hawaii
5 imports nearly ninety per cent of its energy and almost one
6 hundred per cent of its transportation resources. The
7 legislature finds that it is critical for Hawaii to ensure
8 greater energy security by becoming more self-sufficient in its
9 energy supply.

10 The purpose of this Act is to:

- 11 (1) Establish a renewable fuels production tax credit to
12 achieve greater energy security for Hawaii; and
13 (2) Repeal the ethanol facility tax credit.

14 SECTION 2. Chapter 235, Hawaii Revised Statutes, is
15 amended by adding a new section to be appropriately designated
16 and to read as follows:

17 "§235- Renewable fuels production tax credit. (a) As
18 used in this section:



1 "Credit period" means a maximum period of five consecutive
2 years beginning from the first taxable year in which a taxpayer
3 begins renewable fuels production at a level of at least fifteen
4 billion British thermal units of renewable fuels per year.

5 "Net income tax liability" means net income tax liability
6 reduced by all other credits allowed under this chapter.

7 "Renewable feedstocks" means:

- 8 (1) Biomass crops;
- 9 (2) Agricultural residues;
- 10 (3) Oil crops, including but not limited to algae, canola,
11 jatropha, palm, soybean, and sunflower;
- 12 (4) Sugar and starch crops, including but not limited to
13 sugar cane and cassava;
- 14 (5) Other agricultural crops;
- 15 (6) Grease and waste cooking oil;
- 16 (7) Food wastes;
- 17 (8) Municipal solid wastes and industrial wastes;
- 18 (9) Water; and
- 19 (10) Animal residues and wastes,
20 that can be used to generate energy.



1 "Renewable fuels" means fuels produced from renewable
2 feedstocks; provided that:

3 (1) The fuels shall be sold as a fuel; and

4 (2) The fuels meet the relevant ASTM International
5 specifications for the particular fuel or other
6 industry specifications for liquid or gaseous fuels,
7 including but not limited to:

8 (A) Methanol, ethanol, or other alcohols;

9 (B) Hydrogen;

10 (C) Biodiesel or renewable diesel;

11 (D) Biogas;

12 (E) Other biofuels; or

13 (F) Renewable jet fuel or renewable gasoline.

14 (b) Each year during the credit period, there shall be
15 allowed to each taxpayer subject to the taxes imposed by this
16 chapter, a renewable fuels production tax credit that shall be
17 applied to the taxpayer's net income tax liability, if any,
18 imposed by this chapter for the taxable year in which the credit
19 is properly claimed.

20 For each taxpayer producing renewable fuels, the annual
21 dollar amount of the renewable fuels production tax credit



1 during the five-year period shall be equal to 20 cents per
2 seventy-six thousand British thermal units of renewable fuels
3 using the lower heating value sold for distribution in Hawaii;
4 provided that the taxpayer's production of renewable fuels is
5 not less than fifteen billion British thermal units of renewable
6 fuels per year; provided further that the amount of the tax
7 credit claimed under this section by a taxpayer shall not exceed
8 \$3,000,000 per taxable year. No other tax credit may be claimed
9 under this chapter for the costs related to renewable fuels
10 production that are used to properly claim a tax credit under
11 this section for the taxable year.

12 (c) The department of business, economic development, and
13 tourism shall:

14 (1) Verify the amount and type of renewable fuels produced
15 and sold, including the purpose for which the fuel was
16 produced;

17 (2) Total all renewable fuels production that the
18 department of business, economic development, and
19 tourism certifies for purposes of paragraph (3); and



1 (3) Certify the total amount of the tax credit for each
2 taxable year and the cumulative amount of the tax
3 credit during the credit period.

4 Upon each determination, the department of business, economic
5 development, and tourism shall issue a certificate to the
6 taxpayer verifying the amount of renewable fuels production, the
7 credit amount certified for each taxable year, and the
8 cumulative amount of the tax credit during the credit period.
9 The taxpayer shall file the certificate with the taxpayer's tax
10 return with the department of taxation. Notwithstanding the
11 department of business, economic development, and tourism's
12 certification authority under this section, the director of
13 taxation may audit and adjust the certification process as is
14 necessary.

15 If in any year, the annual amount of certified credits
16 reaches \$3,000,000 in the aggregate, the department of business,
17 economic development, and tourism shall immediately discontinue
18 certifying credits and notify the department of taxation. In no
19 instance shall the total amount of certified credits exceed
20 \$3,000,000 per year. Notwithstanding any other law to the
21 contrary, the verification and certification information



1 compiled by the department of business, economic development,
2 and tourism shall be available for public inspection and
3 dissemination under chapter 92F.

4 (d) If the credit under this section exceeds the
5 taxpayer's income tax liability, the excess of the credit over
6 liability may be used as a credit against the taxpayer's income
7 tax liability in subsequent years until exhausted. All claims
8 for a credit under this section shall be properly filed on or
9 before the end of the twelfth month following the close of the
10 taxable year for which the credit may be claimed. Failure to
11 comply with the foregoing provision shall constitute a waiver of
12 the right to claim the credit.

13 (e) Prior to production of any renewable fuels for the
14 year, the taxpayer shall provide written notice of the
15 taxpayer's intention to begin production of renewable fuels.
16 The information shall be provided to the department of taxation
17 and the department of business, economic development, and
18 tourism on forms provided by the department of business,
19 economic development, and tourism, and shall include information
20 on the taxpayer, facility location, facility production
21 capacity, anticipated production start date, and taxpayer's



1 contact information. Notwithstanding any other law to the
2 contrary, this taxpayer and facility information shall be
3 available for public inspection and dissemination under chapter
4 92F.

5 (f) The taxpayer shall provide written notice to the
6 director of taxation and the director of business, economic
7 development, and tourism within thirty days following the start
8 of production. The notice shall include the production start
9 date and expected renewable fuels production for the next twelve
10 months. Notwithstanding any other law to the contrary, this
11 production information shall be available for public inspection
12 and dissemination under chapter 92F.

13 (g) Each calendar year during the credit period, the
14 taxpayer shall provide information to the director of business,
15 economic development, and tourism on the number of British
16 thermal units of renewable fuels produced and sold during the
17 previous calendar year, the type of fuels, feedstocks used for
18 renewable fuels production, the number of employees of the
19 facility and each employee's state of residency, and the
20 projected number of British thermal units of renewable fuels
21 production for the succeeding year.



1 (h) In the case of a partnership, S corporation, estate,
2 or trust, distribution and share of the tax credit for renewable
3 fuels production shall be determined pursuant to section 704(b)
4 (with respect to partner's distributive share) of the Internal
5 Revenue Code.

6 (i) Following each year in which a credit under this
7 section has been claimed, the director of business, economic
8 development, and tourism shall submit a written report to the
9 governor and legislature regarding the production and sale of
10 renewable fuels. The report shall include:

11 (1) The number, location, and production of renewable
12 fuels production facilities in the State and outside
13 the State that have claimed a credit under this
14 section;

15 (2) The total number of British thermal units of renewable
16 fuels, broken down by type of fuel, produced and sold
17 during the previous year; and

18 (3) The projected number of British thermal units of
19 renewable fuels production for the succeeding year.

20 (j) The director of taxation shall prepare forms that may
21 be necessary to claim a credit under this section. The director



1 of taxation may require the taxpayer to furnish information to
2 ascertain the validity of the claim for credit made under this
3 section and may adopt rules necessary to effectuate the purposes
4 of this section pursuant to chapter 91."

5 SECTION 3. Section 235-110.3, Hawaii Revised Statutes, is
6 repealed.

7 [~~"§235-110.3 Ethanol facility tax credit. (a) Each year~~
8 ~~during the credit period, there shall be allowed to each~~
9 ~~taxpayer subject to the taxes imposed by this chapter, an~~
10 ~~ethanol facility tax credit that shall be applied to the~~
11 ~~taxpayer's net income tax liability, if any, imposed by this~~

6 ~~(2) The qualifying ethanol production facility operated at~~
7 ~~a level of production of at least seventy five per~~
8 ~~cent of its nameplate capacity on an annualized basis;~~

9 ~~(3) The qualifying ethanol production facility is in~~
10 ~~production on or before January 1, 2017; and~~

11 ~~(4) No taxpayer that claims the credit under this section~~
12 ~~shall claim any other tax credit under this chapter~~
13 ~~for the same taxable year.~~

14 ~~(b) As used in this section:~~

15 ~~"Credit period" means a maximum period of eight years~~
16 ~~beginning from the first taxable year in which the qualifying~~
17 ~~ethanol production facility begins production even if actual~~
18 ~~production is not at seventy five per cent of nameplate~~
19 ~~capacity.~~

20 ~~"Investment" means a nonrefundable capital expenditure~~
21 ~~related to the development and construction of any qualifying~~



1 ~~ethanol production facility, including processing equipment,~~
2 ~~waste treatment systems, pipelines, and liquid storage tanks at~~
3 ~~the facility or remote locations, including expansions or~~
4 ~~modifications. Capital expenditures shall be those direct and~~
5 ~~certain indirect costs determined in accordance with section~~
6 ~~263A of the Internal Revenue Code, relating to uniform~~
7 ~~capitalization costs, but shall not include expenses for~~
8 ~~compensation paid to officers of the taxpayer, pension and other~~
9 ~~related costs, rent for land, the costs of repairing and~~
10 ~~maintaining the equipment or facilities, training of operating~~
11 ~~personnel, utility costs during construction, property taxes,~~
12 ~~costs relating to negotiation of commercial agreements not~~

3 ~~"Nameplate capacity" means the qualifying ethanol~~
4 ~~production facility's production design capacity, in gallons of~~
5 ~~motor fuel grade ethanol per year.~~

6 ~~"Net income tax liability" means net income tax liability~~
7 ~~reduced by all other credits allowed under this chapter.~~

8 ~~"Qualifying ethanol production" means ethanol produced from~~
9 ~~renewable, organic feedstocks, or waste materials, including~~
10 ~~municipal solid waste. All qualifying production shall be~~
11 ~~fermented, distilled, gasified, or produced by physical chemical~~
12 ~~conversion methods such as reformation and catalytic conversion~~
13 ~~and dehydrated at the facility.~~

14 ~~"Qualifying ethanol production facility" or "facility"~~
15 ~~means a facility located in Hawaii which produces motor fuel~~
16 ~~grade ethanol meeting the minimum specifications by the American~~
17 ~~Society of Testing and Materials standard D 4806, as amended.~~

18 ~~(c) In the case of a taxable year in which the cumulative~~
19 ~~claims for the credit by the taxpayer of a qualifying ethanol~~
20 ~~production facility exceeds the cumulative investment made in~~
21 ~~the qualifying ethanol production facility by the taxpayer, only~~



1 ~~that portion that does not exceed the cumulative investment~~
2 ~~shall be claimed and allowed.~~

3 ~~(d) The department of business, economic development, and~~
4 ~~tourism shall:~~

5 ~~(1) Maintain records of the total amount of investment~~
6 ~~made by each taxpayer in a facility;~~

7 ~~(2) Verify the amount of the qualifying investment;~~

8 ~~(3) Total all qualifying and cumulative investments that~~
9 ~~the department of business, economic development, and~~
10 ~~tourism certifies; and~~

11 ~~(4) Certify the total amount of the tax credit for each~~
12 ~~taxable year and the cumulative amount of the tax~~
13 ~~credit during the credit period.~~

14 ~~Upon each determination, the department of business,~~
15 ~~economic development, and tourism shall issue a certificate to~~
16 ~~the taxpayer verifying the qualifying investment amounts, the~~
17 ~~credit amount certified for each taxable year, and the~~
18 ~~cumulative amount of the tax credit during the credit period.~~

19 ~~The taxpayer shall file the certificate with the taxpayer's tax~~

2 ~~taxation may audit and adjust certification to conform to the~~

4 ~~If in any year, the annual amount of certified credits~~
5 ~~reaches \$12,000,000 in the aggregate, the department of~~
6 ~~business, economic development, and tourism shall immediately~~
7 ~~discontinue certifying credits and notify the department of~~
8 ~~taxation. In no instance shall the total amount of certified~~
9 ~~credits exceed \$12,000,000 per year. Notwithstanding any other~~
10 ~~law to the contrary, this information shall be available for~~
11 ~~public inspection and dissemination under chapter 92F.~~

12 ~~(c) If the credit under this section exceeds the~~
13 ~~taxpayer's income tax liability, the excess of credit over~~
14 ~~liability shall be refunded to the taxpayer; provided that no~~
15 ~~refunds or payments on account of the tax credit allowed by this~~
16 ~~section shall be made for amounts less than \$1. All claims for~~
17 ~~a credit under this section must be properly filed on or before~~
18 ~~the end of the twelfth month following the close of the taxable~~
19 ~~year for which the credit may be claimed. Failure to comply~~
20 ~~with the foregoing provision shall constitute a waiver of the~~
21 ~~right to claim the credit.~~



1 ~~(f) If a qualifying ethanol production facility or an~~
2 ~~interest therein is acquired by a taxpayer prior to the~~
3 ~~expiration of the credit period, the credit allowable under~~

6 ~~subsection (a) to the prior taxpayer had the taxpayer not~~

7 SECTION 4. If any provision of this Act, or the
8 application thereof to any person or circumstance, is held
9 invalid, the invalidity does not affect other provisions or
10 applications of the Act that can be given effect without the
11 invalid provision or application, and to this end the provisions
12 of this Act are severable.

13 SECTION 5. Statutory material to be repealed is bracketed
14 and stricken. New statutory material is underscored.

15 SECTION 6. This Act shall take effect on July 1, 2050, and
16 shall apply to taxable years beginning after December 31, 2016;
17 provided that section 2 shall be repealed on December 31, 2021.



Report Title:

Tax Credit; Renewable Fuels Production; Ethanol Facility Tax Credit Repeal

Description:

Establishes a five-year renewable fuels production tax credit and repeals the ethanol facility tax credit. Allows qualifying taxpayers to claim an income tax credit equal to 20 cents per seventy-six thousand British thermal units of renewable fuel, capped at \$3,000,000 per taxable year. Caps the credit at \$3,000,000 per year in aggregate. Requires DBEDT to certify all tax credits and submit a report regarding the production and sale of renewable fuels to the governor and legislature each year. Directs DOTAX to create forms for the tax credit. Applies to taxable years beginning after December 31, 2016. Repeals the tax credit on 12/31/2021. Effective 7/1/2050.
